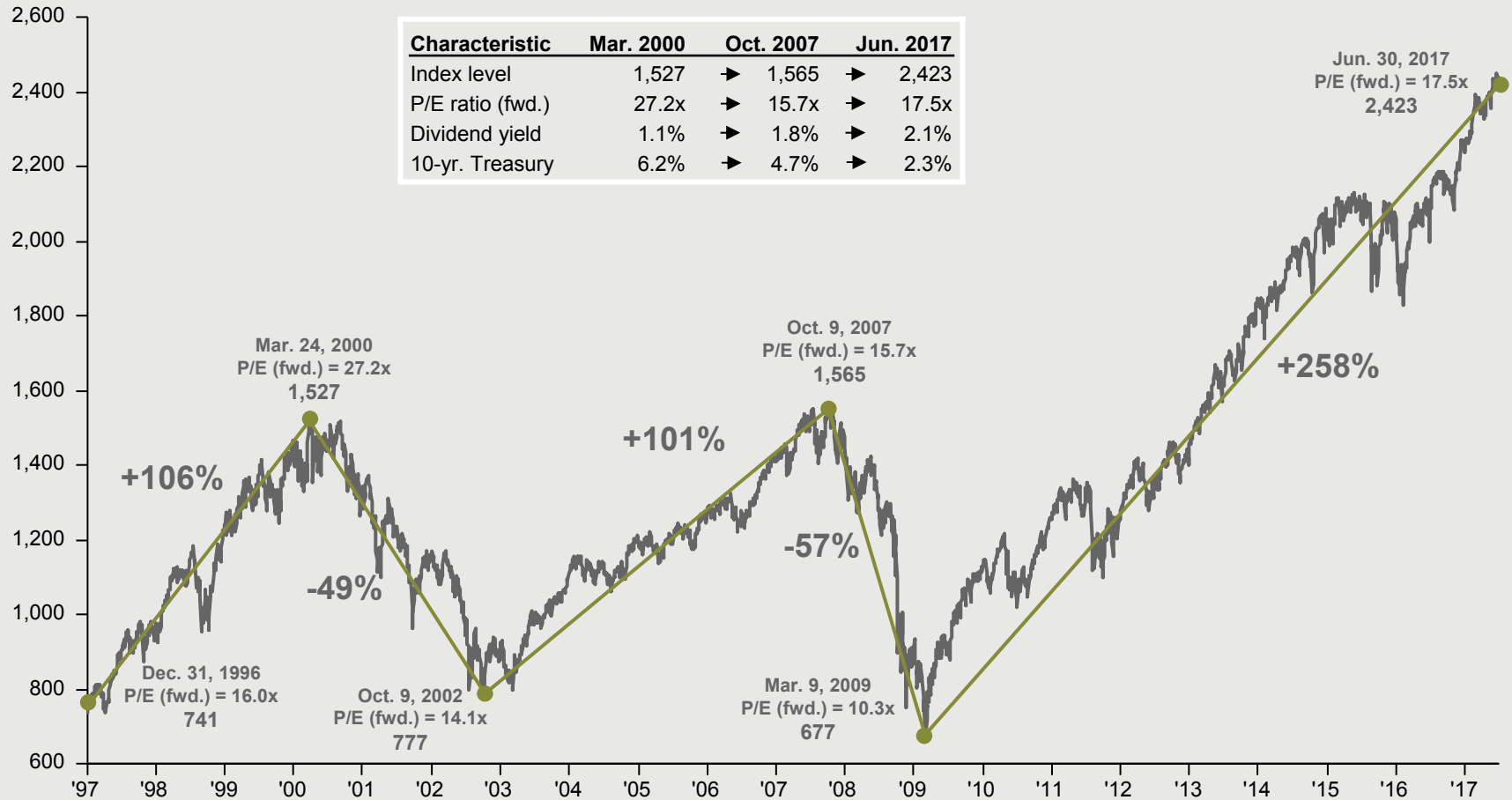

S&P 500 Index: Forward P/E ratio

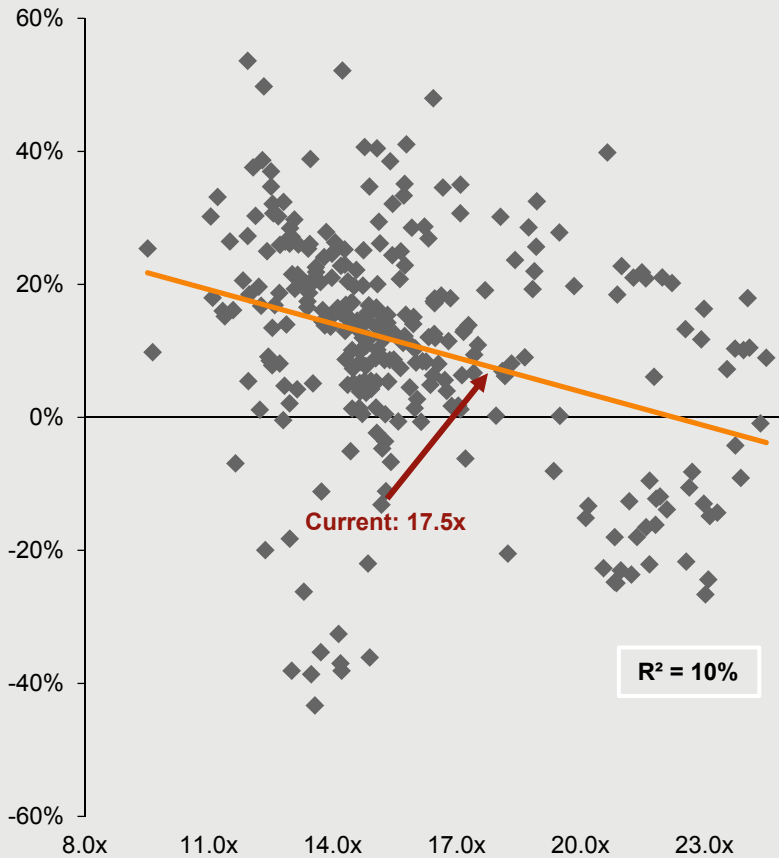

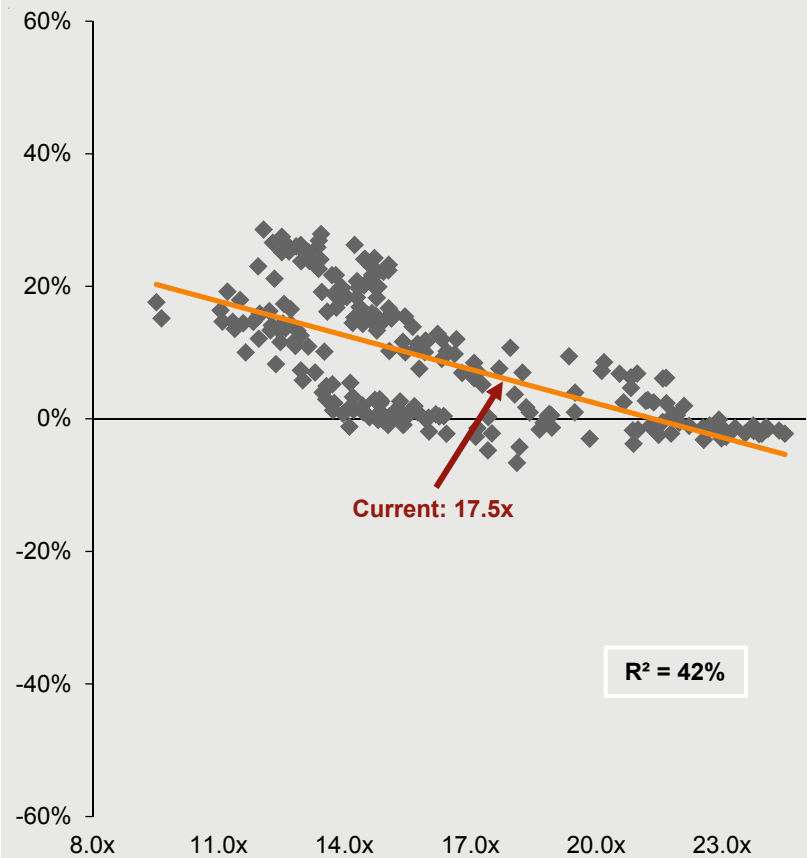
Price to earnings is price divided by consensus analyst estimates of earnings per share for the next 12 months as provided by IBES since December 1989, and FactSet for June 30, 2017. Average P/E and standard deviations are calculated using 25 years of FactSet history. Shiller's P/E uses trailing 10-years of inflation-adjusted earnings as reported by companies. Dividend yield is calculated as the next 12-month consensus dividend divided by most recent price. Price to book ratio is the price divided by book value per share. Price to cash flow is price divided by NTM cash flow. EY minus Baa yield is the forward earnings yield (consensus analyst estimates of EPS over the next 12 months divided by price) minus the Moody's Baa seasoned corporate bond yield. Std. dev. over-/under-valued is calculated using the average and standard deviation over 25 years for each measure. *P/CF is a 20-year average due to cash flow data availability.

S&P 500 Total Return Index



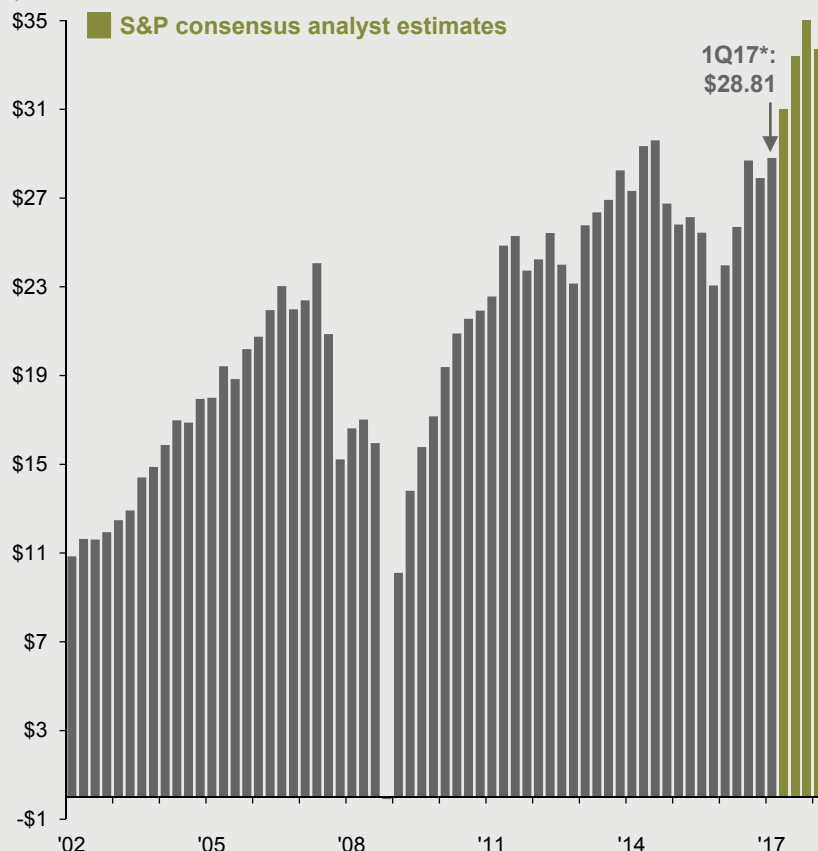
Forward P/E and subsequent 5-yr. annualized returns

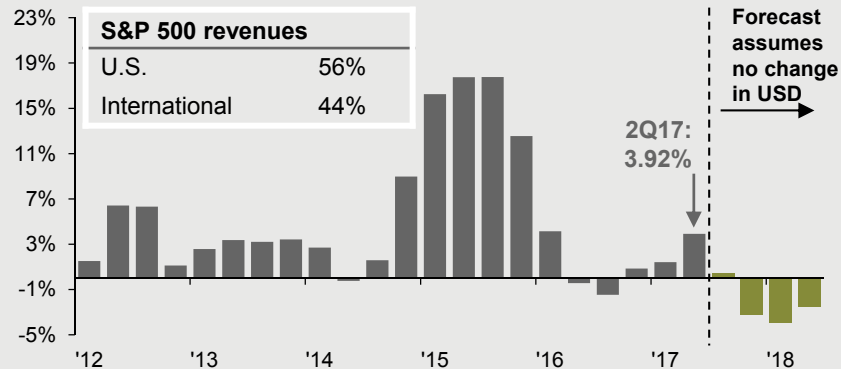
S&P 500 earnings per share

Index quarterly operating earnings



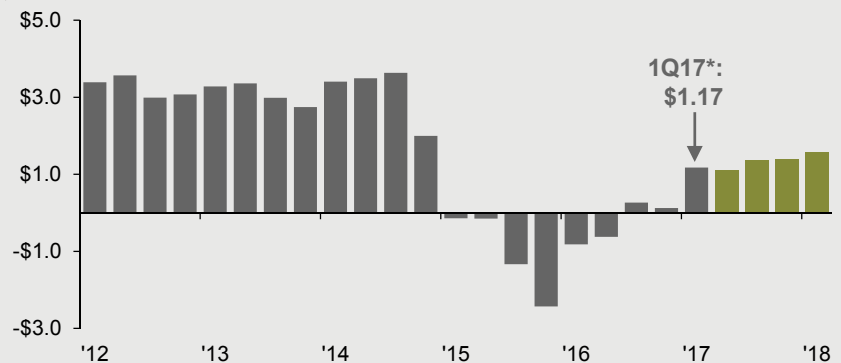

Trailing P/E ratios are bottom-up values defined as month-end price divided by the last 12 months of available reported earnings. Historical data can change as new information becomes available. Note that P/E ratios for the S&P 500 may differ from estimates elsewhere in this book due to the use of a bottom-up calculation of constituent earnings (as described) rather than a top-down calculation. This methodology is used to allow proper comparison of sector level data to broad index level data. Dividend yield is calculated as the next 12-month consensus dividend divided by most recent price. Beta calculations are based on 10-years of monthly price returns for the S&P 500 and its sub-indices. Past performance is not indicative of future returns.

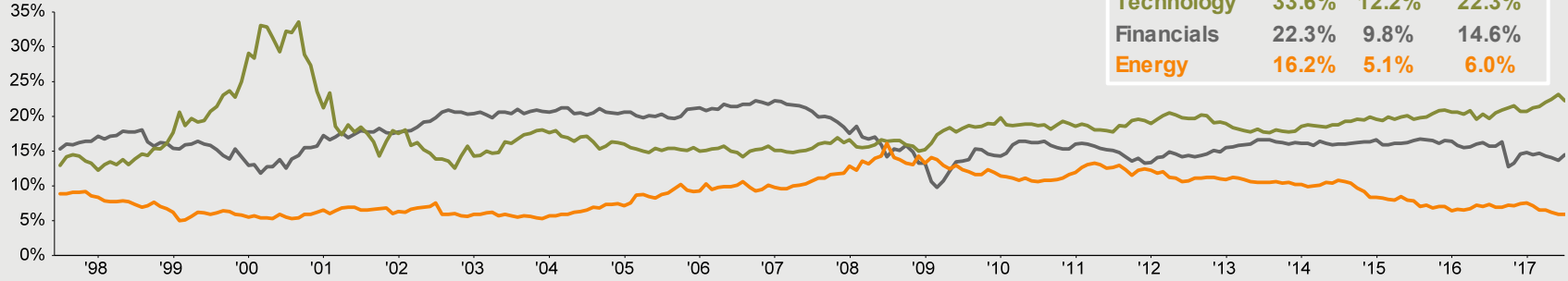

Sector weights over time

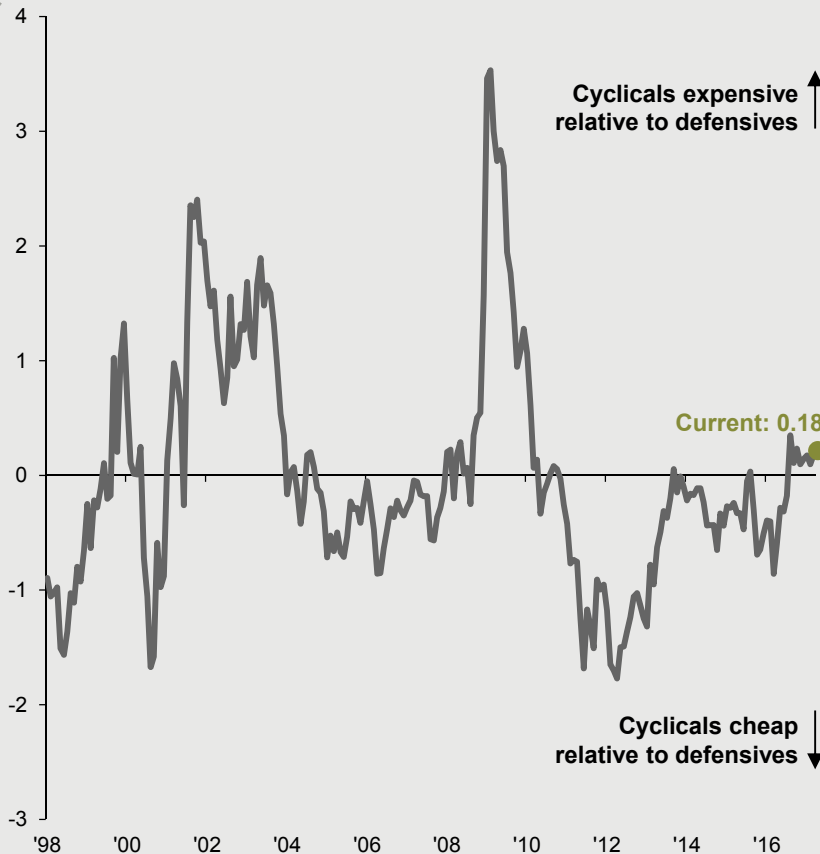
S&P 500 technology, energy and financial sector weights, 20-years

The MSCI Defensive Sectors Index includes: Consumer Staples, Energy, Health Care, Telecommunication Services and Utilities. The MSCI Cyclical Sectors Index contains: Consumer Discretionary, Financials, Industrials, Information Technology and Materials. Securities in the MSCI Momentum Index are selected based on a momentum value on 12-month and 6-month price performance. Constituents of the MSCI Quality Index are selected based on three main variables: high return on equity, stable year-over-year earnings growth and low financial leverage. 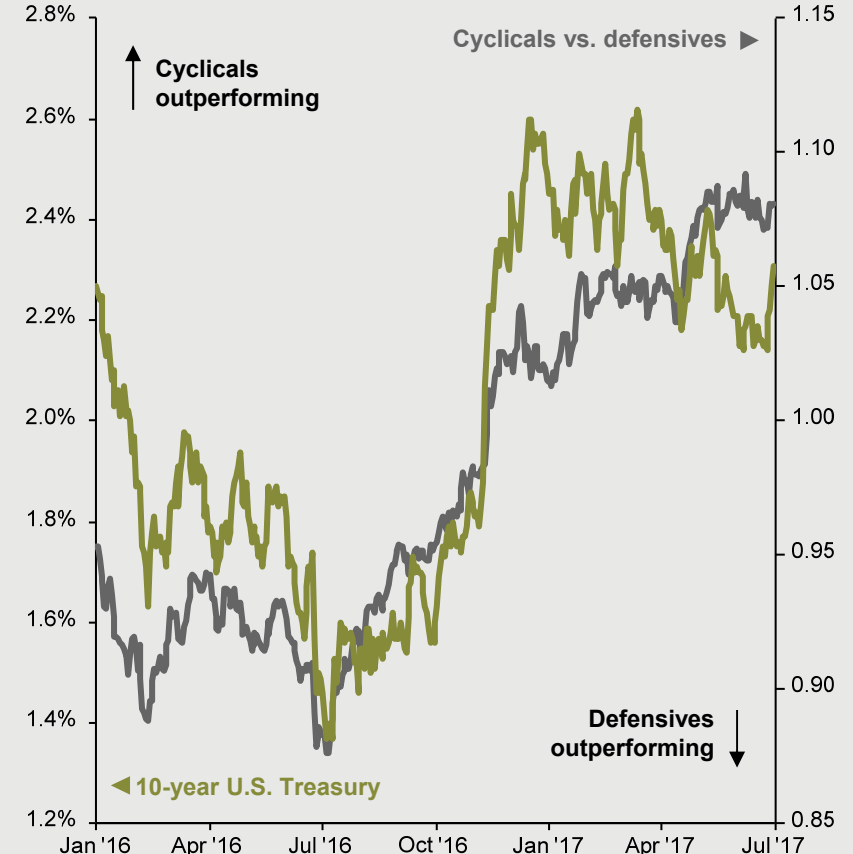
Cyclicals ex-energy vs. defensive valuations*

Cyclical/defensive performance**, 10-year U.S. Treasury yield

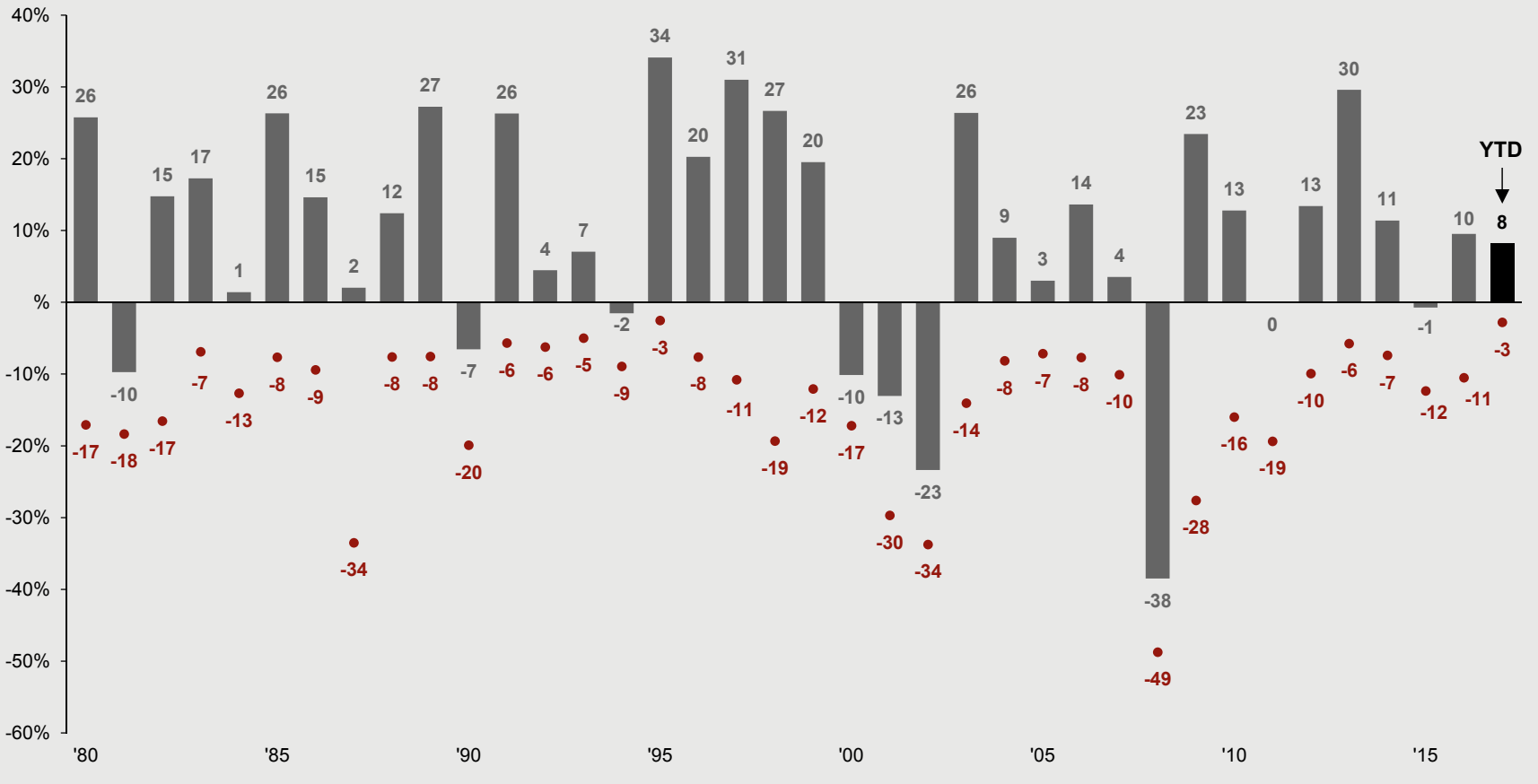

S&P 500 intra-year declines vs. calendar year returns

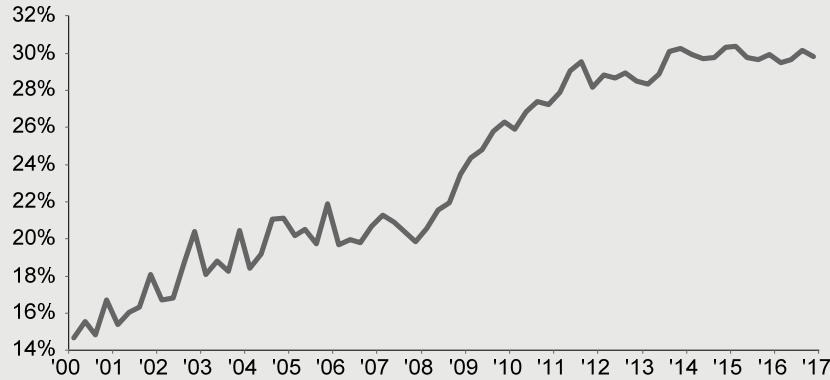

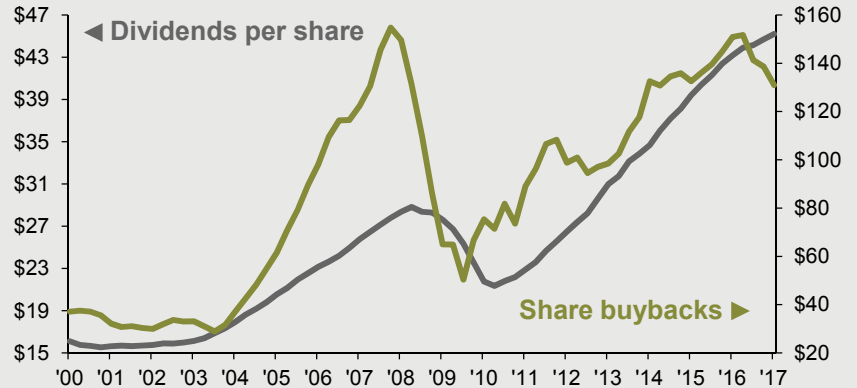
Corporate cash as a % of current assets

S&P 500 companies – cash and cash equivalents, quarterly



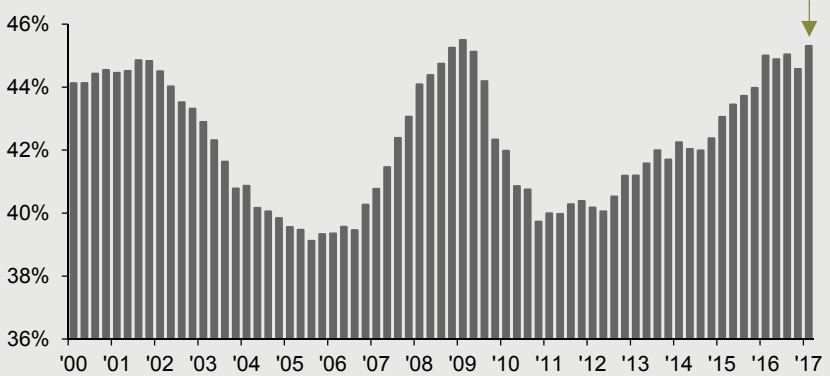
Cash returned to shareholders

Non-financial corporate debt

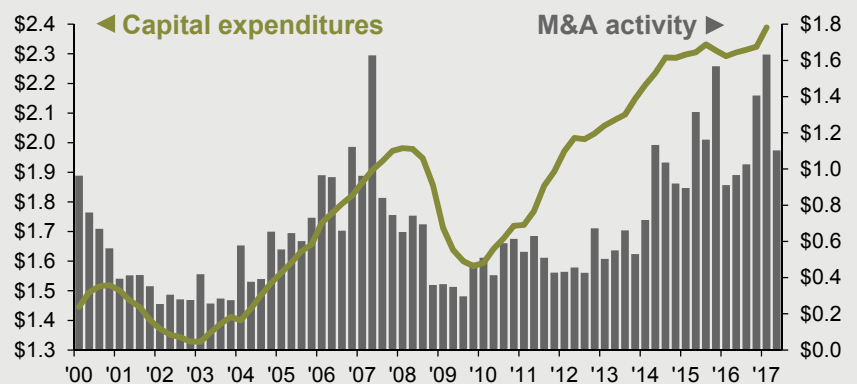
U.S. non-financial corporations, % of GDP

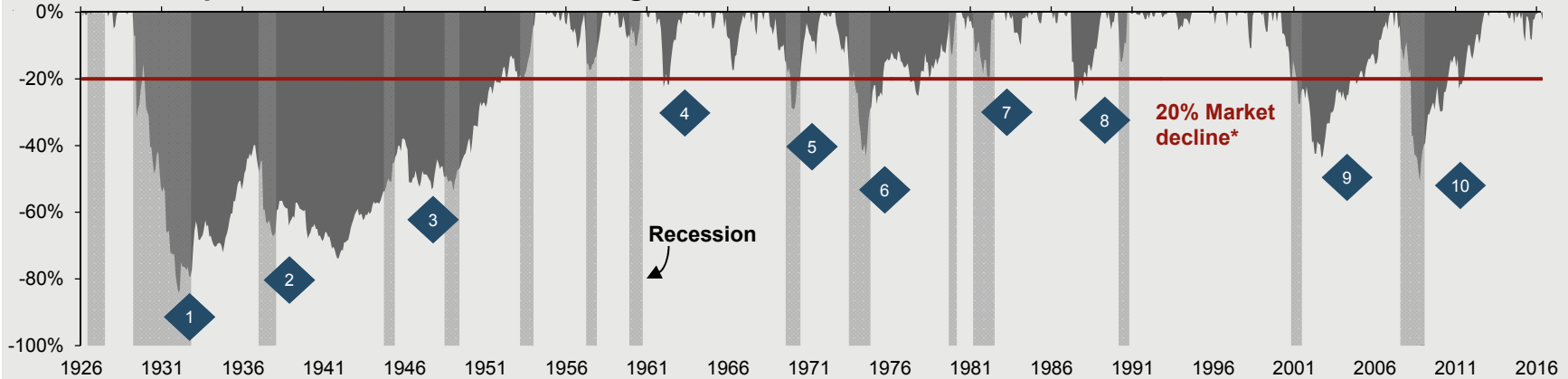

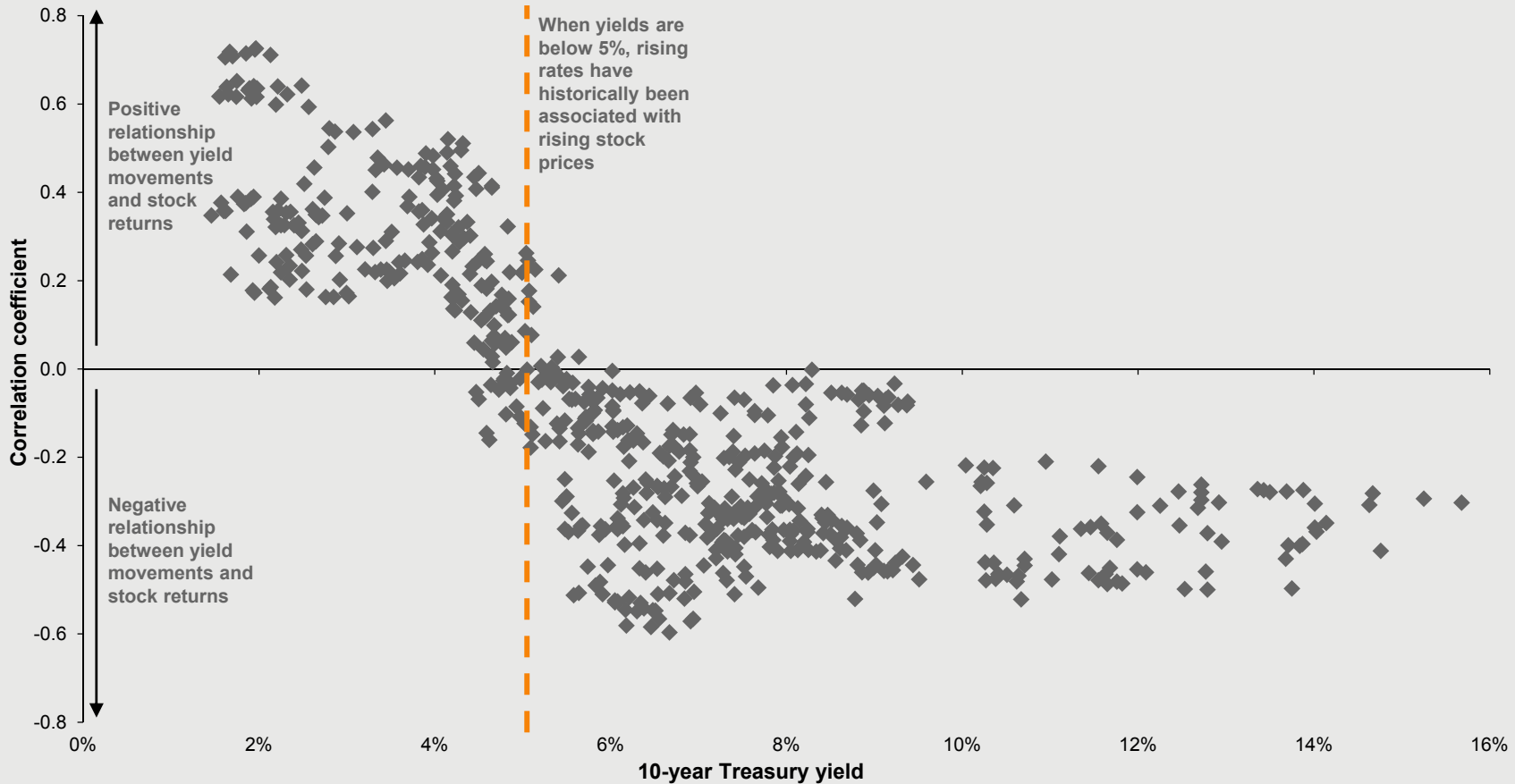

"Aggressive Fed Tightening" is defined as Federal Reserve monetary tightening that was unexpected and/or significant in magnitude. Bear and Bull returns are price returns.

Correlations between weekly stock returns and interest rate movements

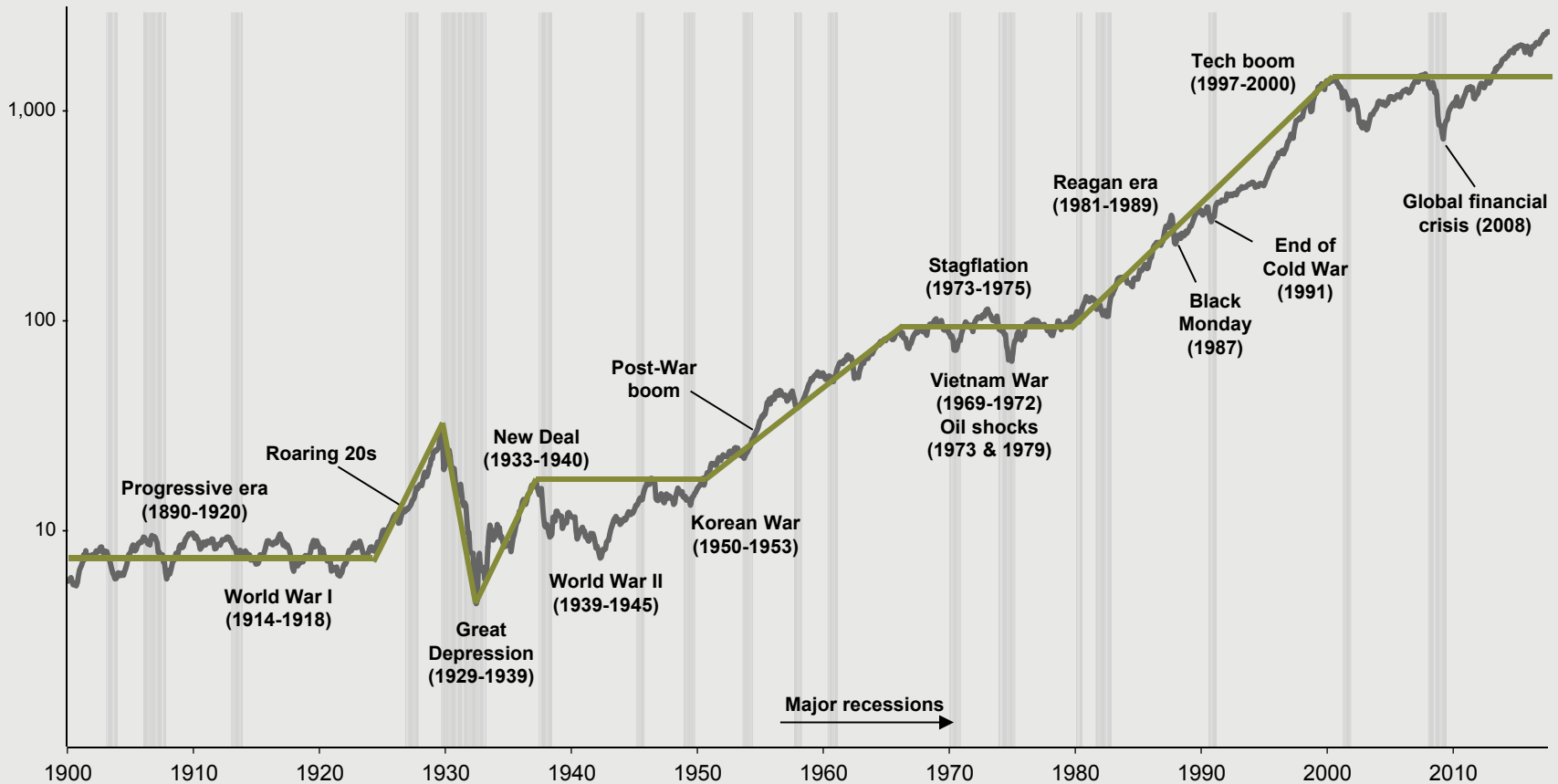
Weekly S&P 500 returns, 10-year Treasury yield, rolling 2-year correlation, June 1963 – June 2017

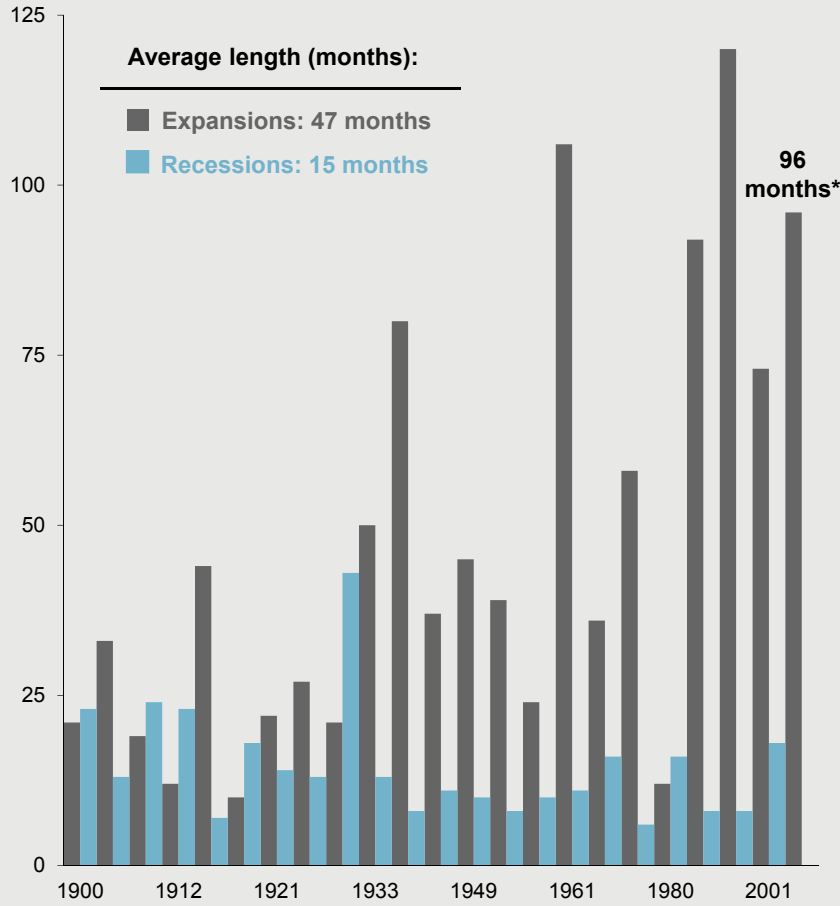
S&P Composite Index

Log scale, annual



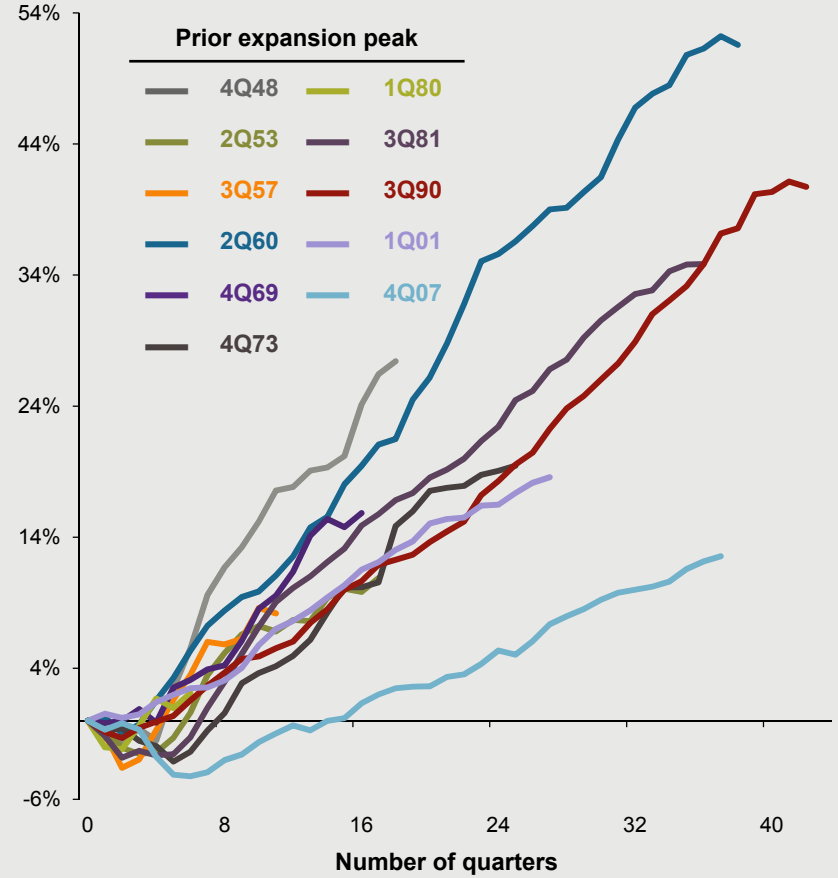

Strength of economic expansions

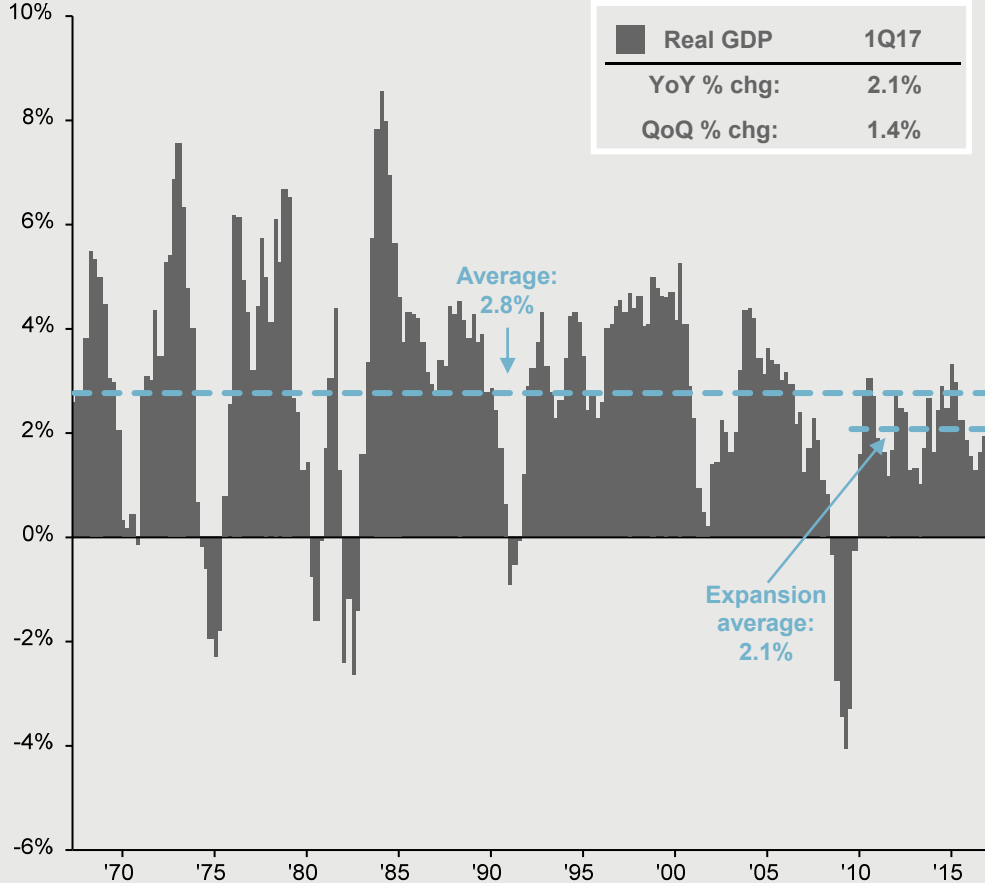
Cumulative real GDP growth since prior peak, percent

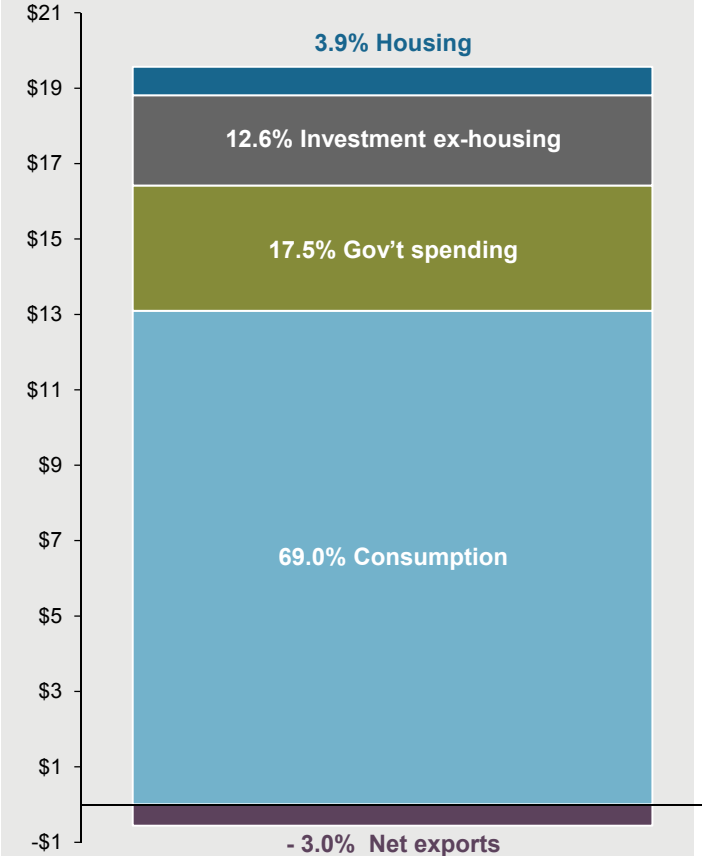
Real GDP

1Q17 nominal GDP, USD trillions



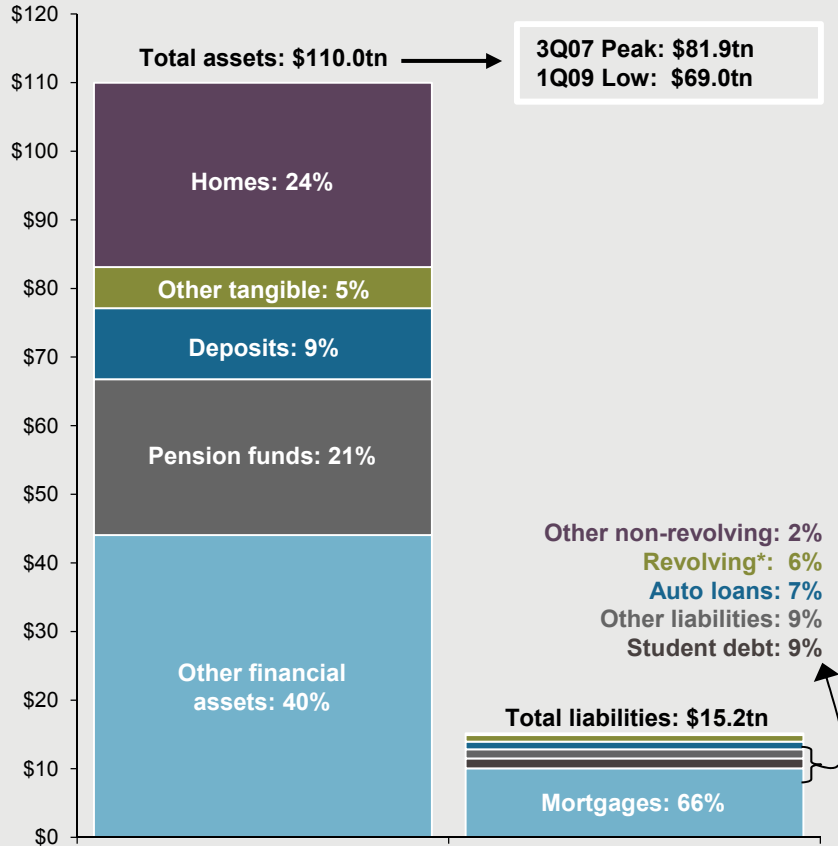

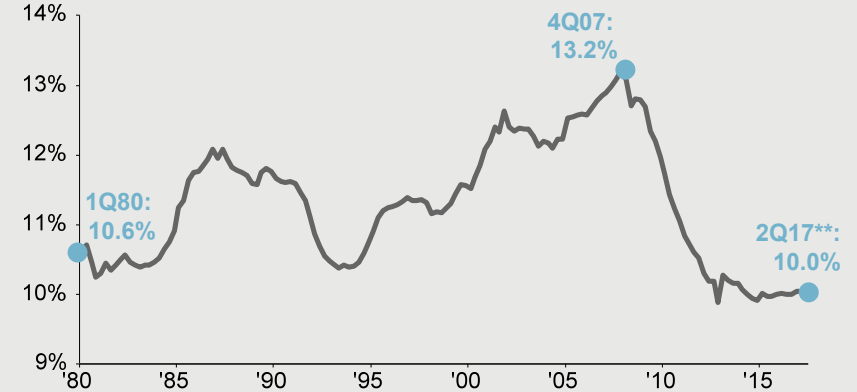

1Q17, trillions of dollars outstanding, not seasonally adjusted



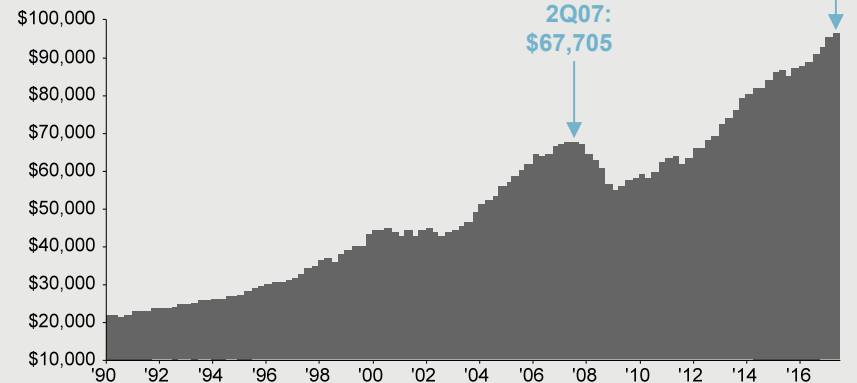
Household debt service ratio

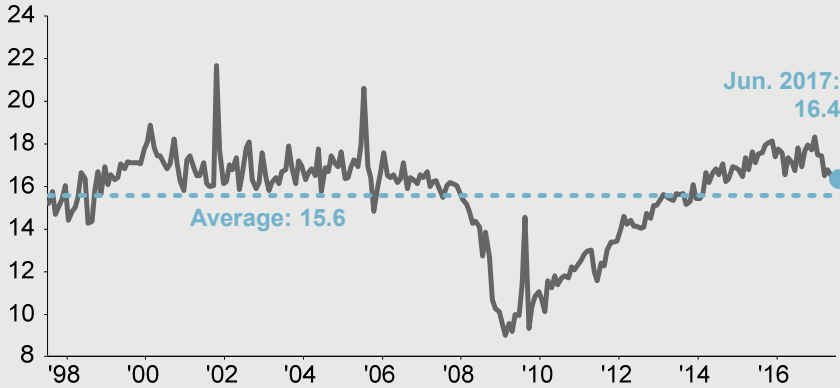

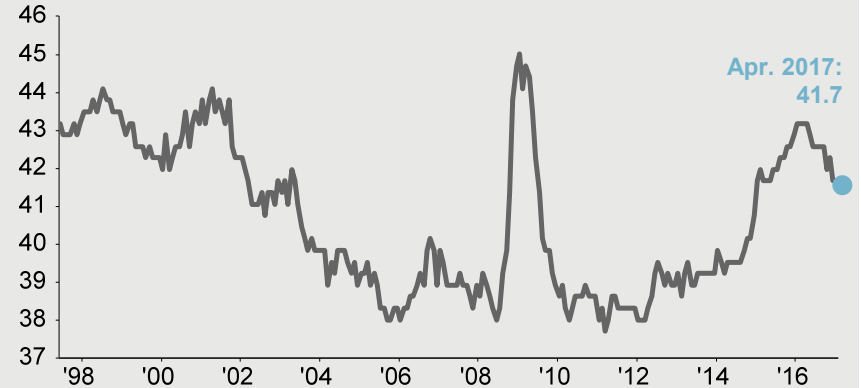
Light vehicle sales

Millions, seasonally adjusted annual rate



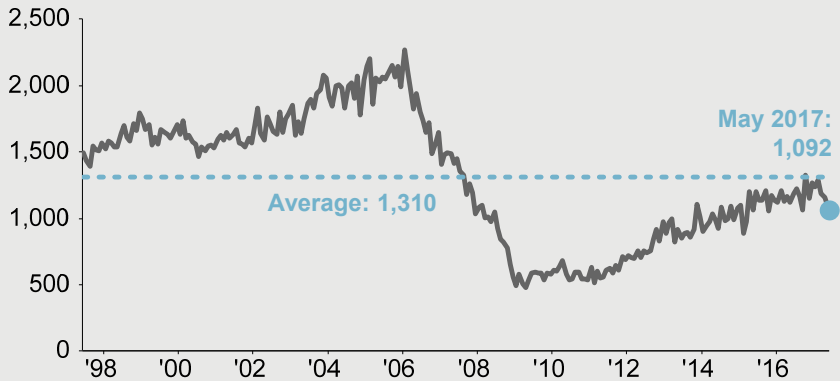

Days of sales, seasonally adjusted



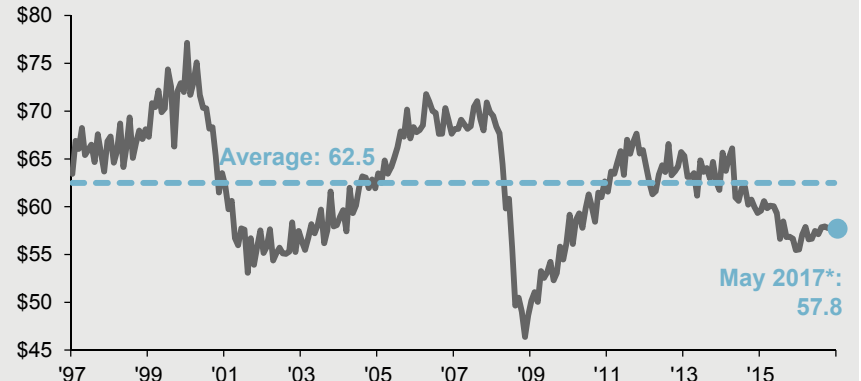

Thousands, seasonally adjusted annual rate

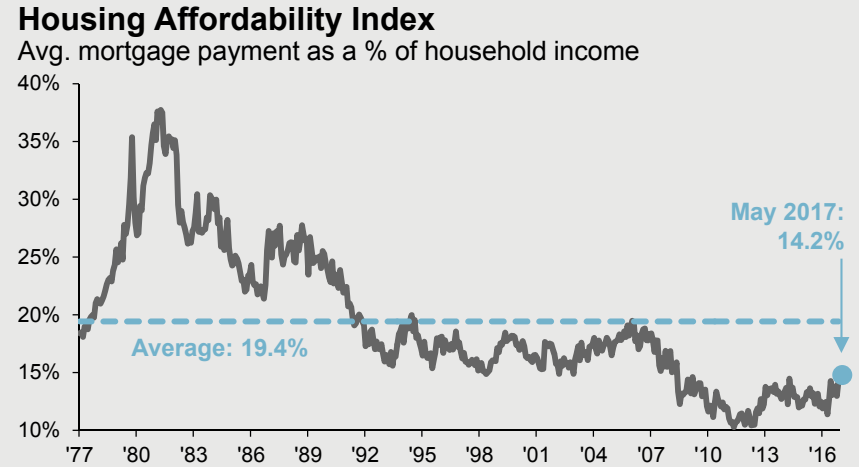
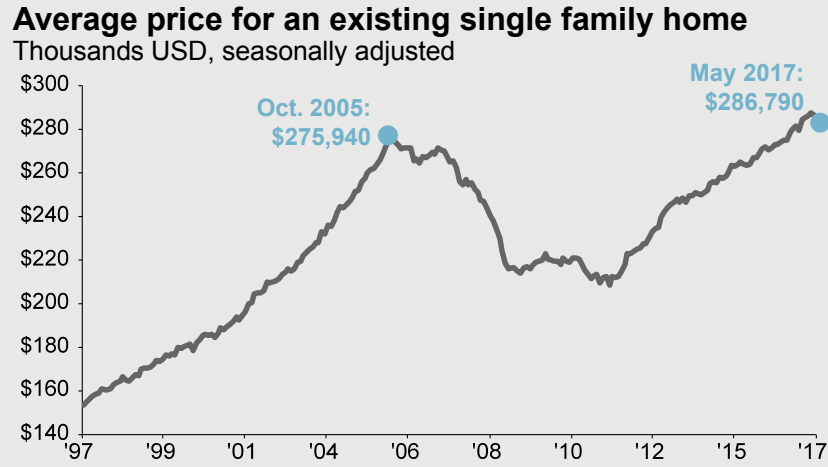


Real capital goods orders

Non-defense capital goods orders ex-aircraft, USD billions, SA



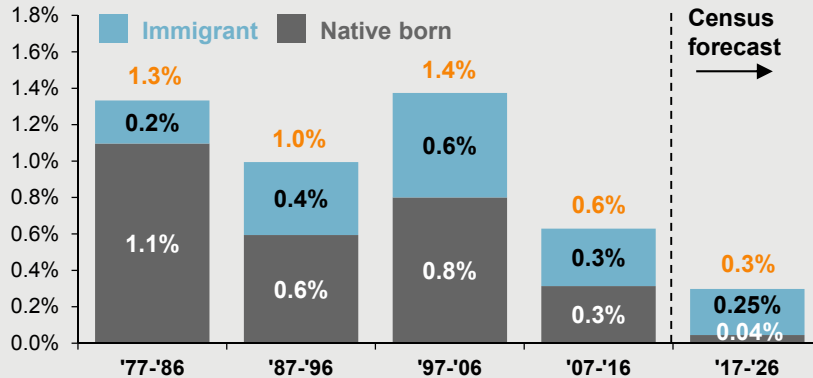

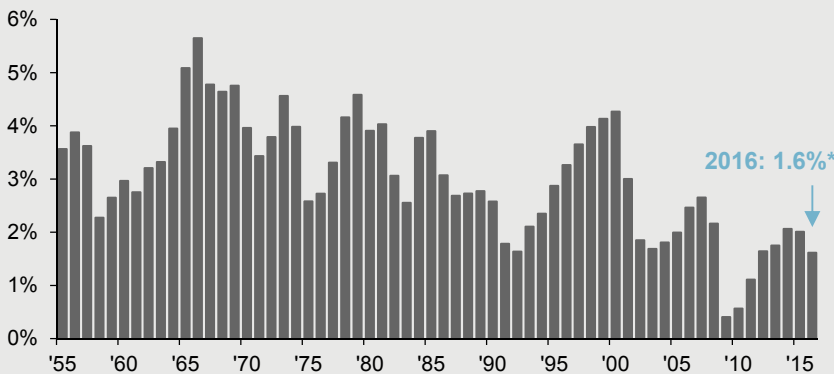
Growth in working-age population

Percent increase in civilian non-institutional population ages 16-64



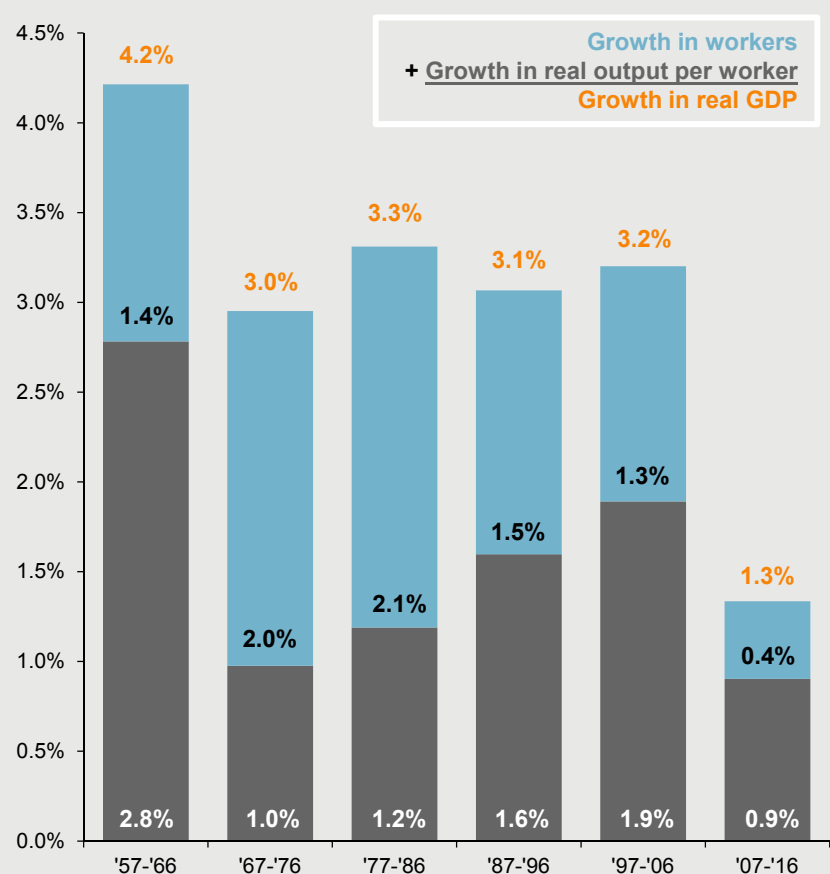
Growth in private non-residential capital stock

Drivers of GDP growth

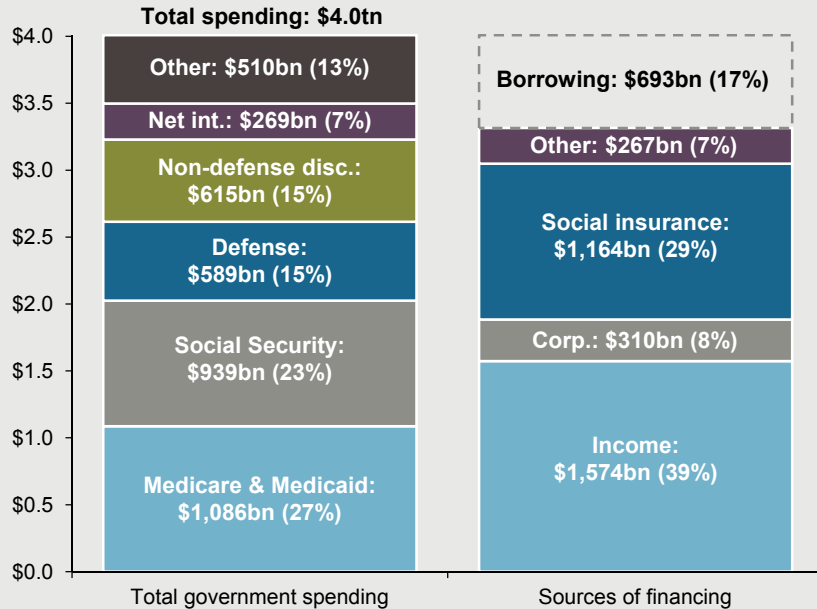
Average year-over-year percent change

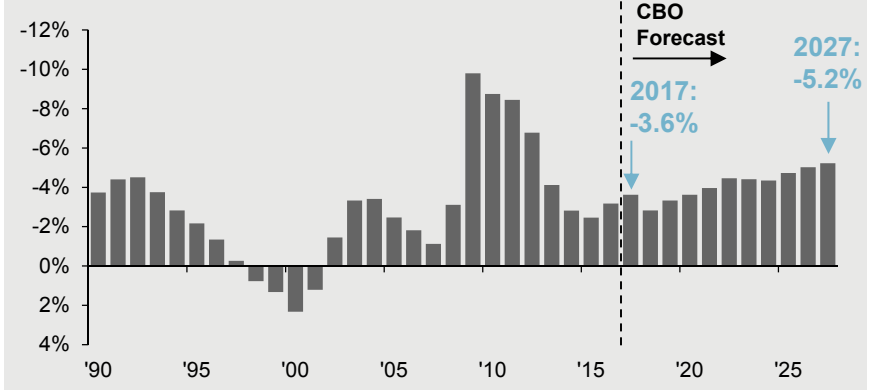

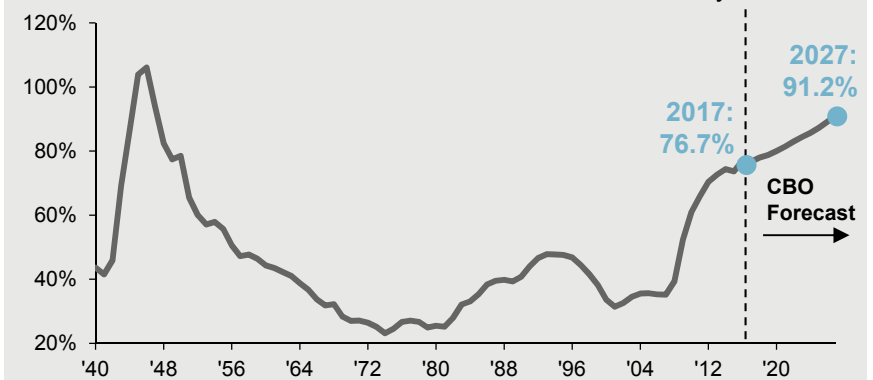
Federal budget surplus/deficit

% of GDP, 1990 – 2027, 2017 CBO Baseline



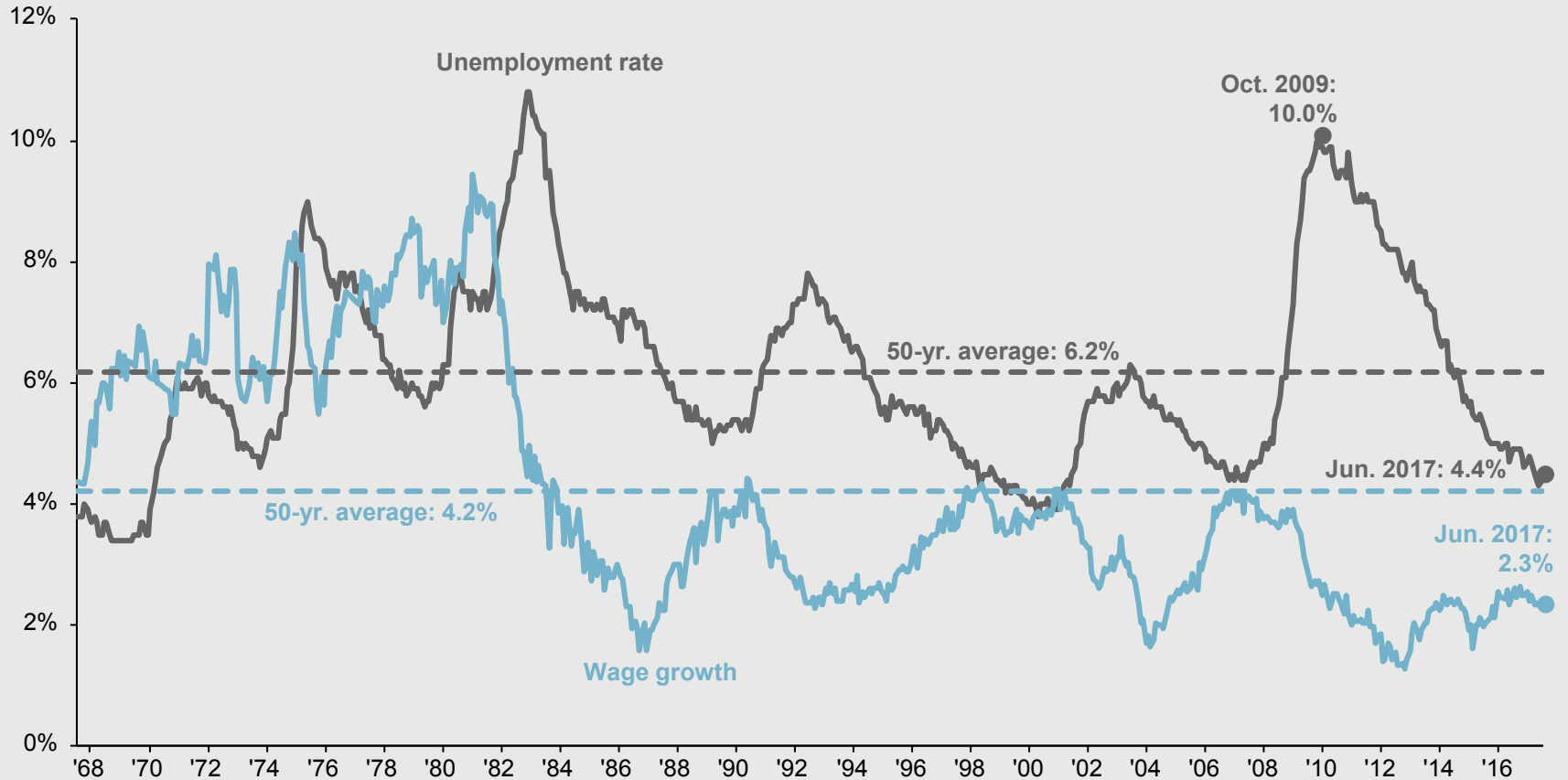
Federal net debt (accumulated deficits)

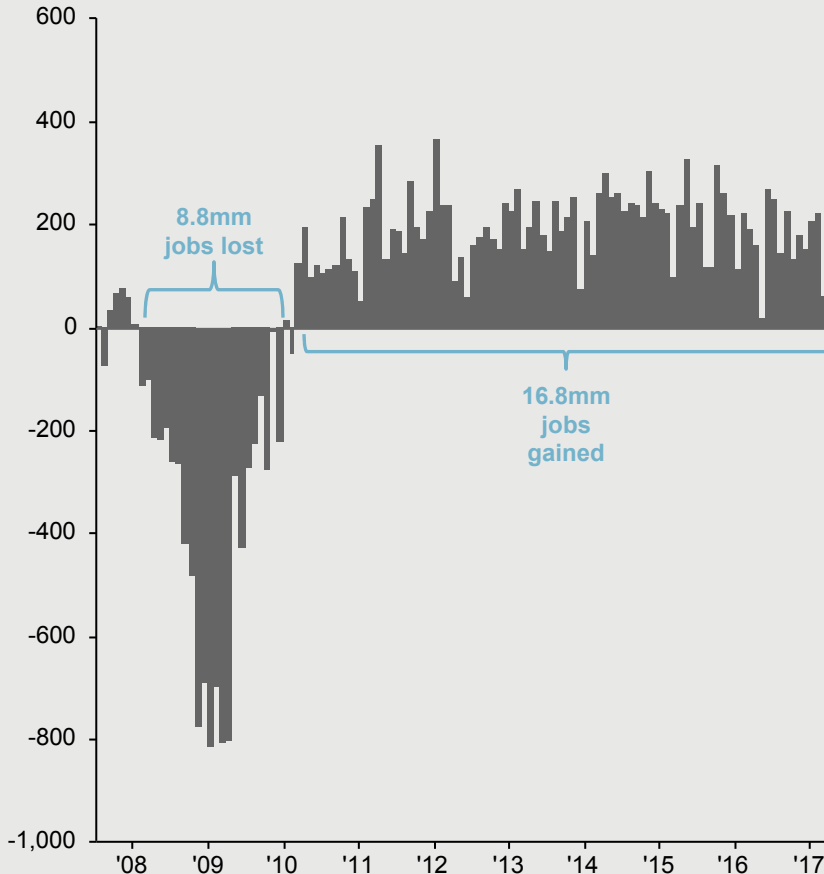
Civilian unemployment rate and year-over-year growth in wages of production and non-supervisory workers

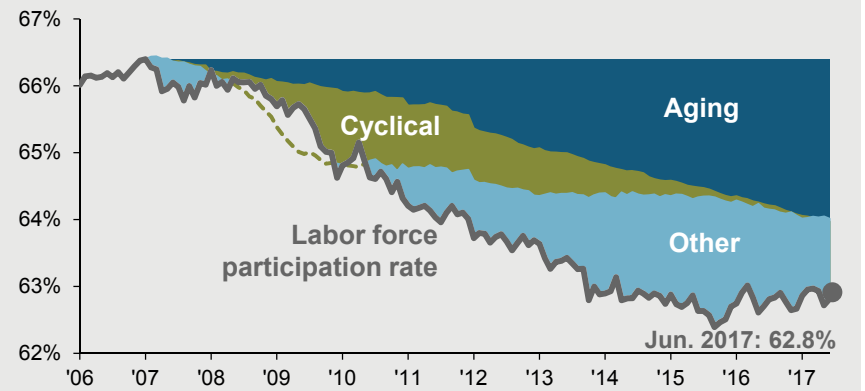
Employment – Total private payroll

Total job gain/loss, thousands



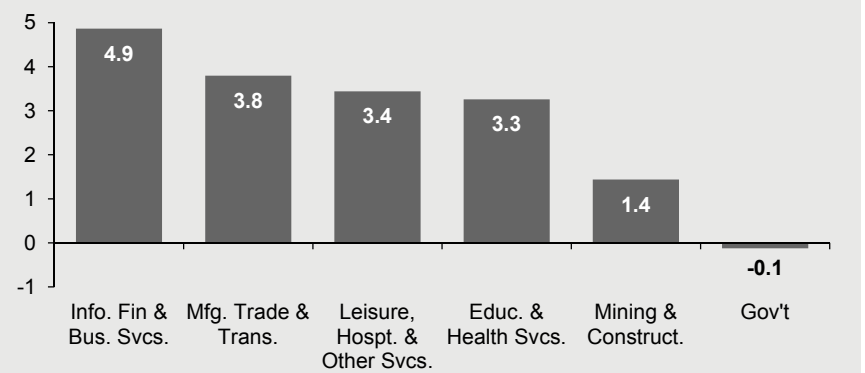
Labor force participation rate decline since 2007 peak*

Population employed or looking for work as a % of total, ages 16+



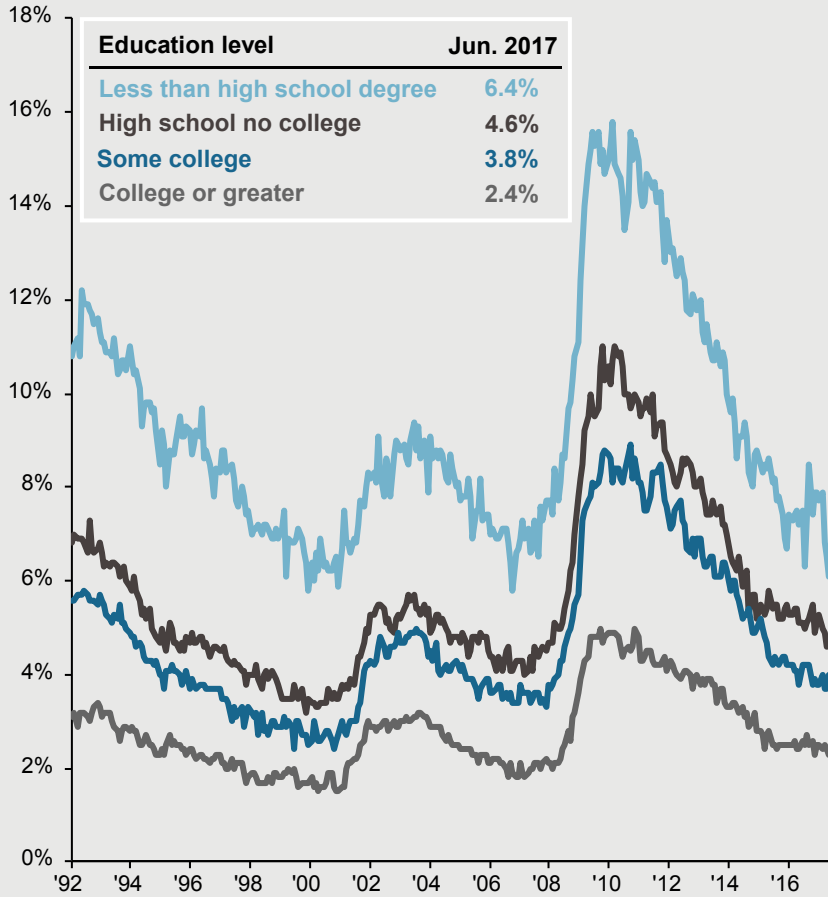
Net job creation since February 2010

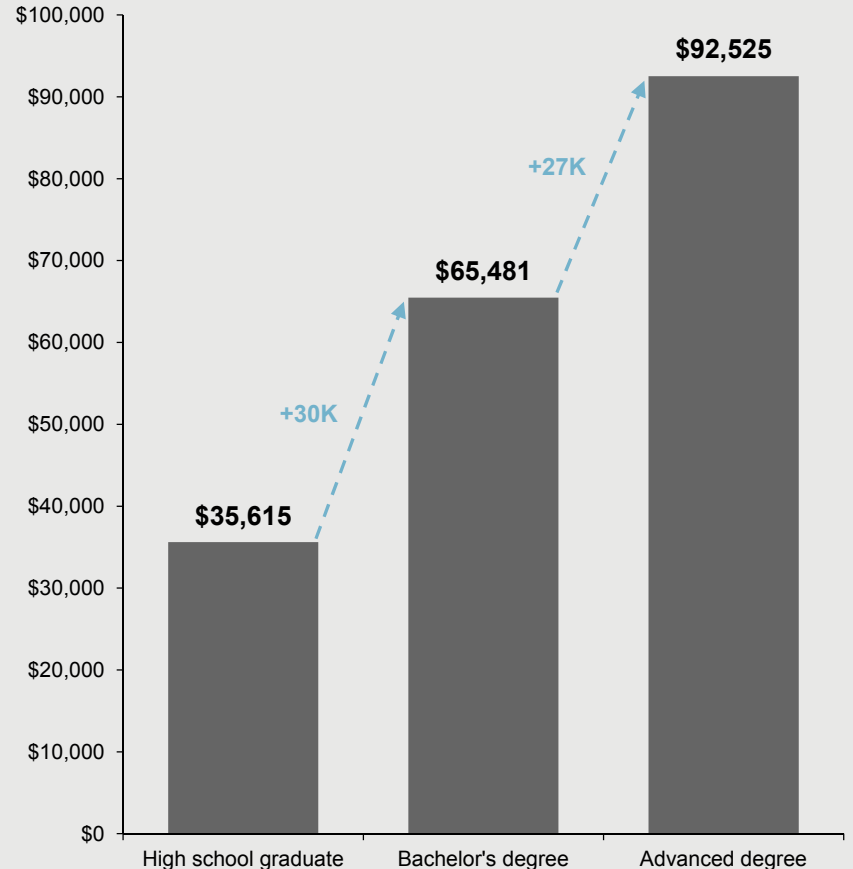

Average annual earnings by highest degree earned

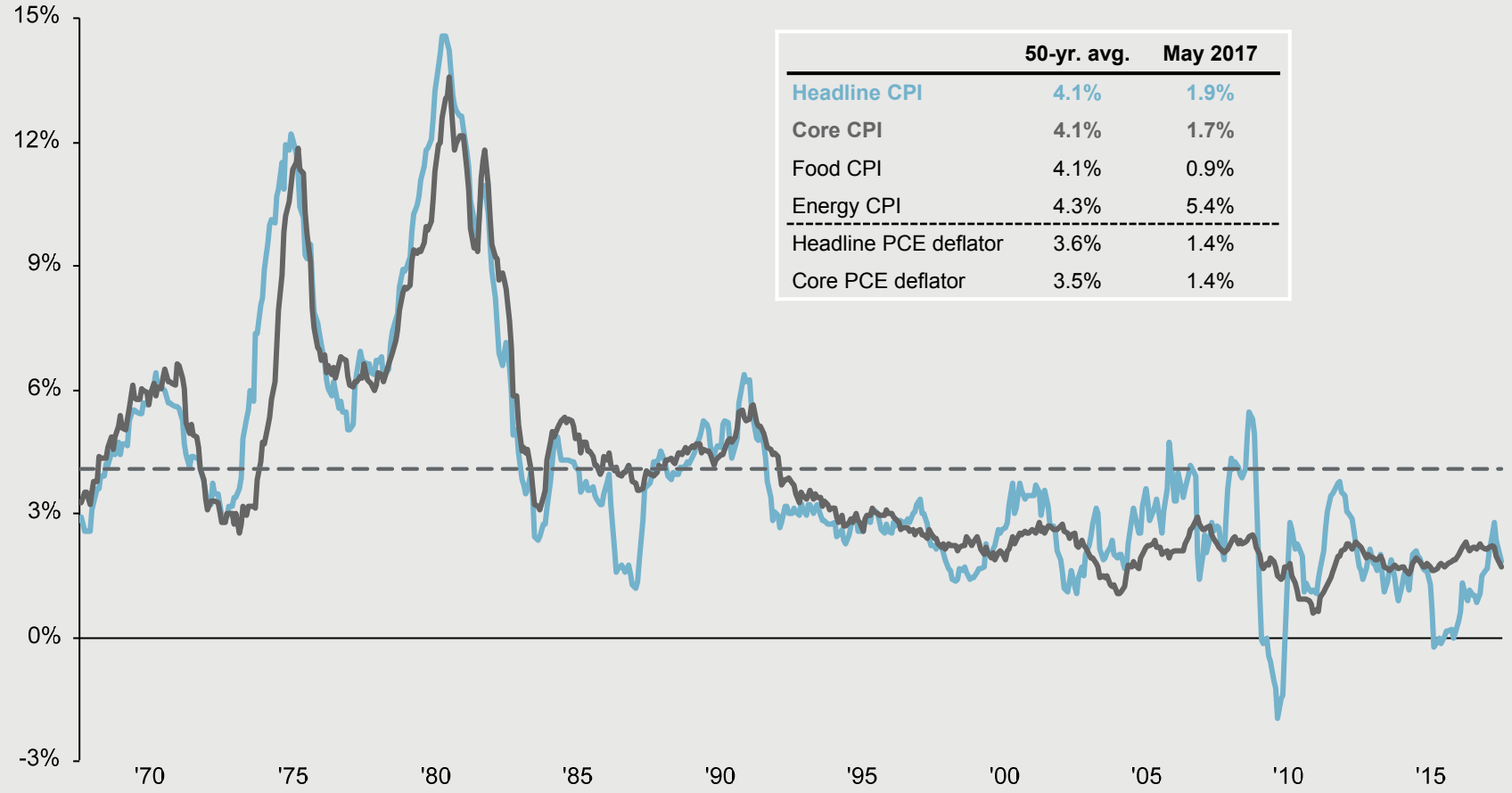

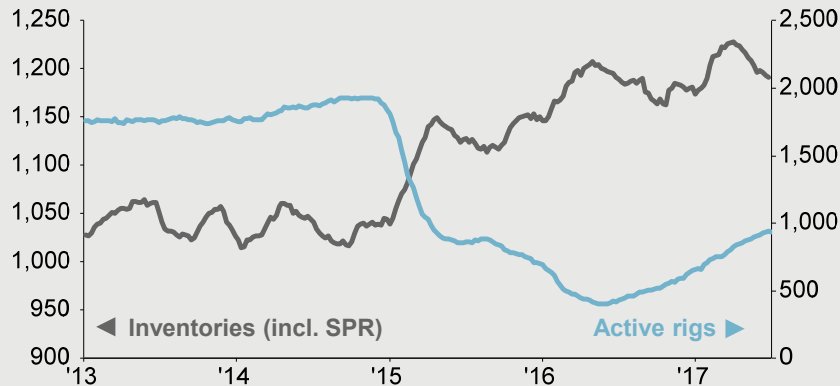

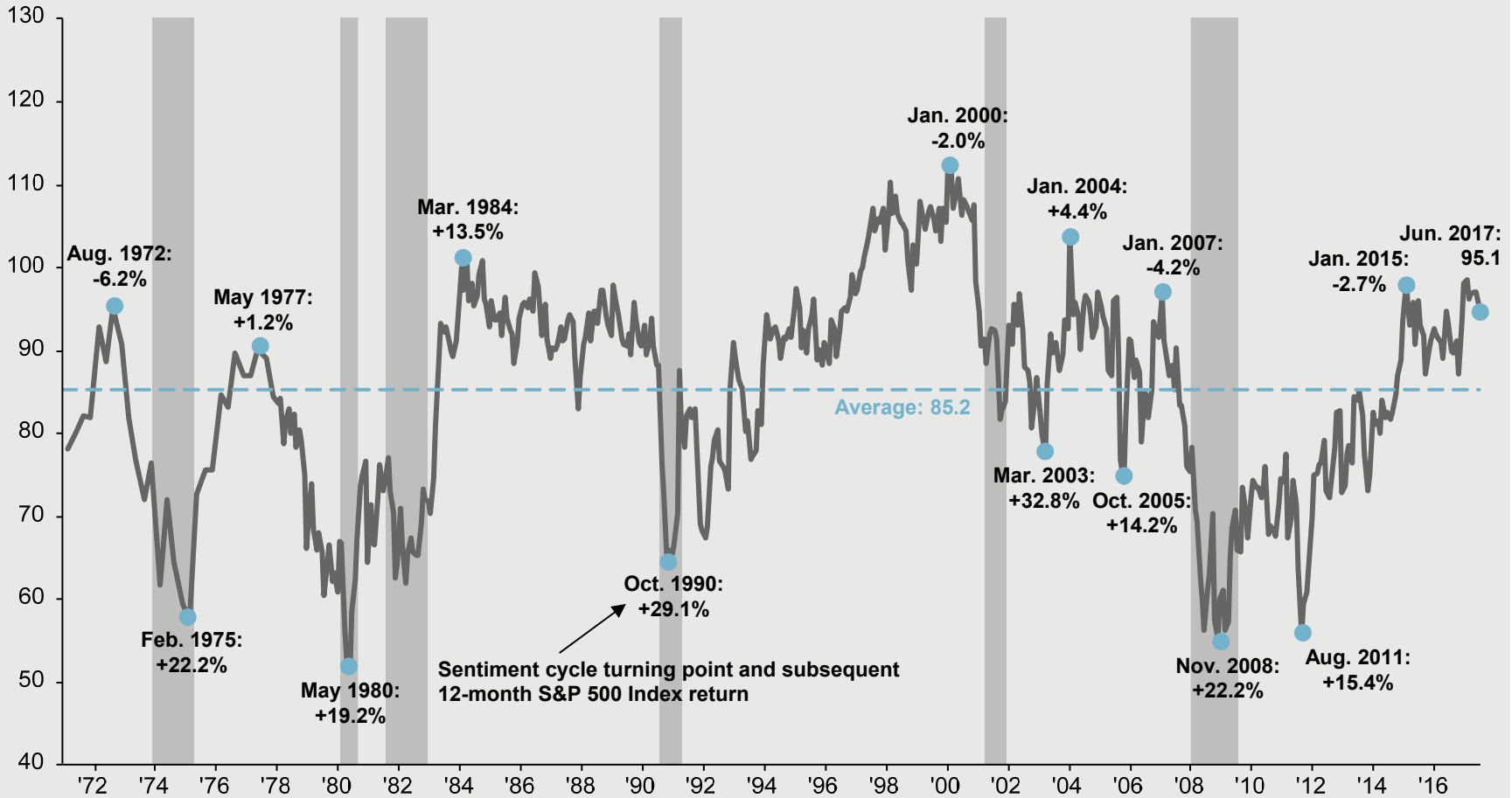

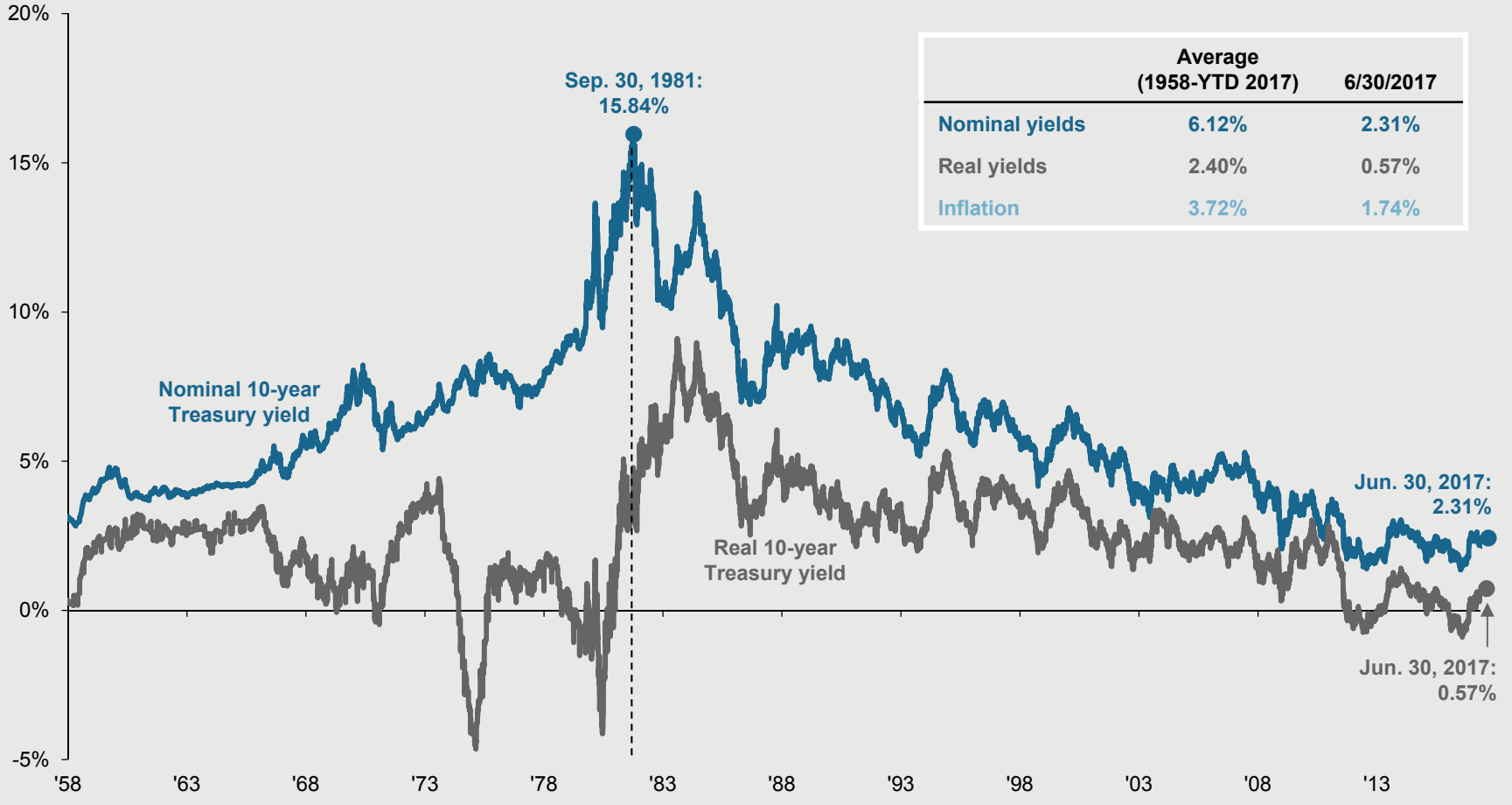

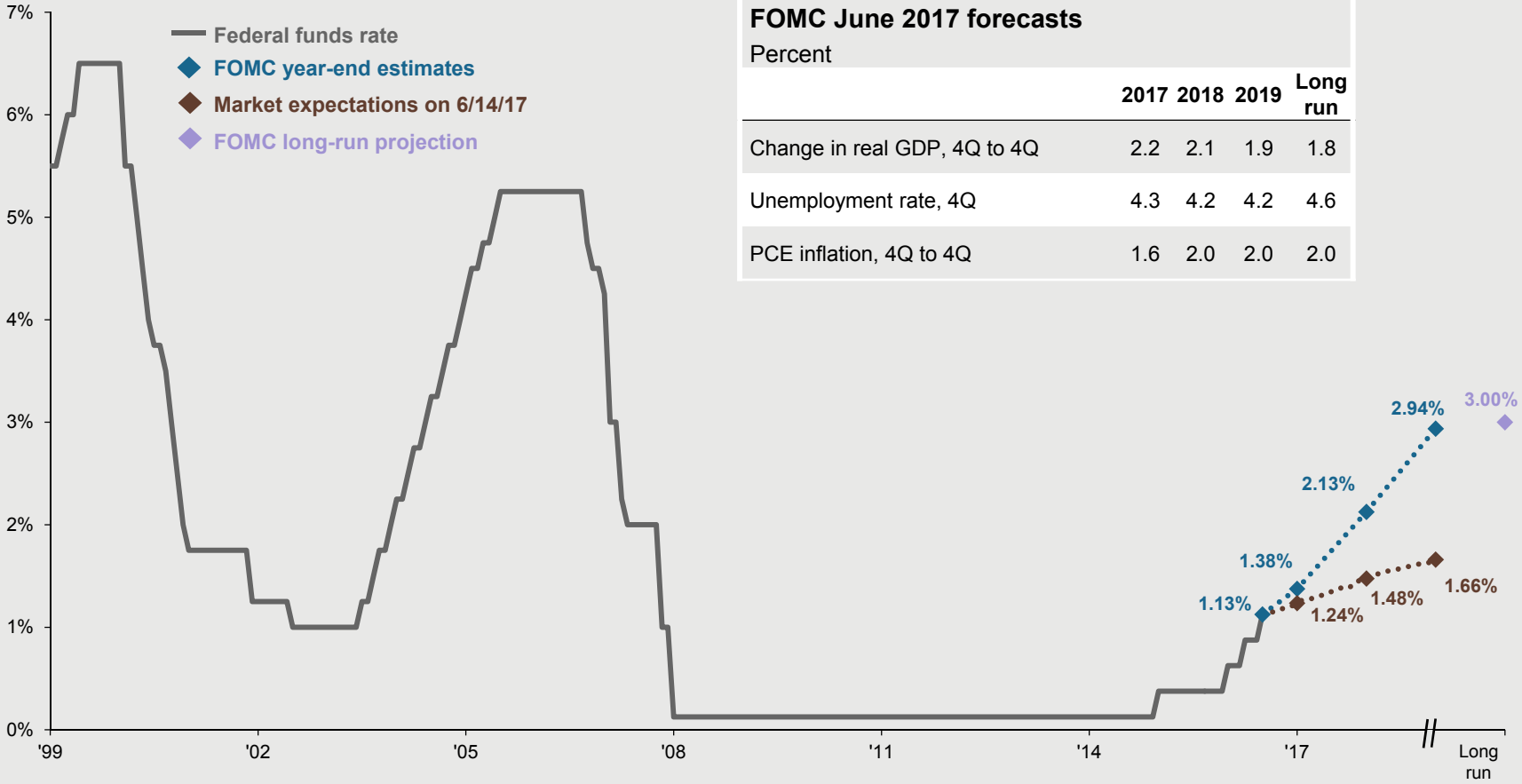
Nominal and real 10-year Treasury yields

FOMC and market expectations for the fed funds rate

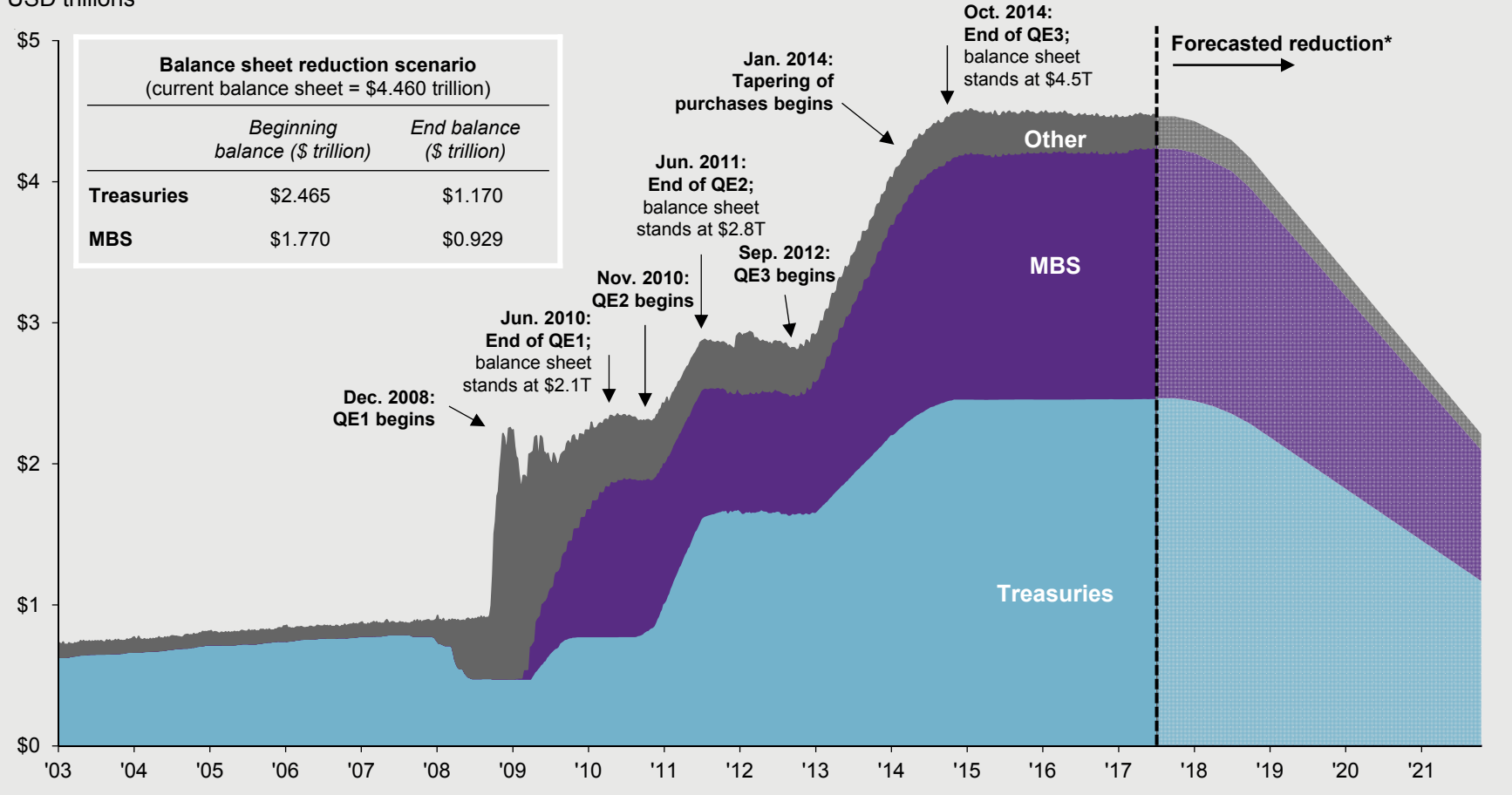

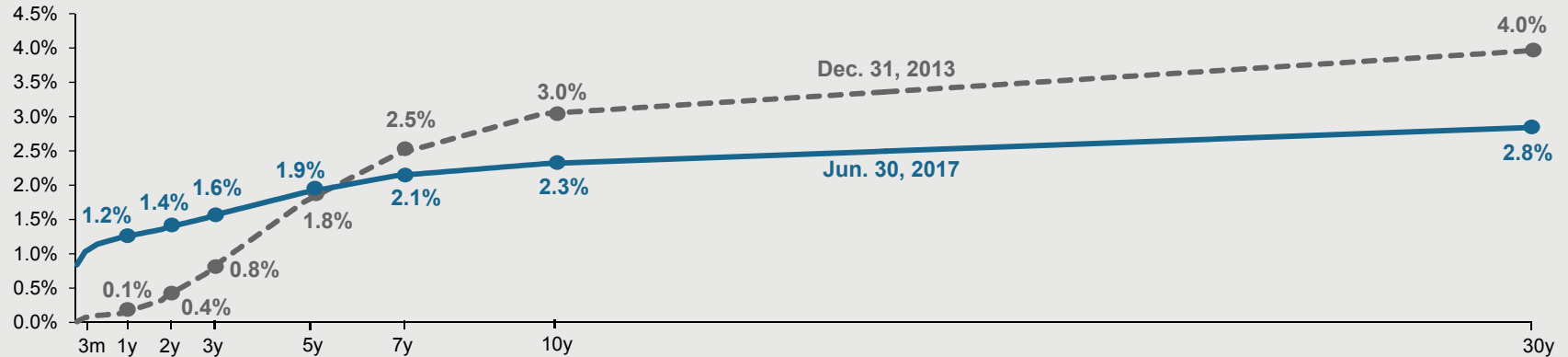

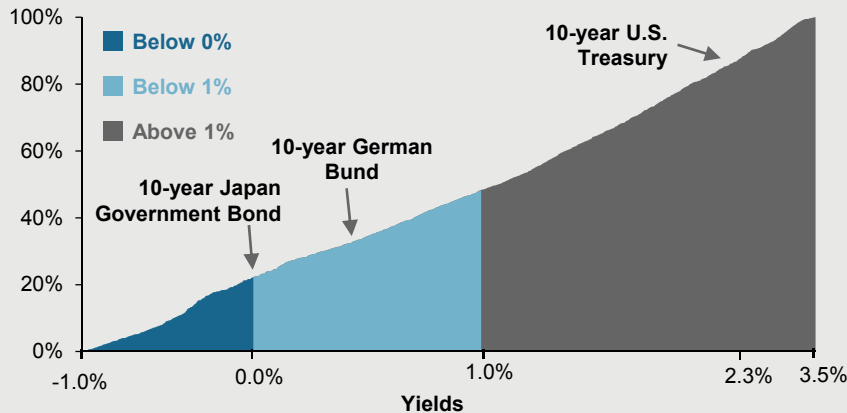

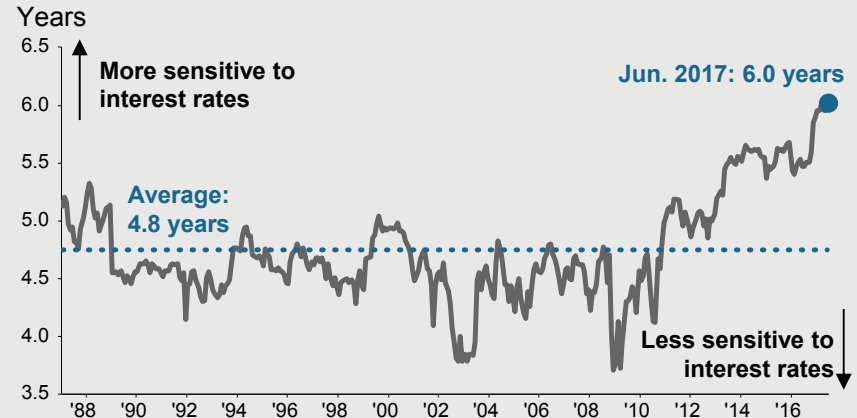
U.S. Treasury yield curve

Duration of Barclays U.S. Aggregate

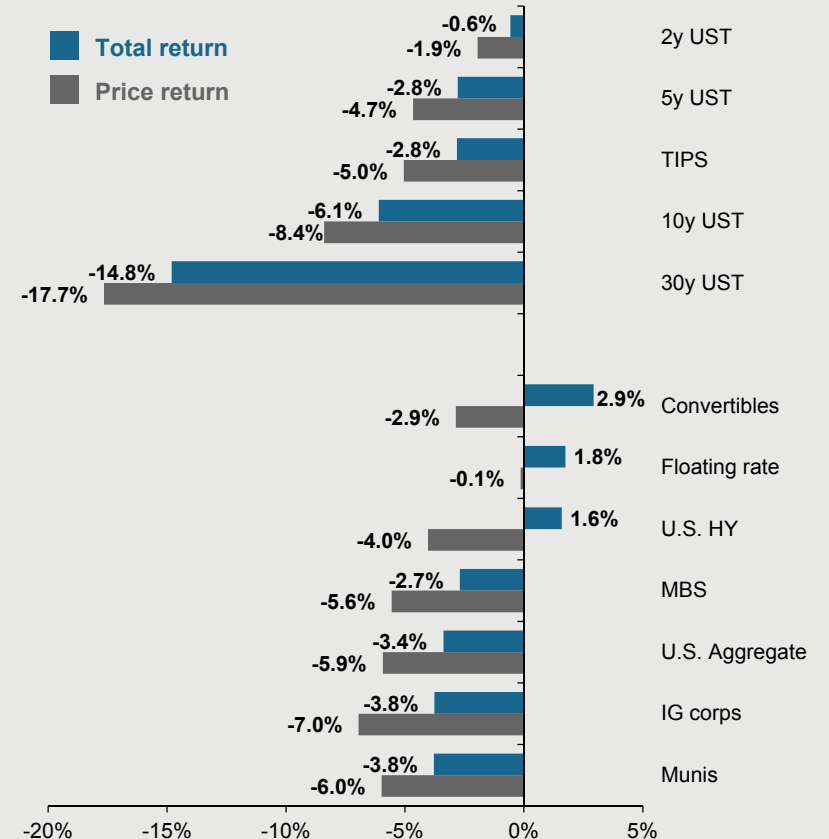

Assumes a parallel shift in the yield curve and steady spreads



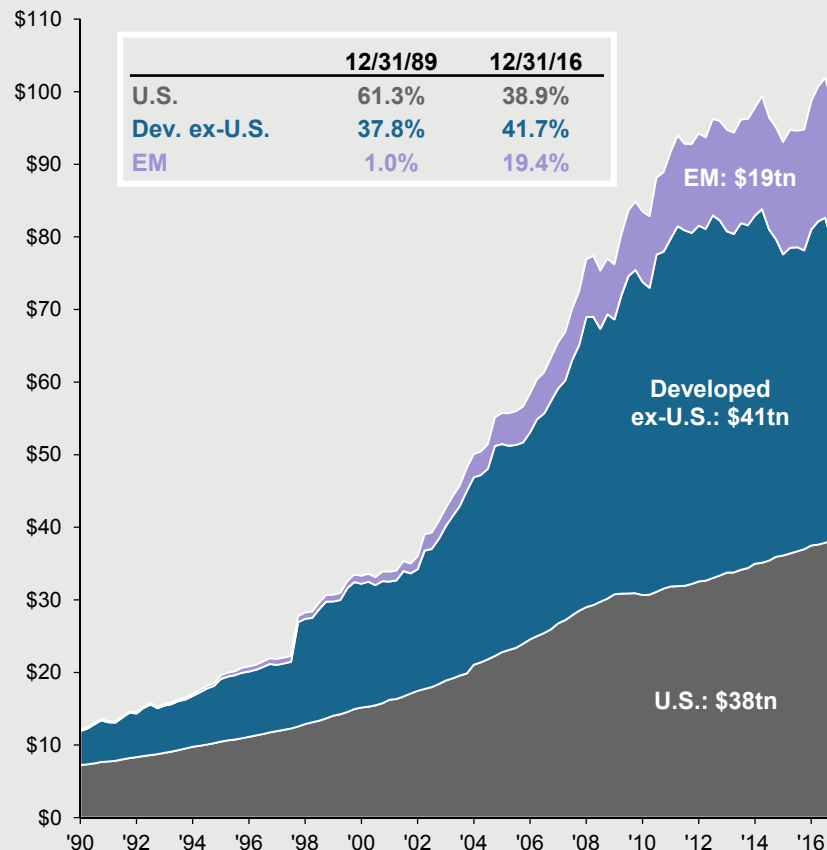

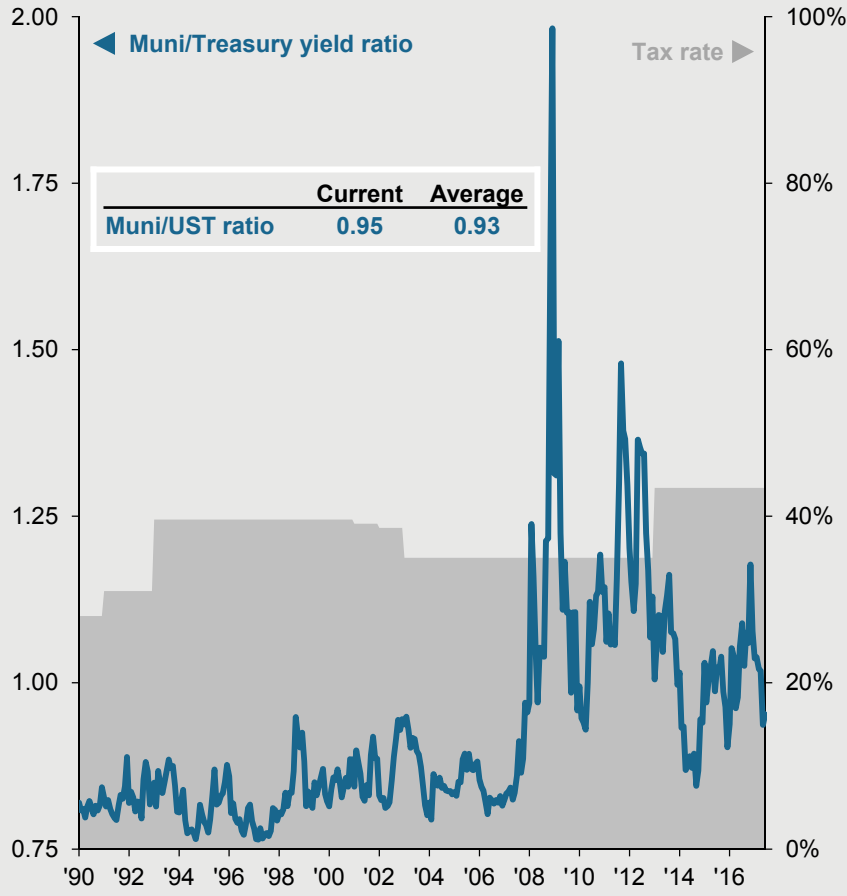

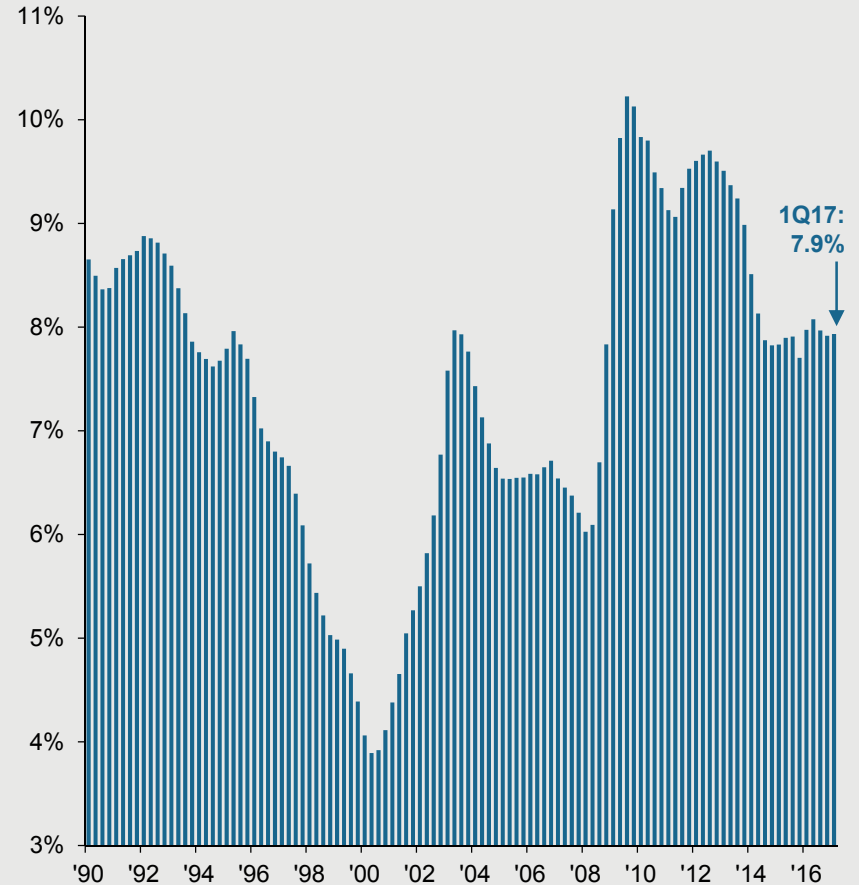

Municipal and Treasury bond yields and the tax rate

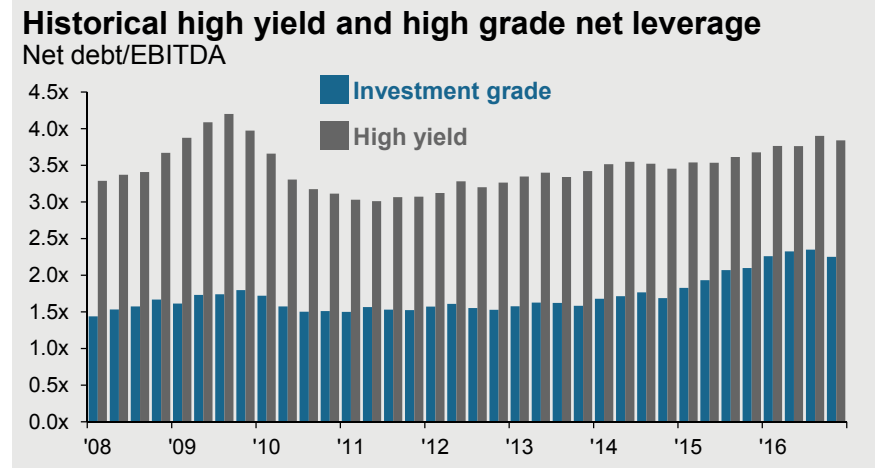
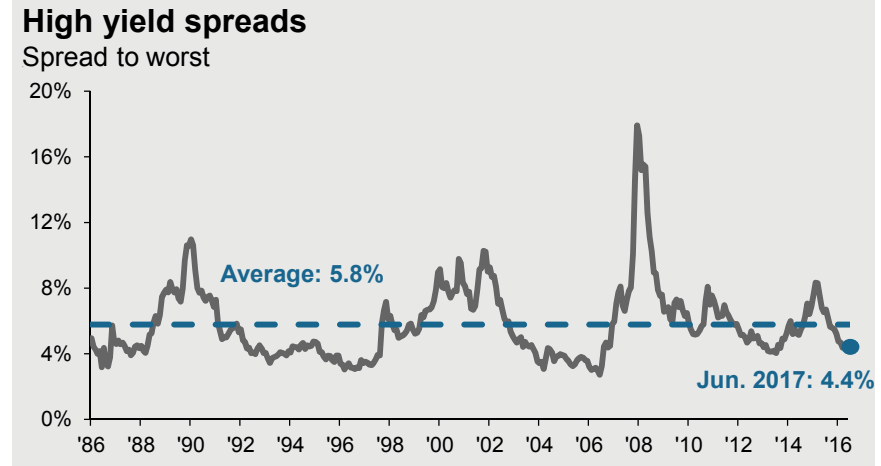
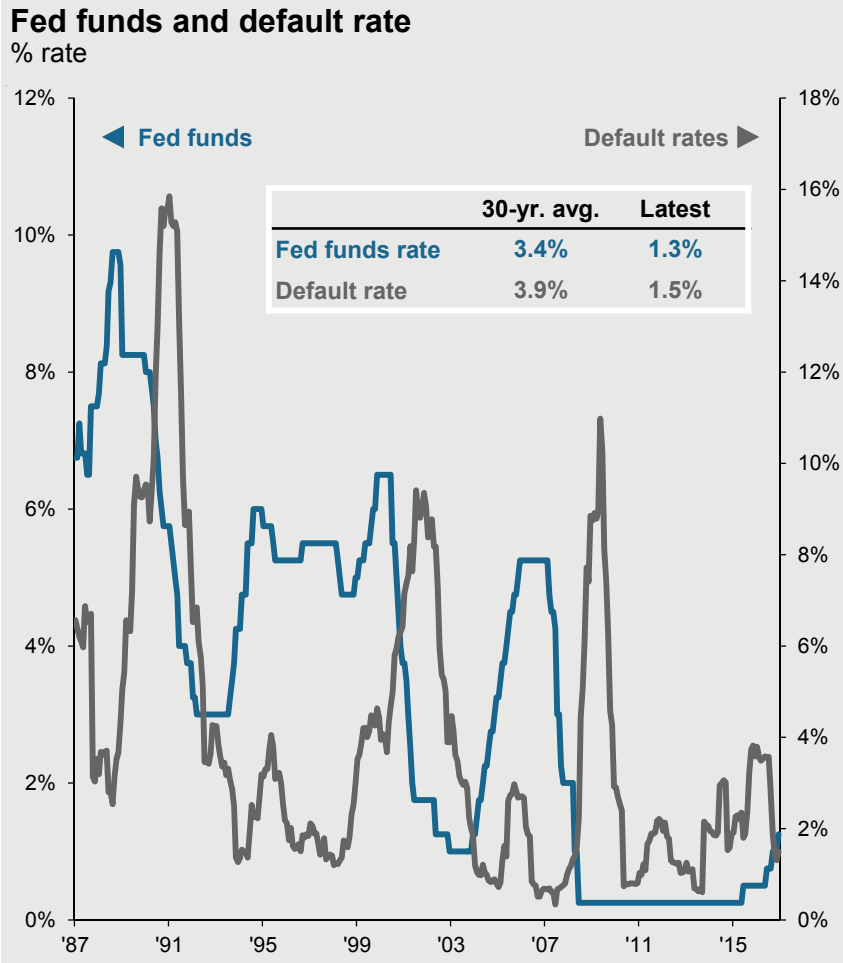


State and local government debt service

Debt service as % of state and local revenue



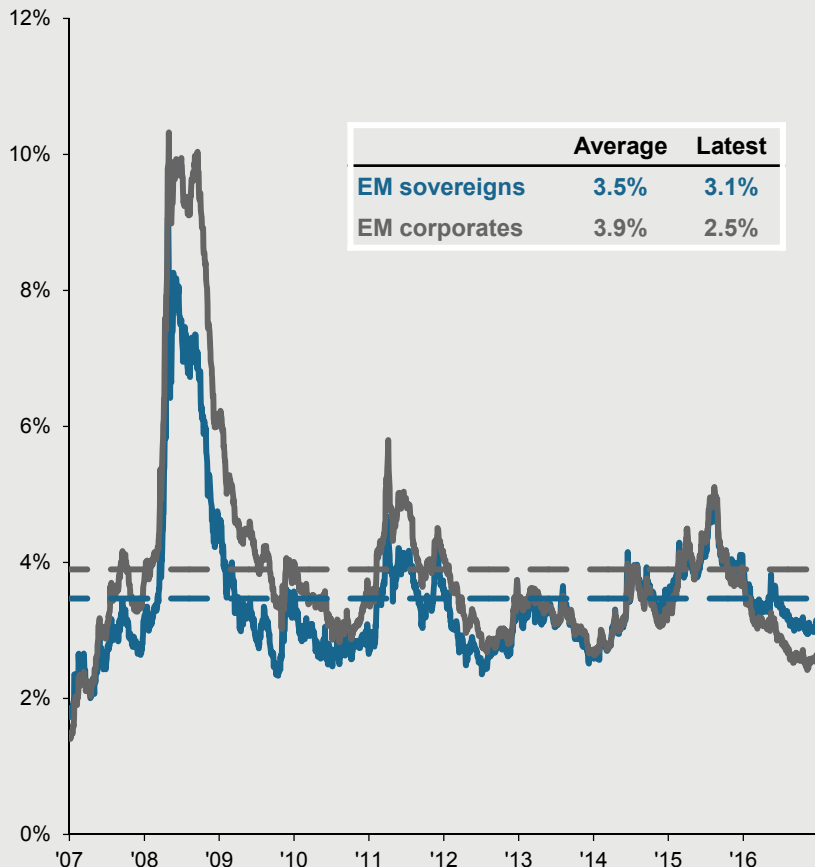

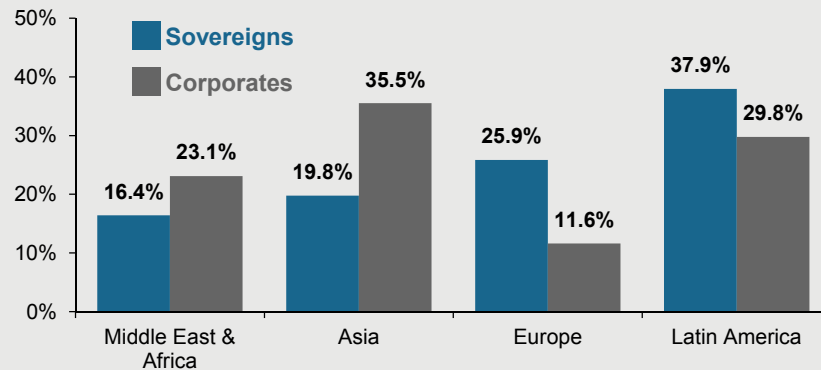
Corporate and sovereign EMD spreads

USD-denominated debt, percentage points over Treasury



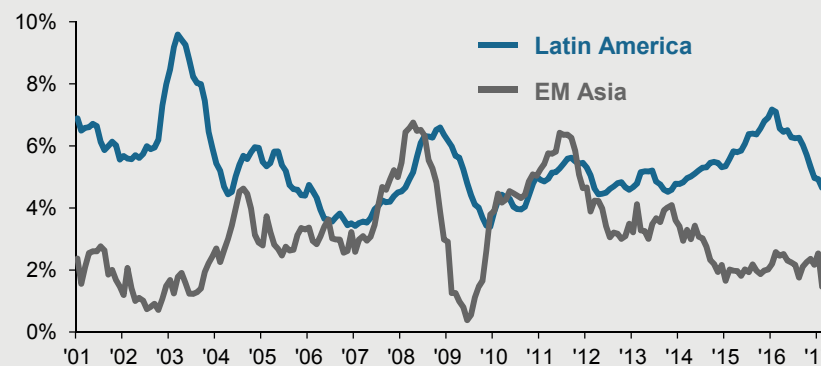
Regional weights in EMD indices

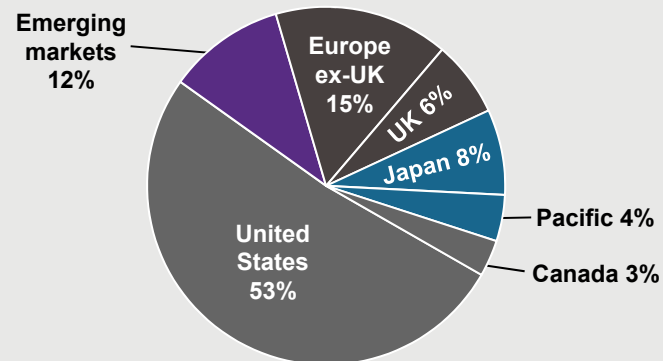

Rolling 1-year correlations, 30 countries



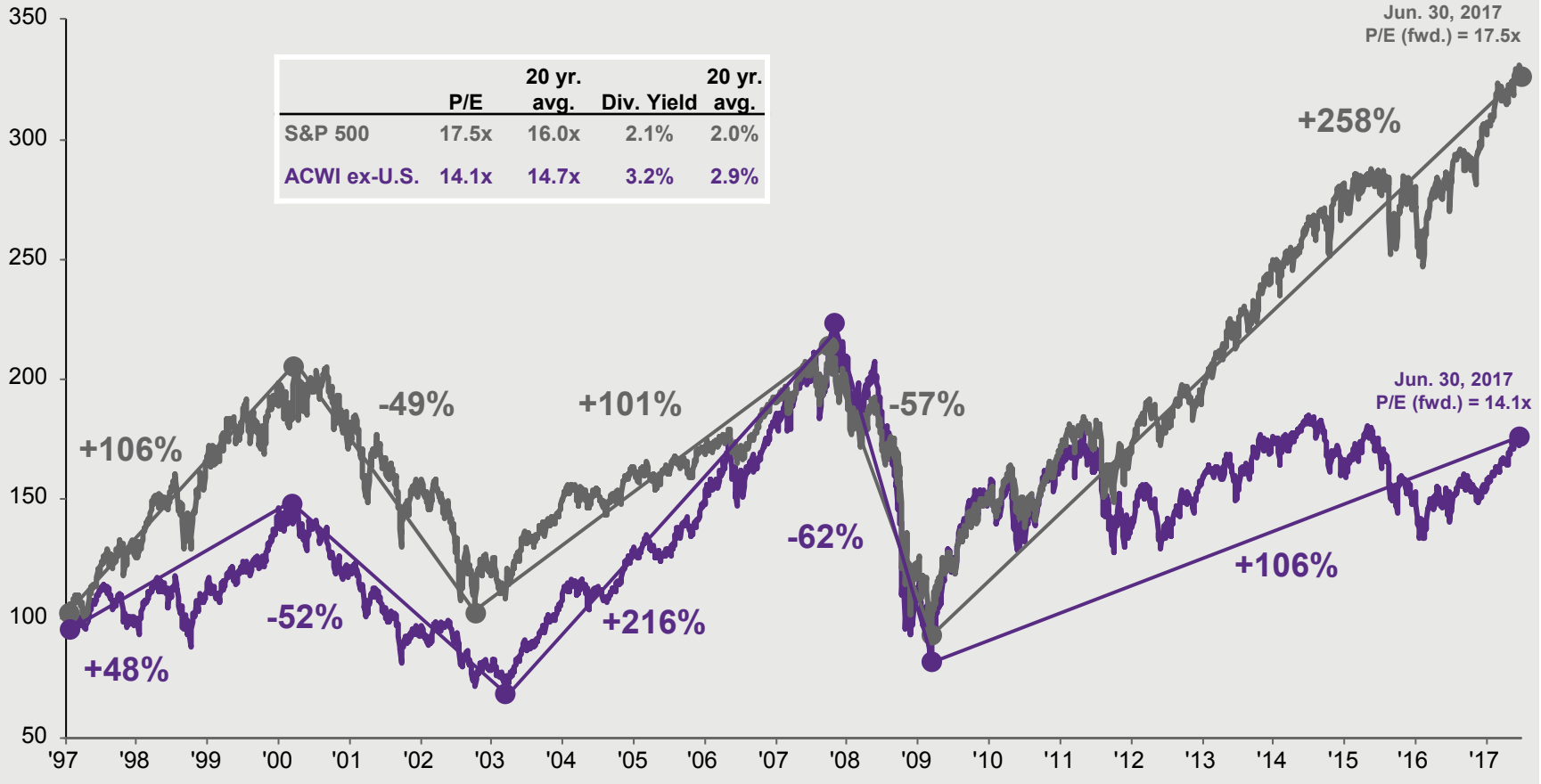

Dec. 1996 = 100, U.S. dollar, price return



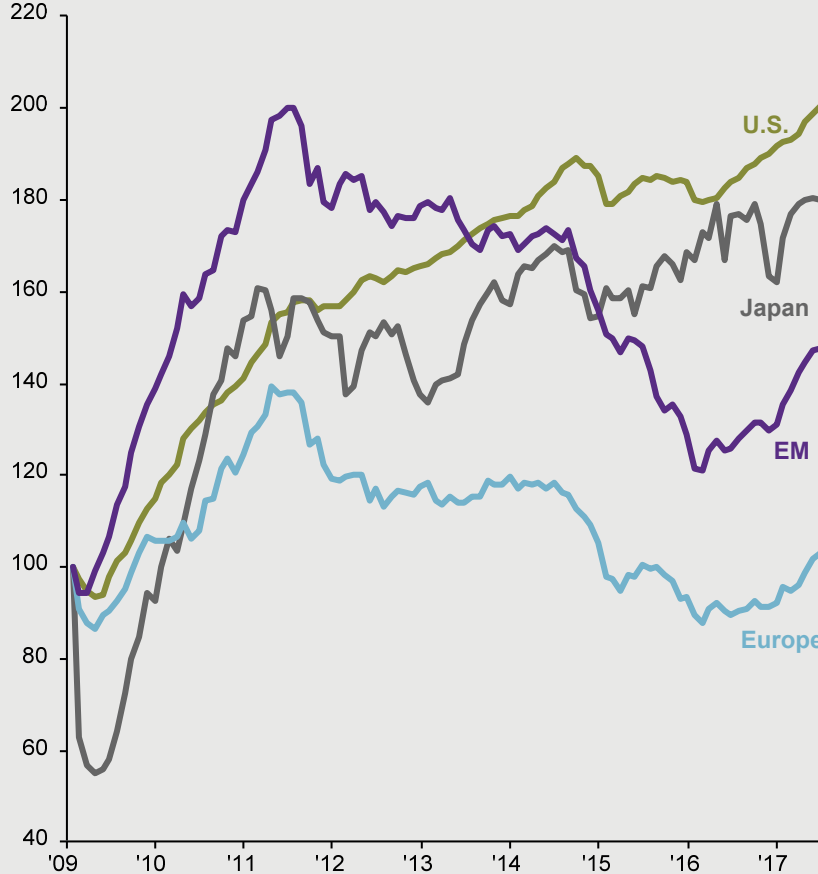

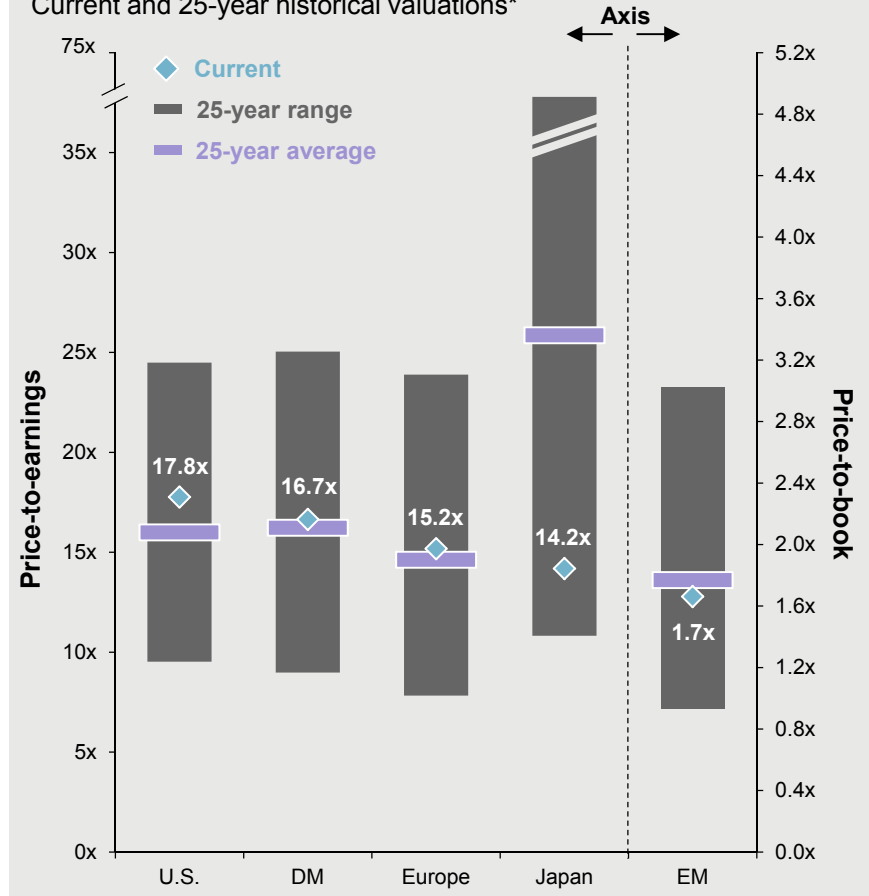

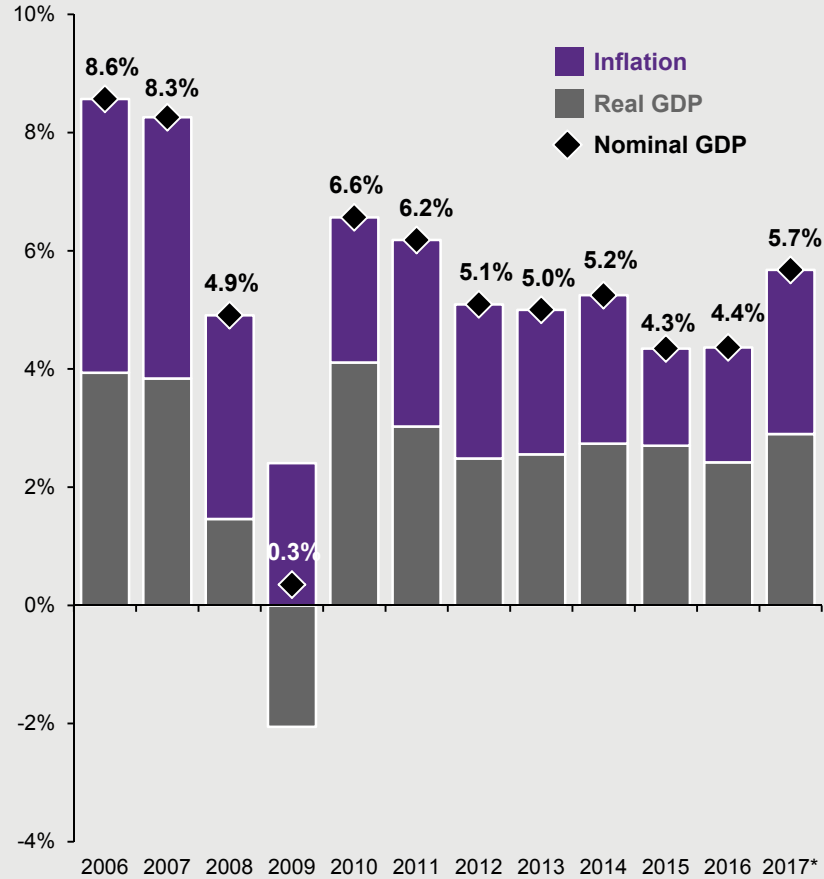

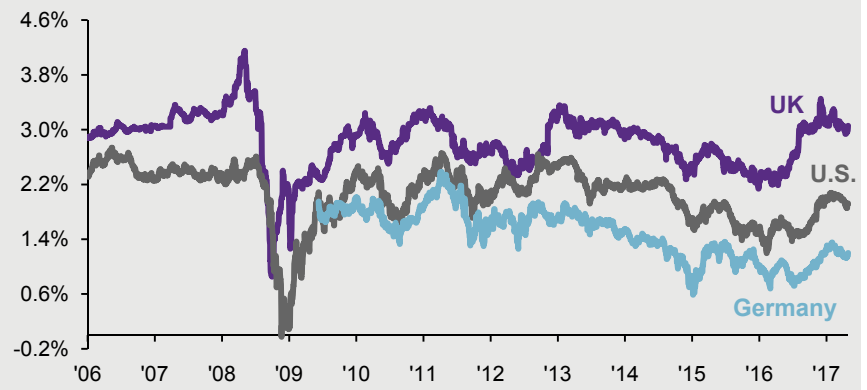

Nominal GDP growth broken down into real GDP growth and inflation



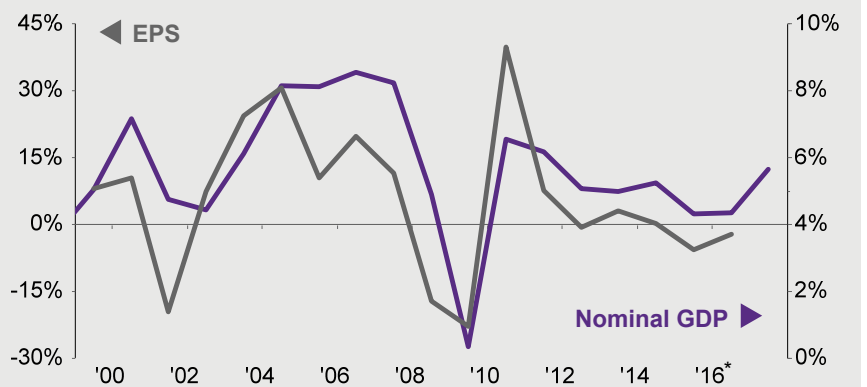
Global inflation breakevens

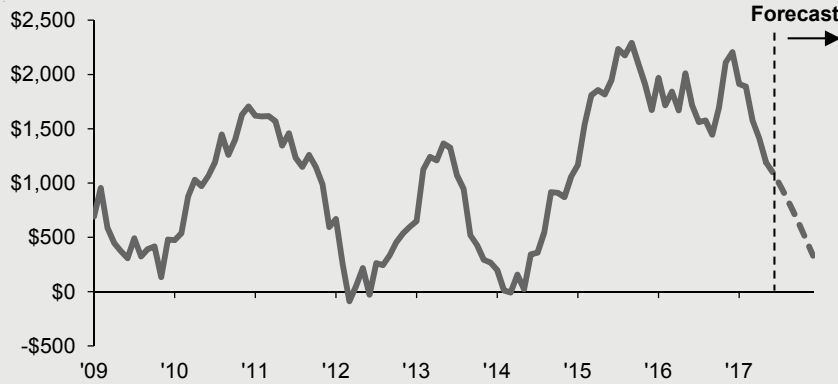
Year-over-year growth, nominal GDP, MSCI AC World trailing EPS



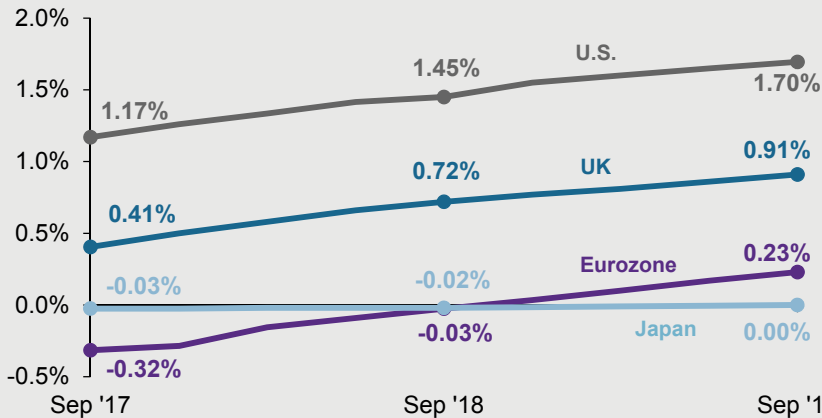

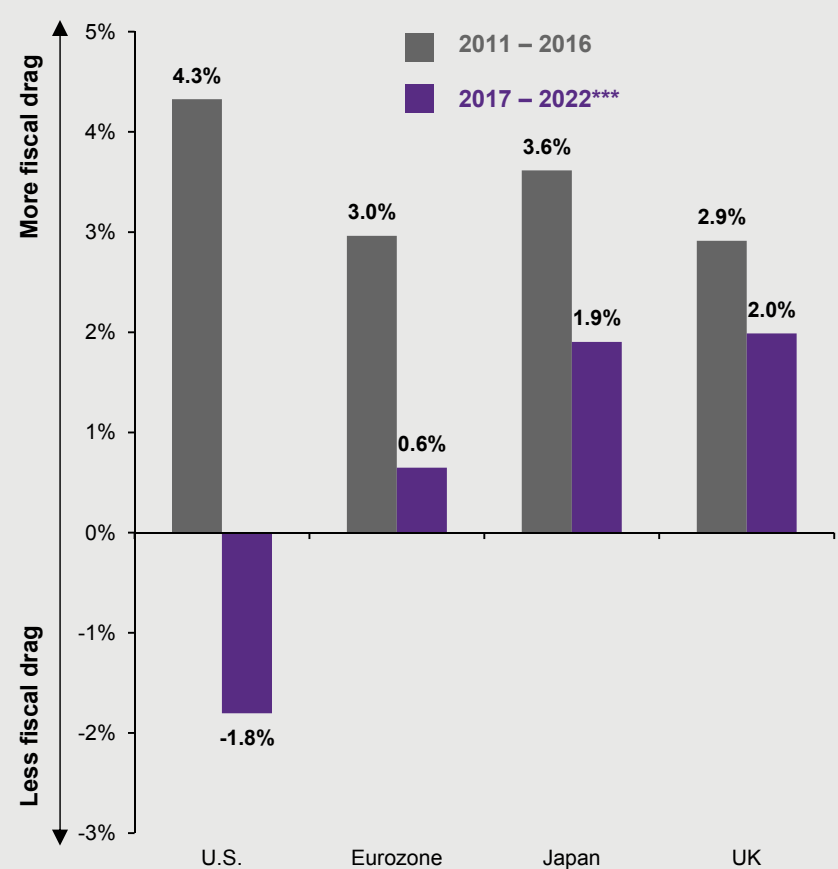

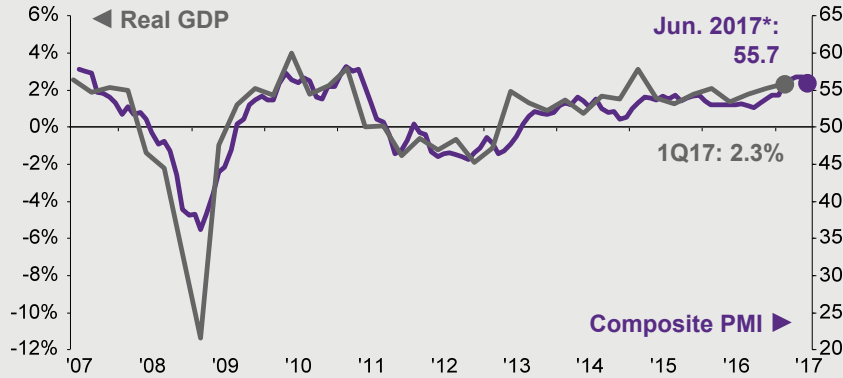

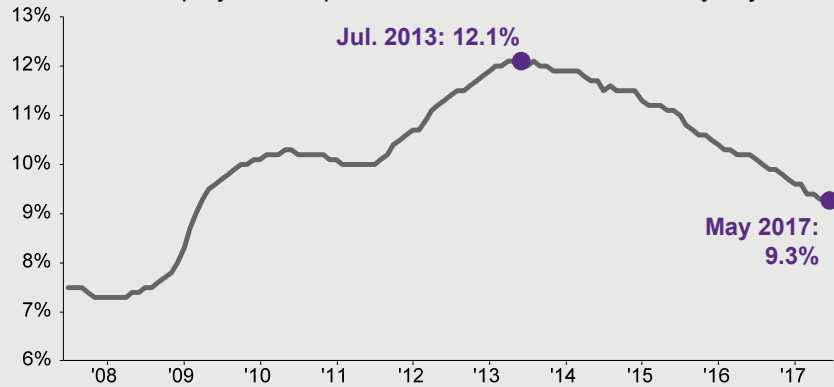
Markit PMI and GDP growth in the eurozone

Eurozone Markit Composite PMI Index and real GDP (q/q saar)



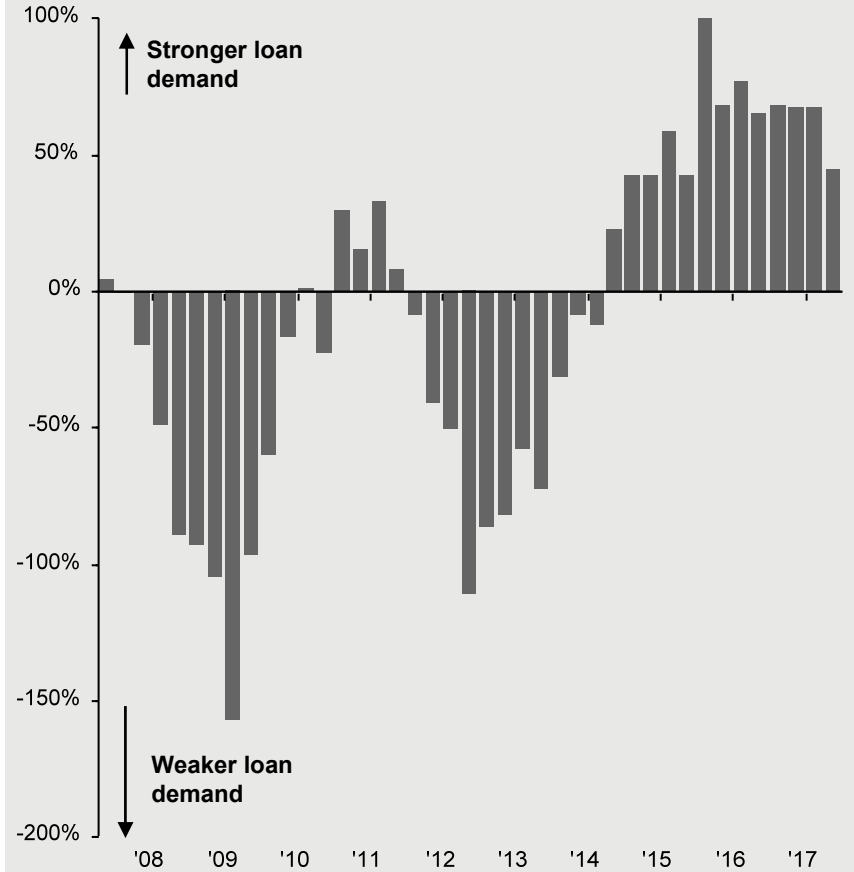
Eurozone unemployment

Eurozone credit demand

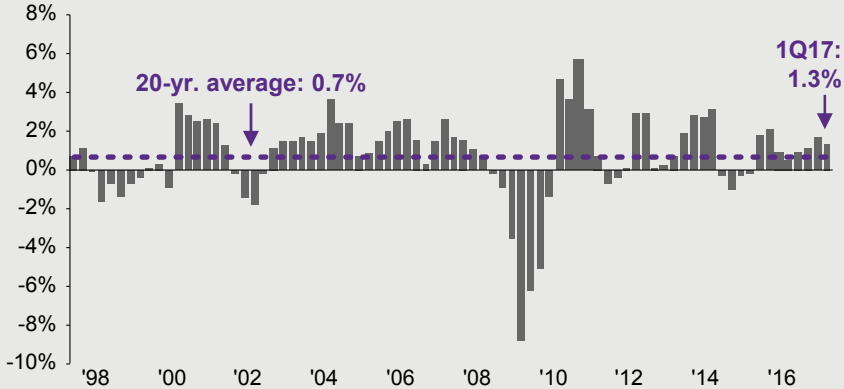
Net % of banks reporting positive loan demand

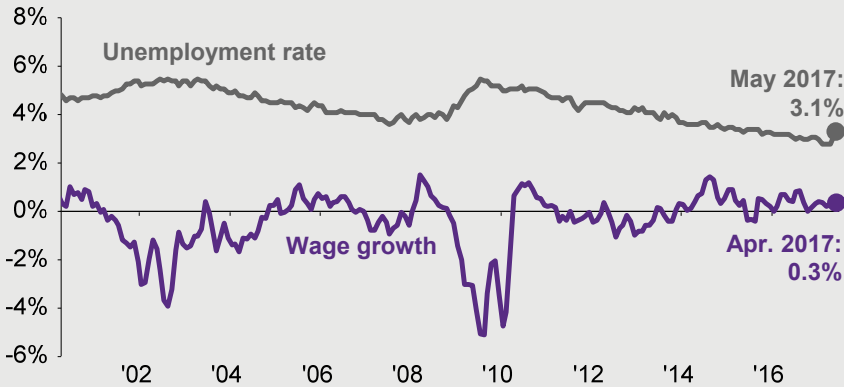

Real GDP, y/y % change

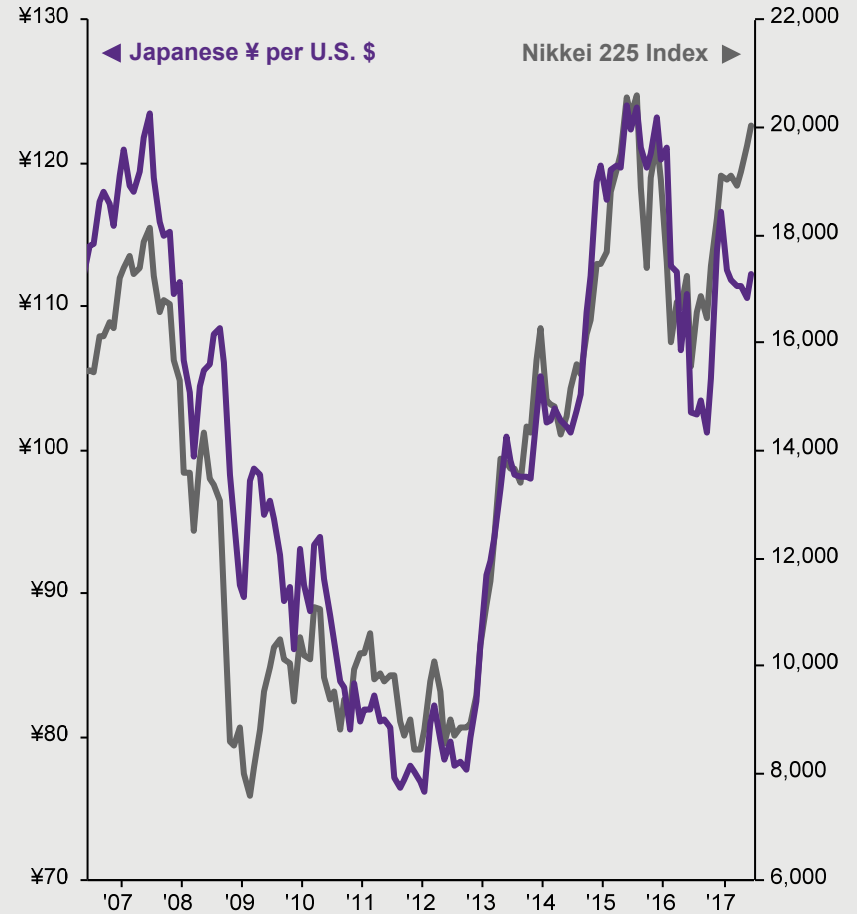


Japanese labor market

Unemployment, y/y % change in wages, 3-month moving average



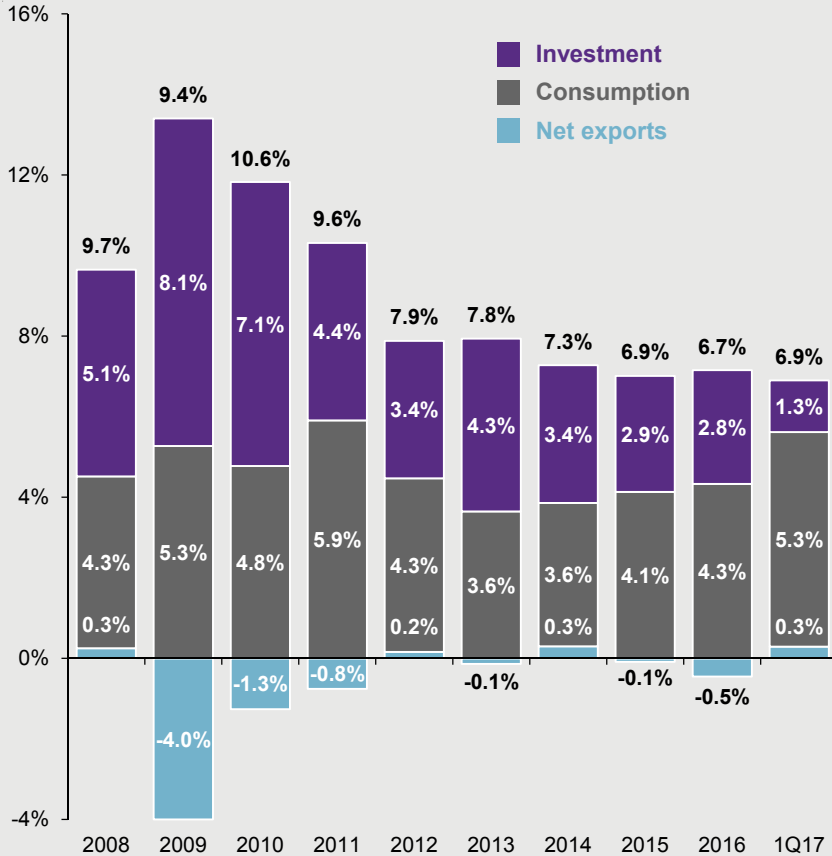
Japanese yen and the stock market

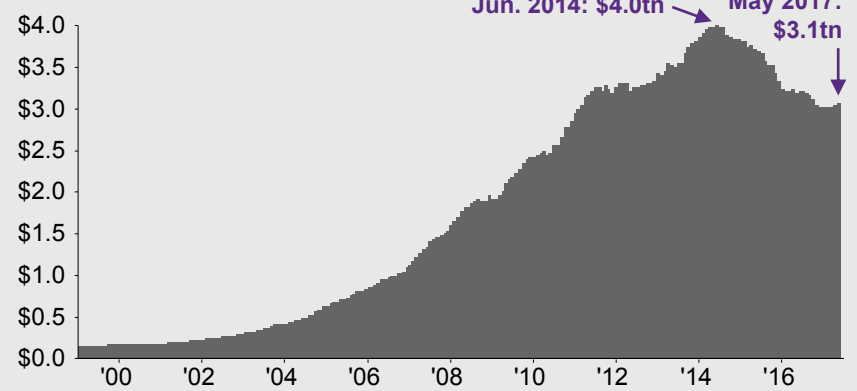
China real GDP contribution

Year-over-year % change



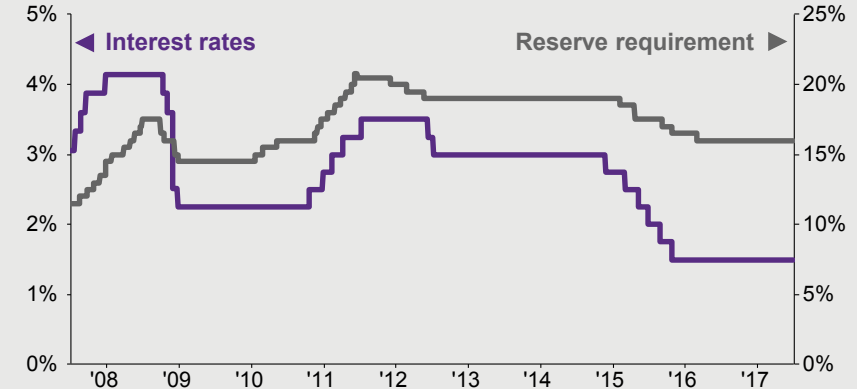

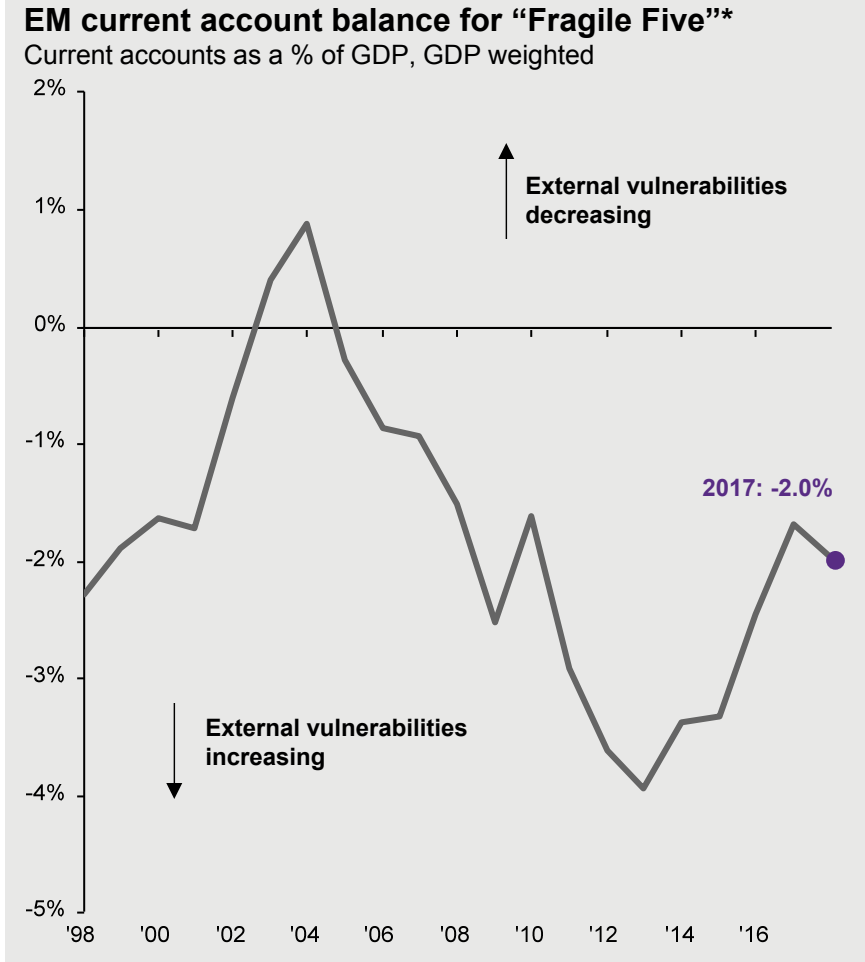
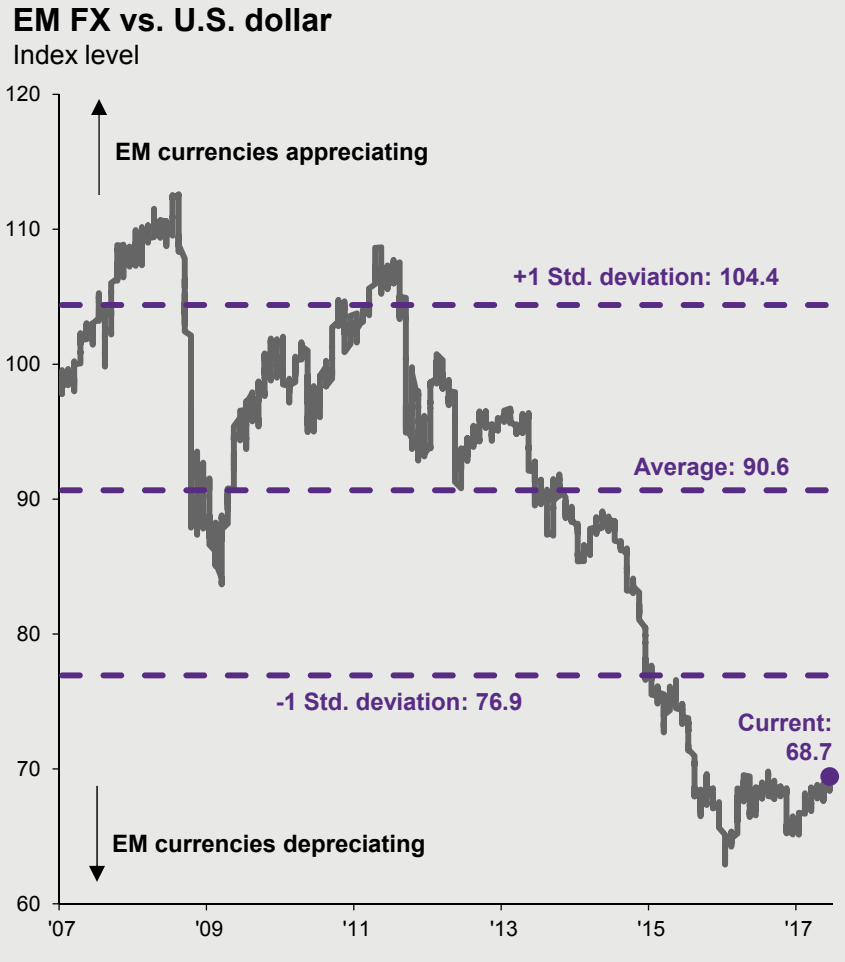

Policy rate on 1-year renminbi deposits



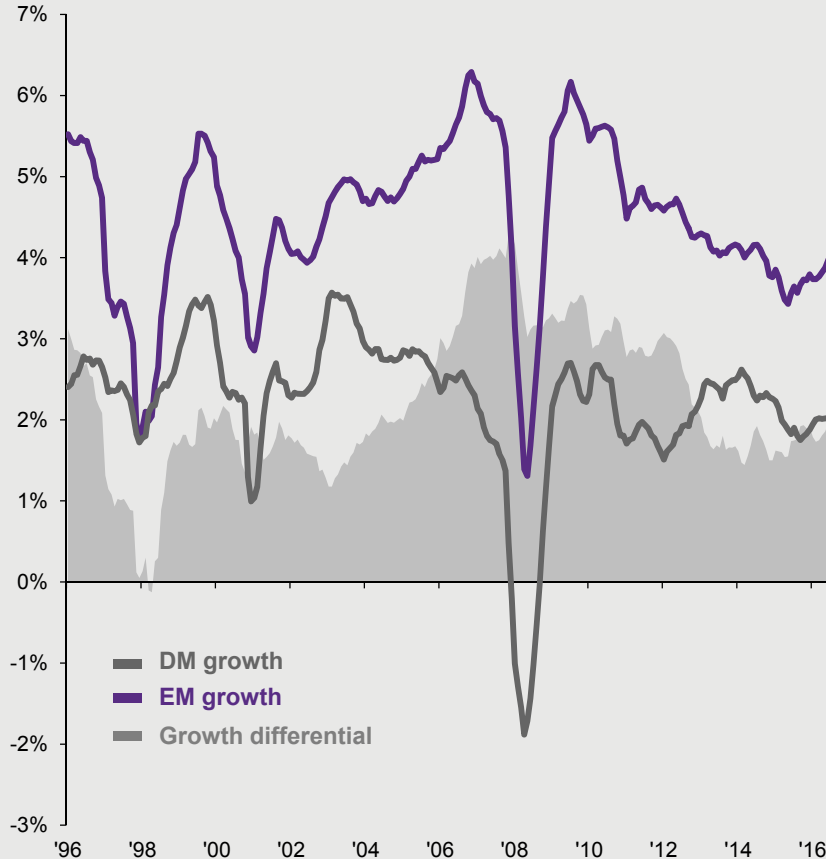

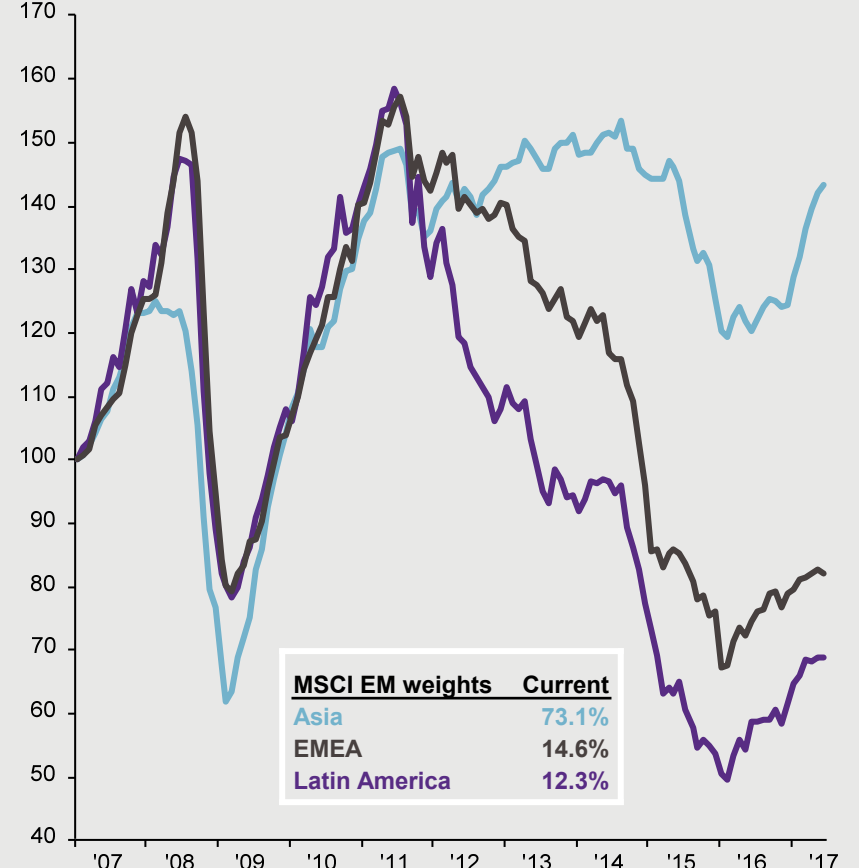
EM vs. DM growth

EPS for next 12-month consensus, U.S. dollar, rebased to 100



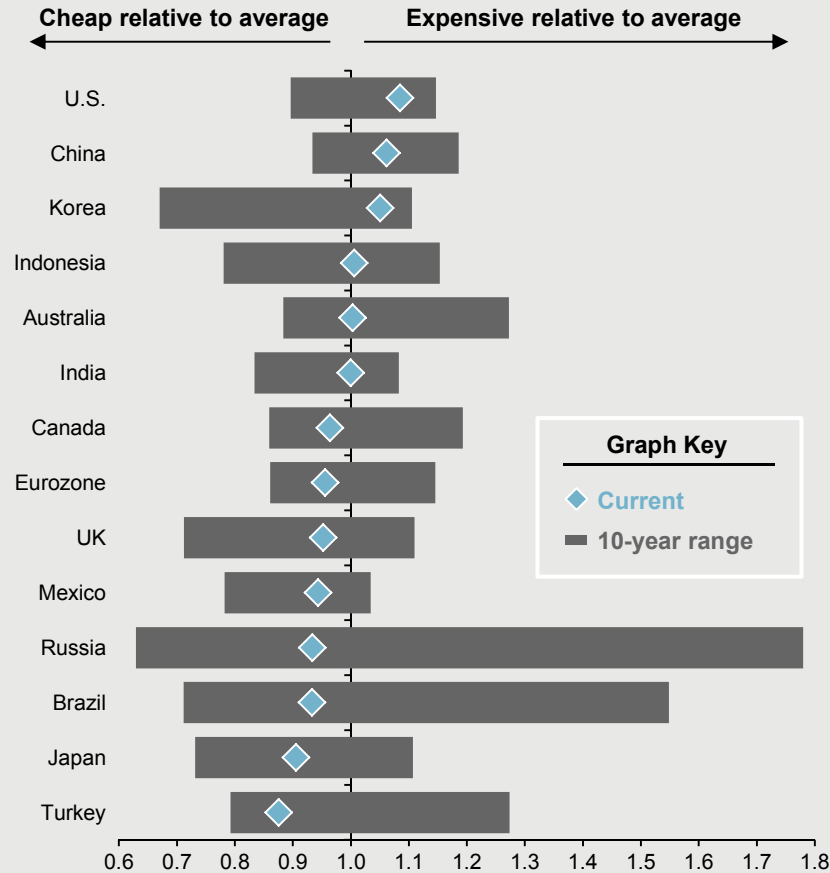

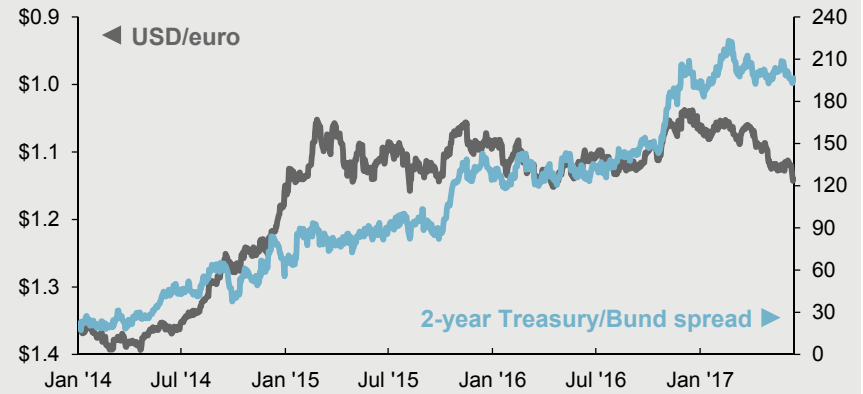

FX adjusted for relative inflation changes vs. 10-year average



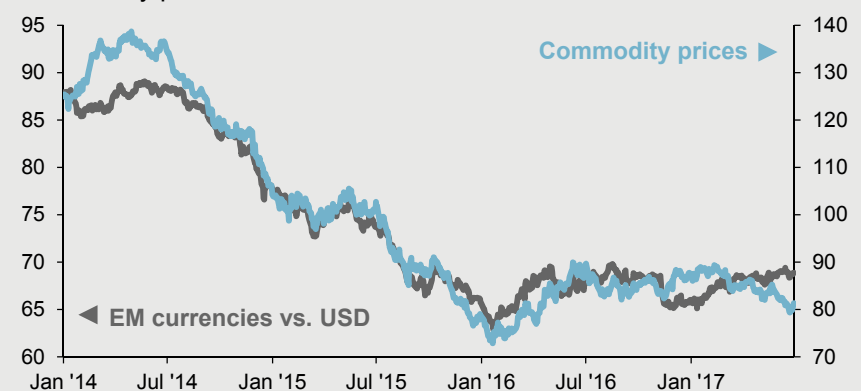

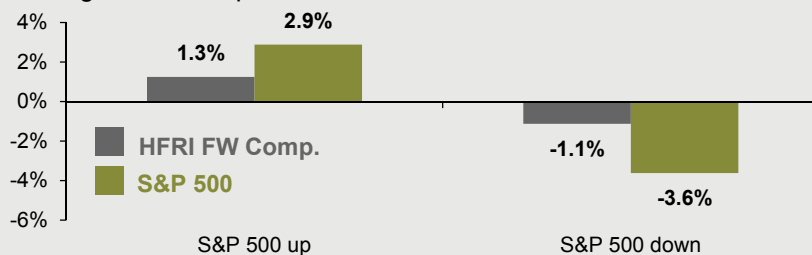

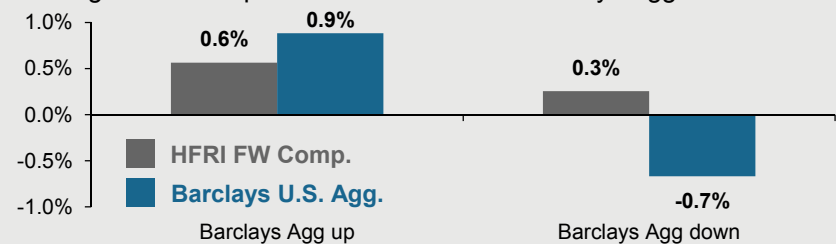
Hedge fund returns in different market environments

Hedge fund returns in different market environments

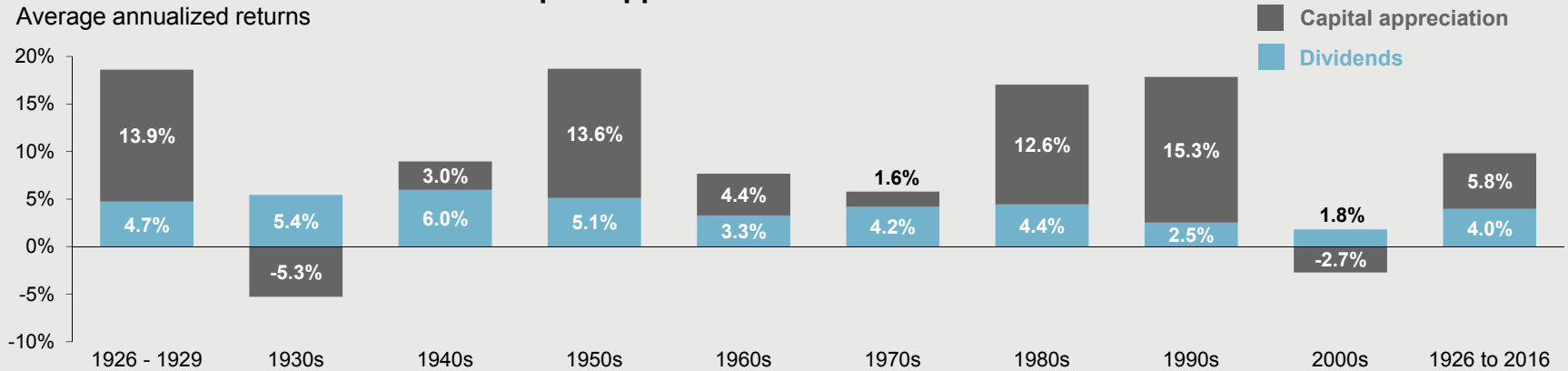
Average return in up and down months for Barclays Agg.



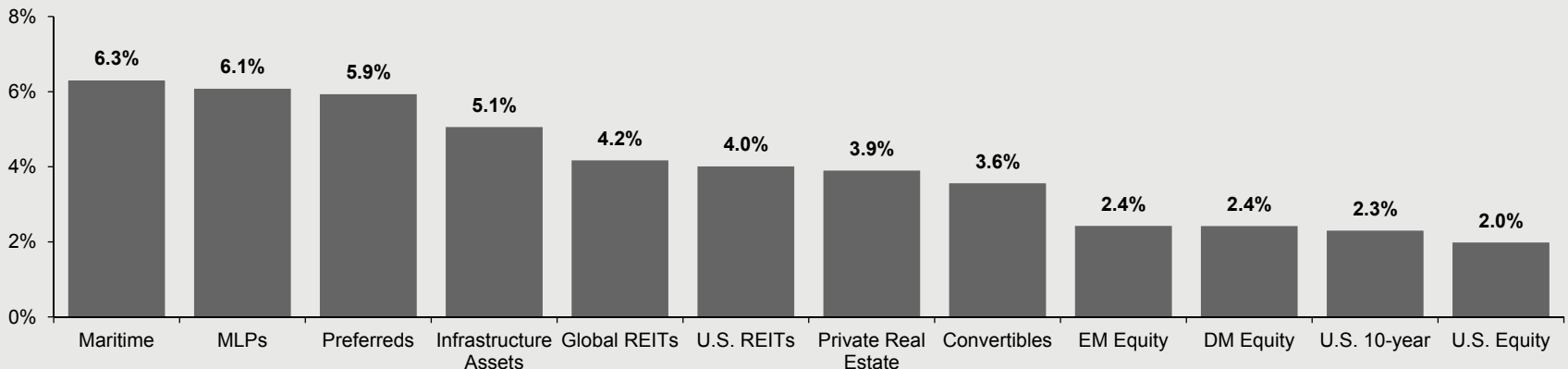

Average annualized returns



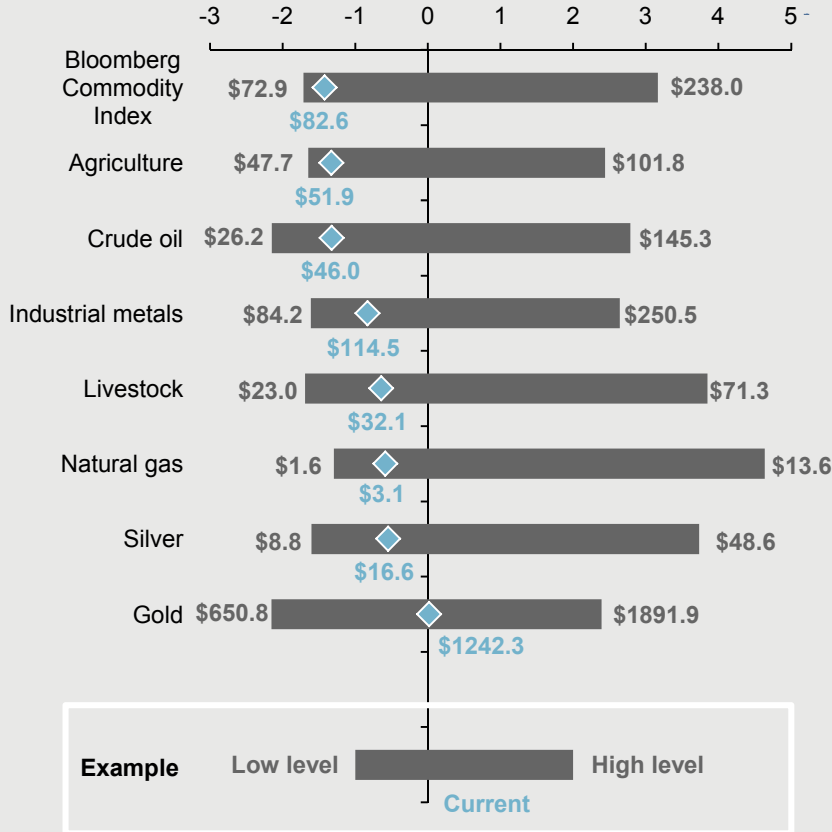

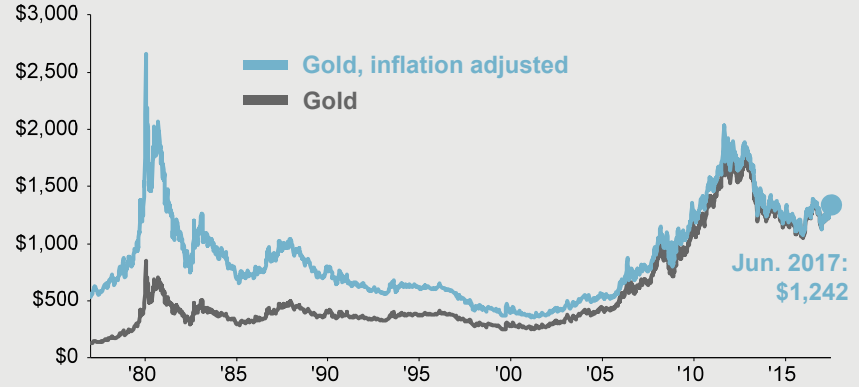
Commodity prices

Commodity price z-scores



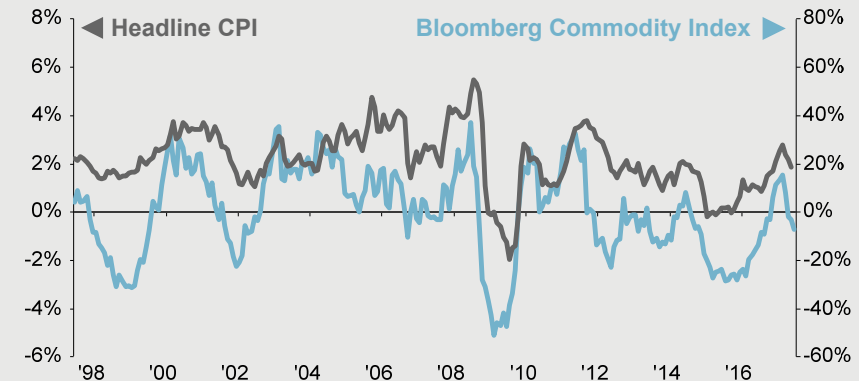
Gold prices

Year-over-year % change

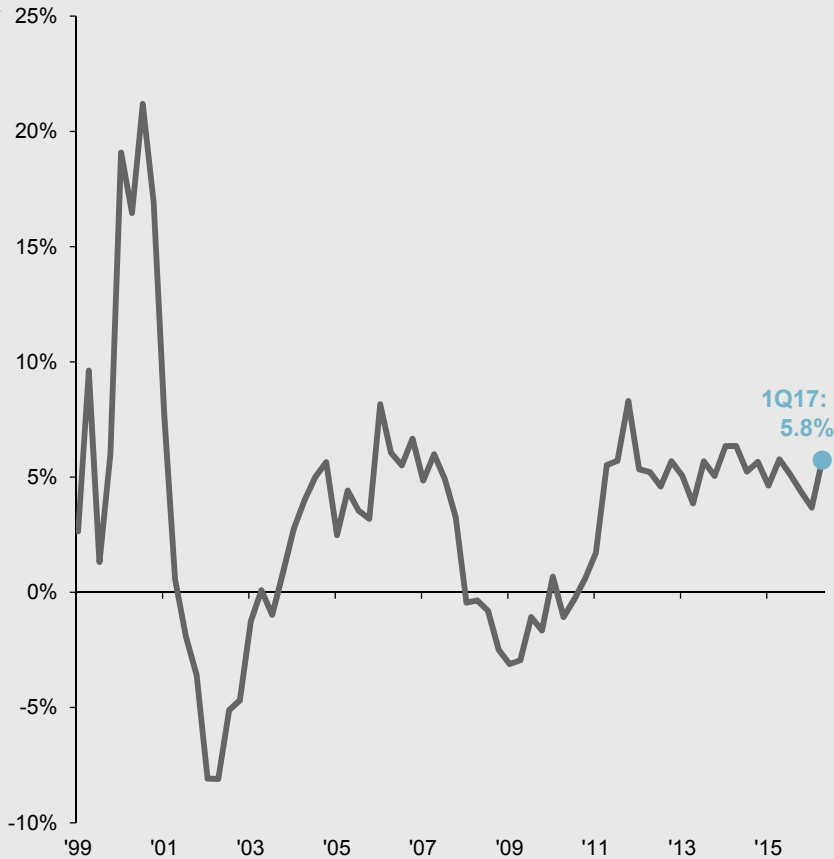

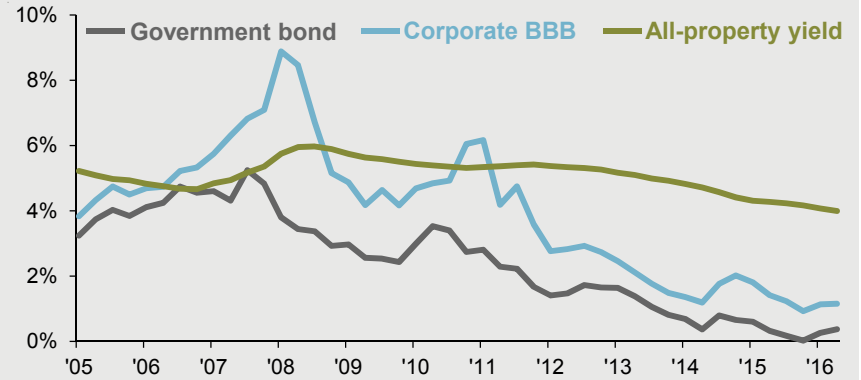
U.S. real estate net operating income growth

Year-over-year NPI-ODCE Index NOI growth



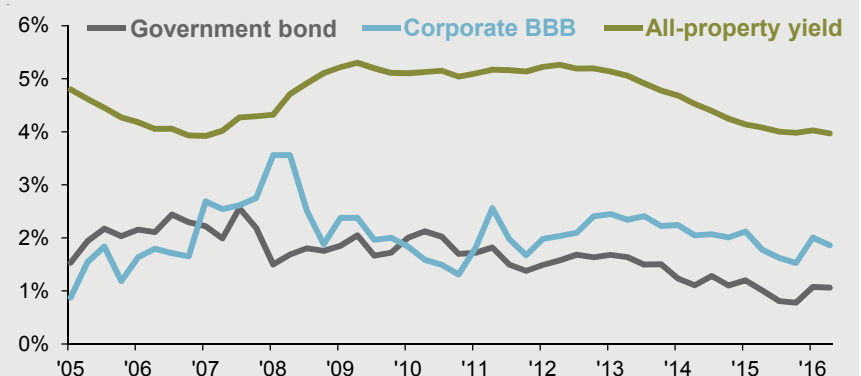
Europe real estate property yield spreads

Property yields vs. government bonds vs. BBB-rated bonds



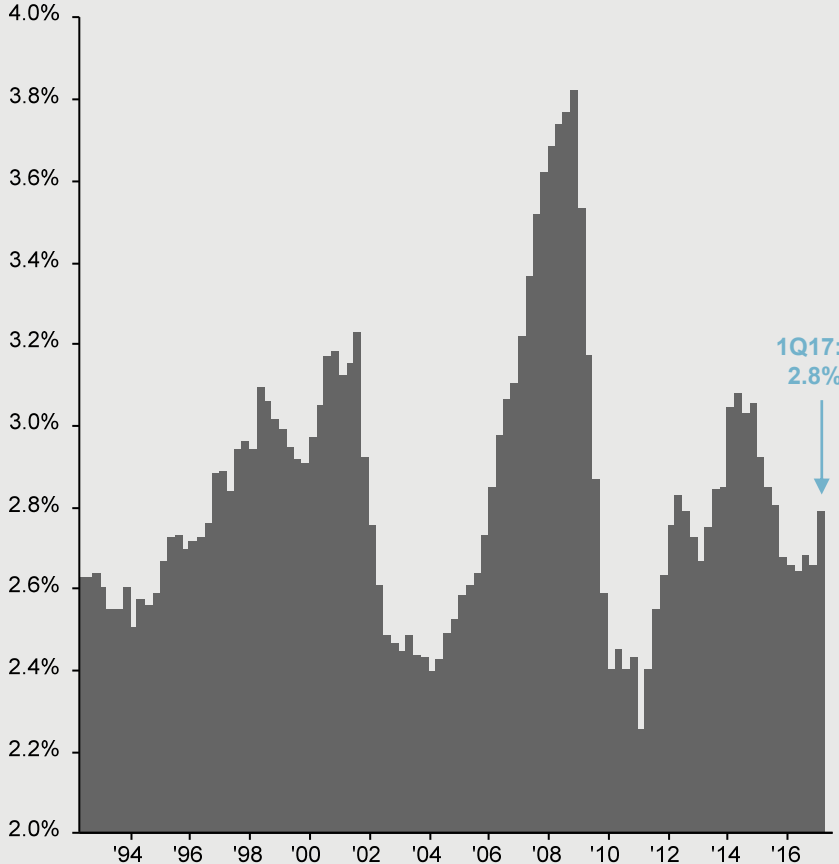

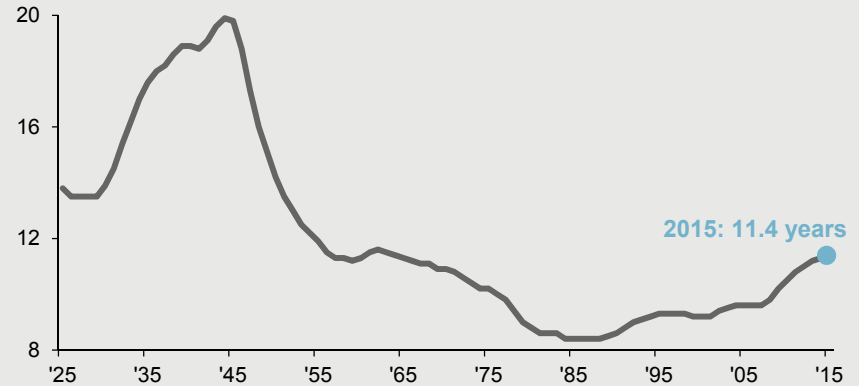
Investment in structures

Percent of nominal GDP



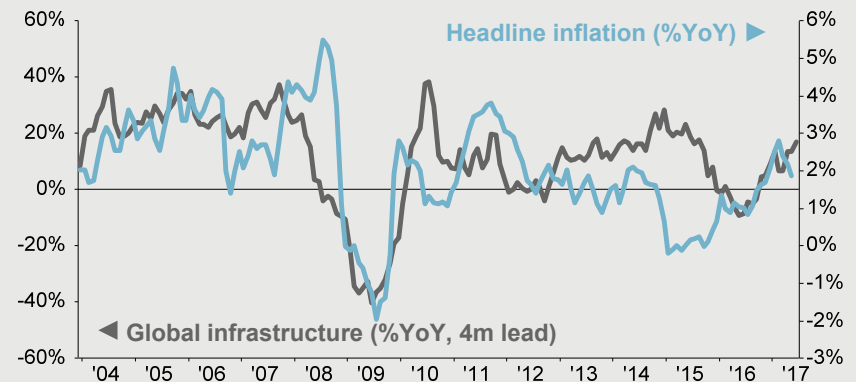
Average age of private fixed assets

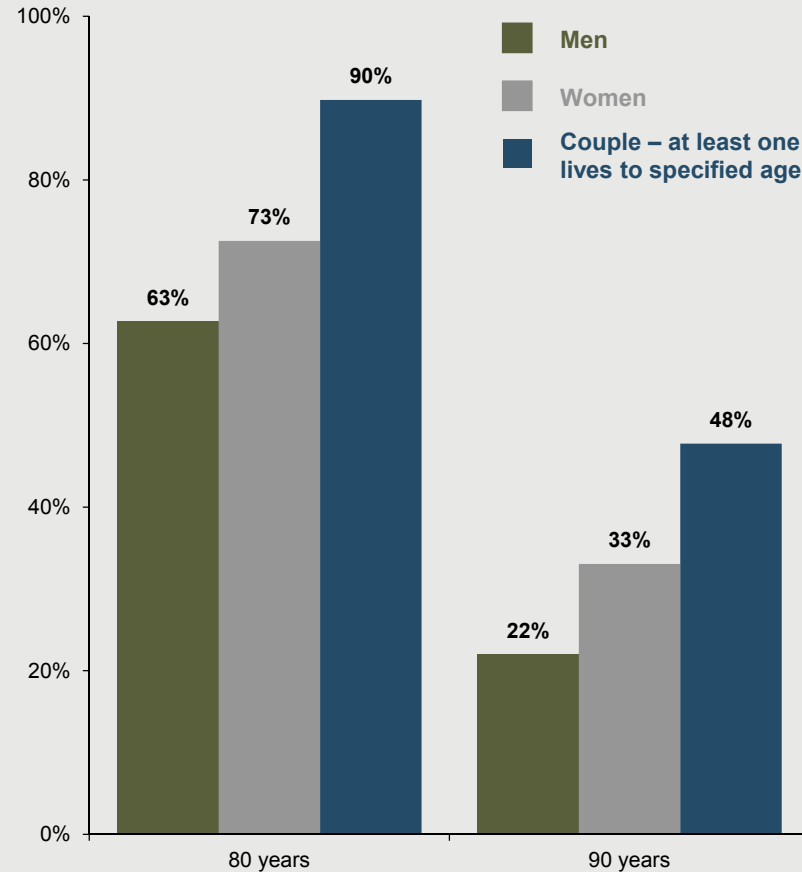

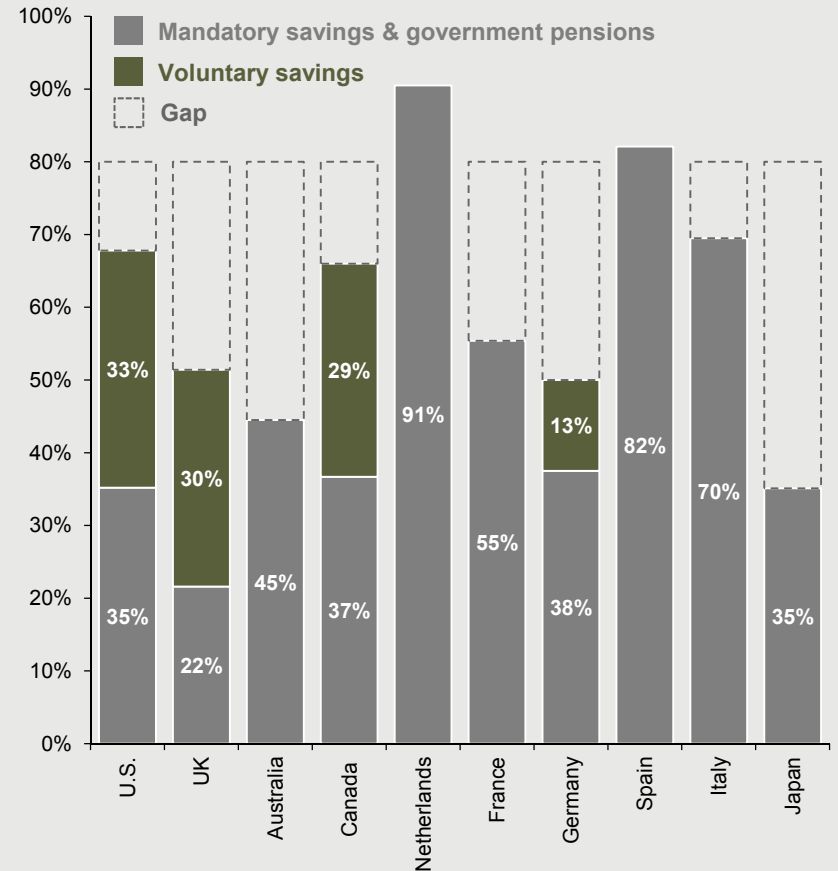
Probability of reaching ages 80 and 90

Mandatory and voluntary savings by country

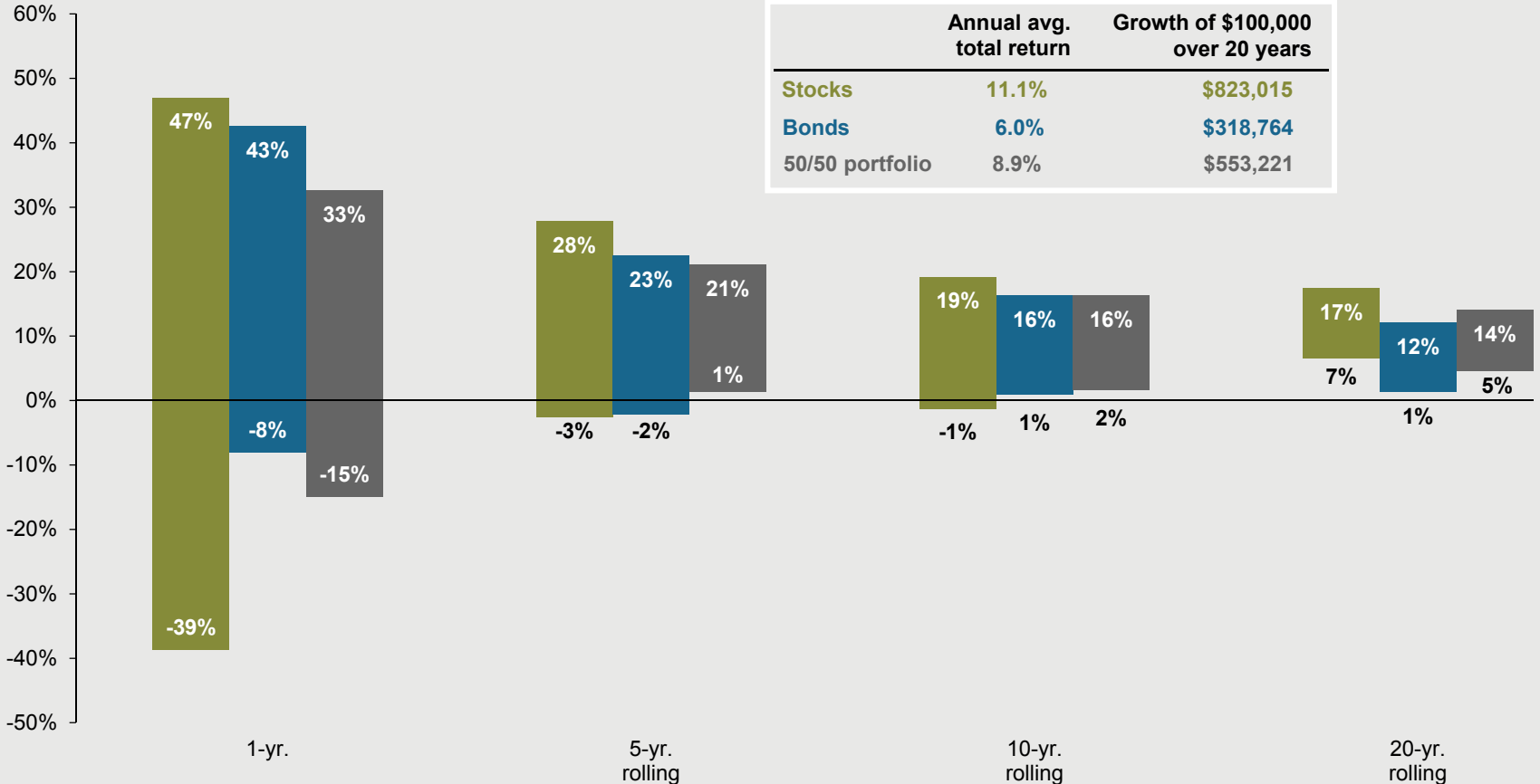
Contribution to pre-retirement income replacement goal of 80%

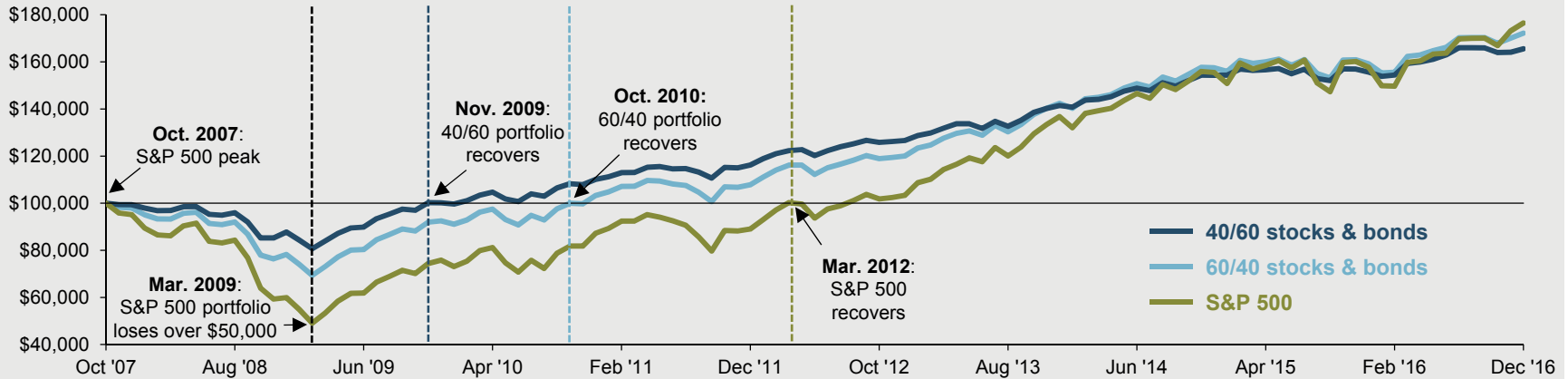
Range of stock, bond and blended total returns

Annual total returns, 1950-2016

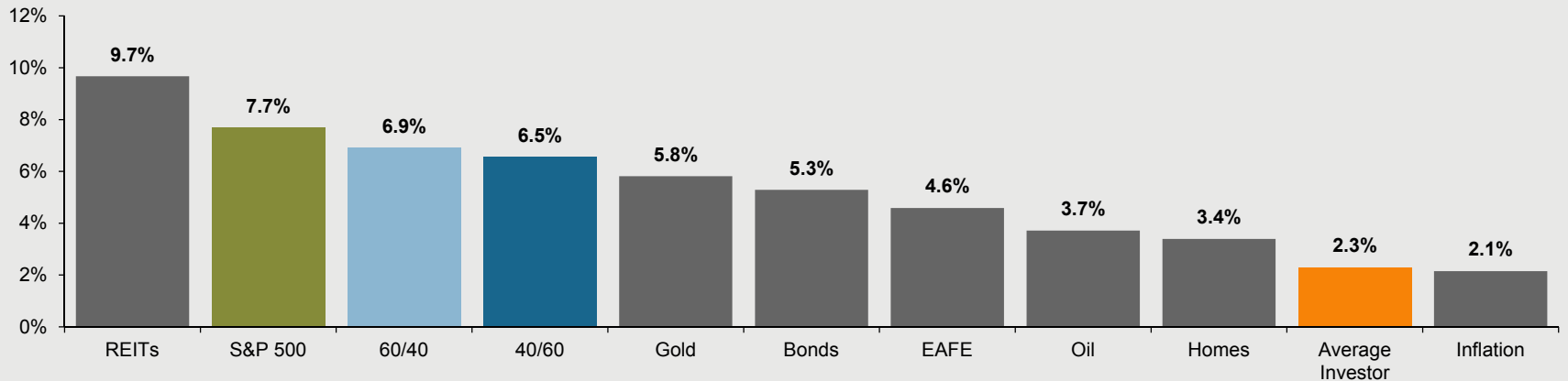

Portfolio returns: Equities vs. equity and fixed income blend



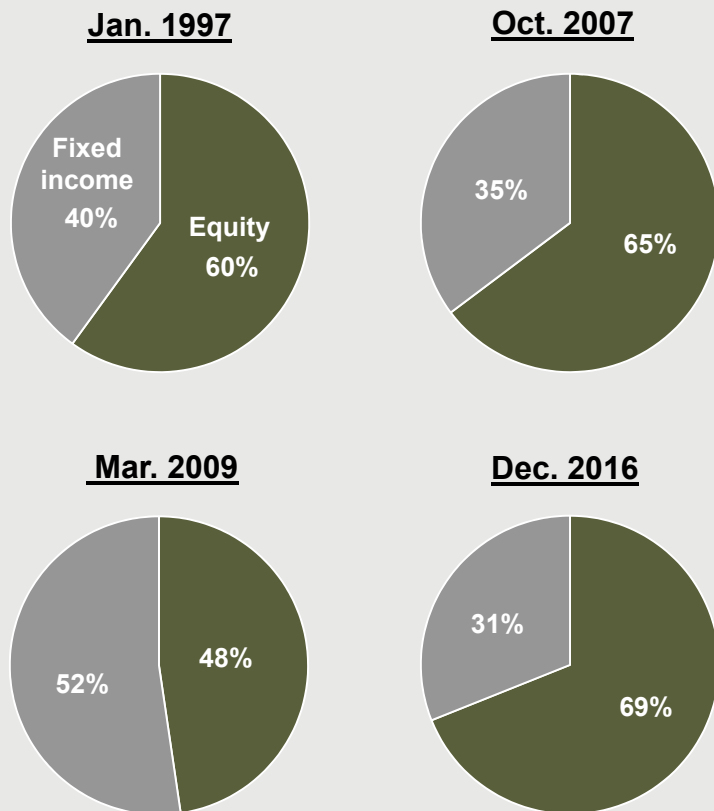
20-year annualized returns by asset class (1997 – 2016)

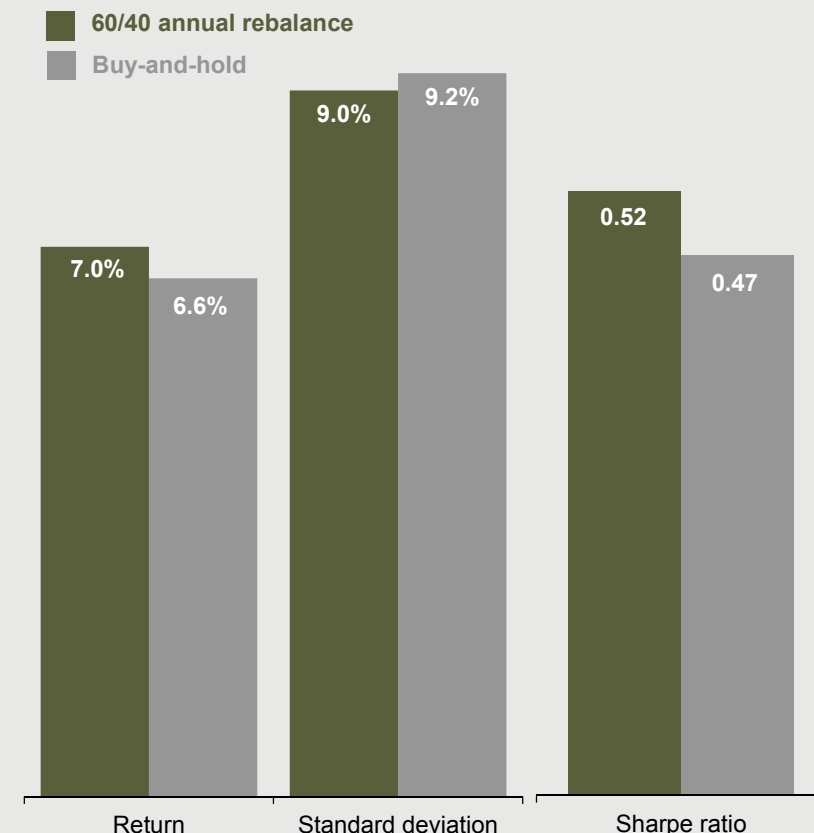
Actual portfolio drift in a buy-and-hold portfolio

60% equity and 40% fixed income portfolio, 20-year holding period

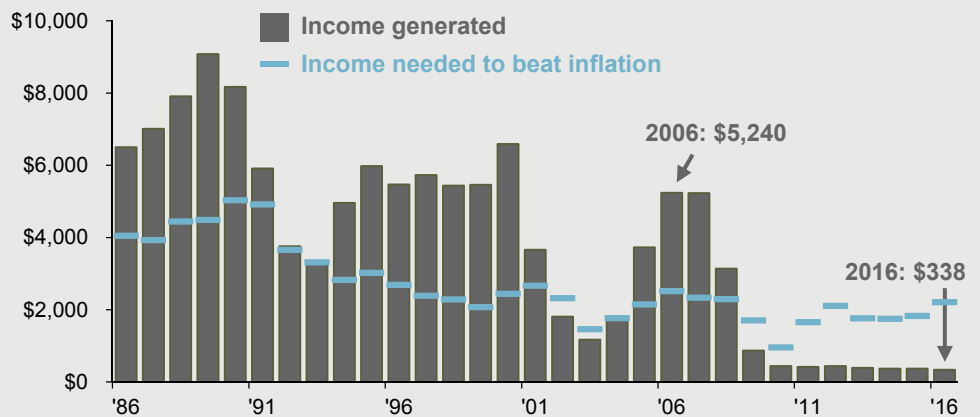

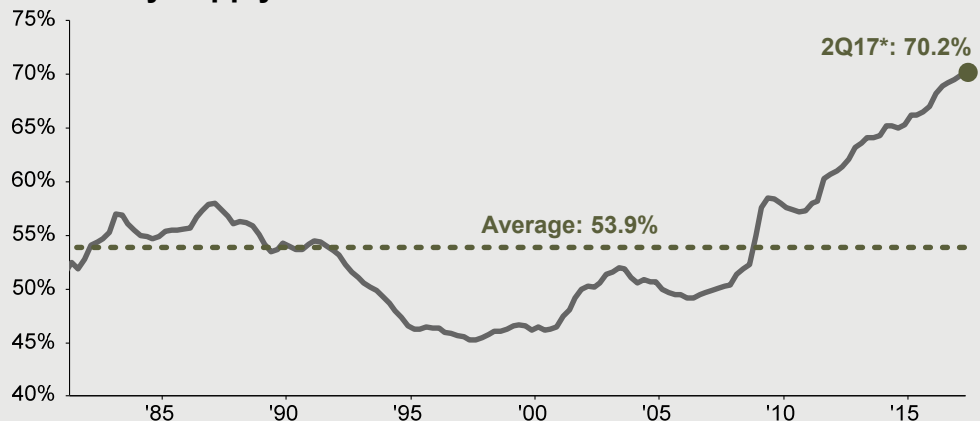

Annual income generated by \$100,000 investment in a 6-mo. CD



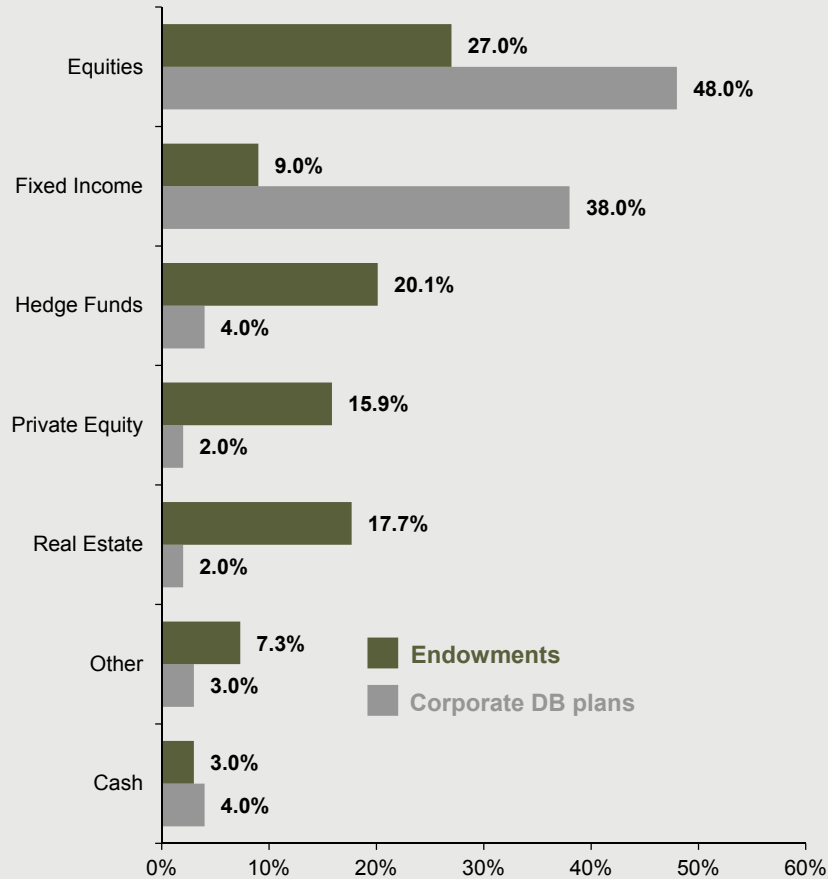
M2 money supply as a % of nominal GDP



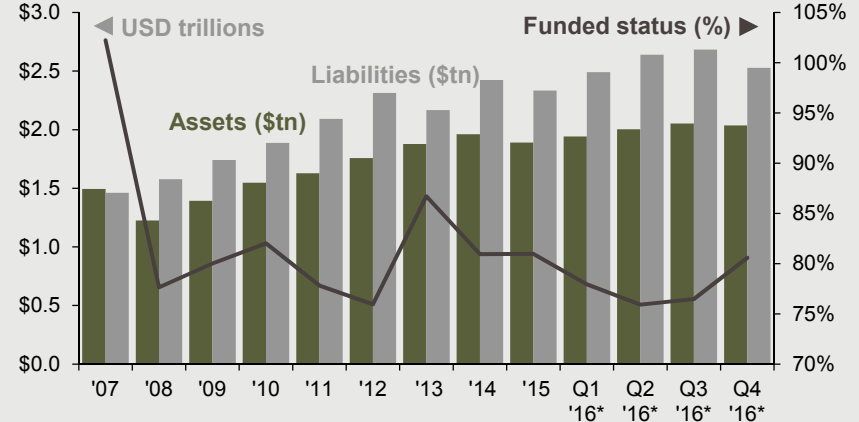

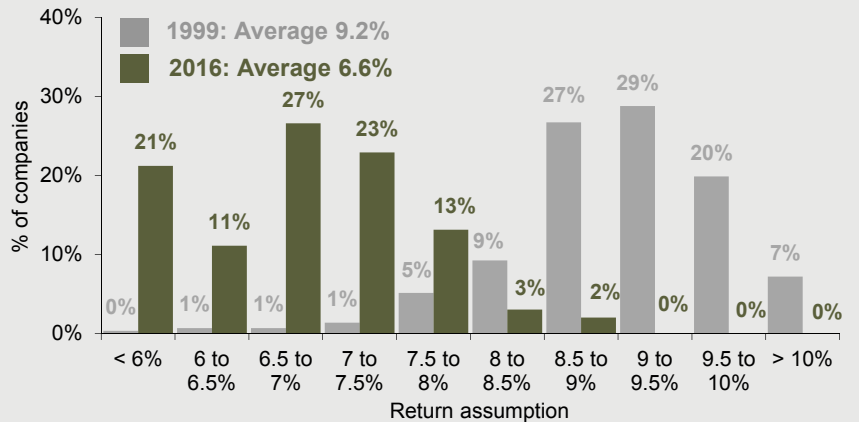
Asset allocation: Corporate DB plans vs. endowments



Defined benefit plans: Russell 3000 companies



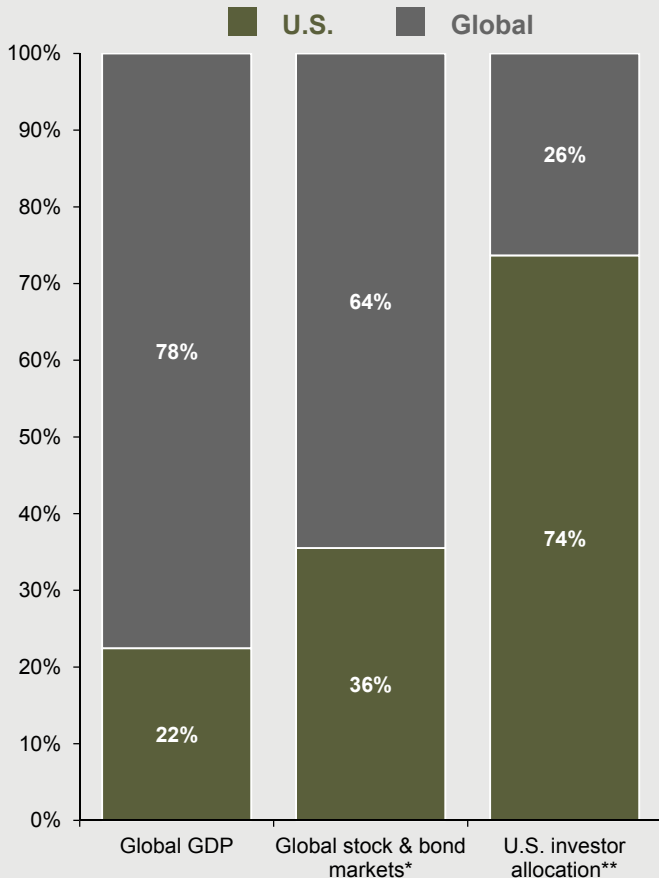
Pension return assumptions: S&P 500 companies

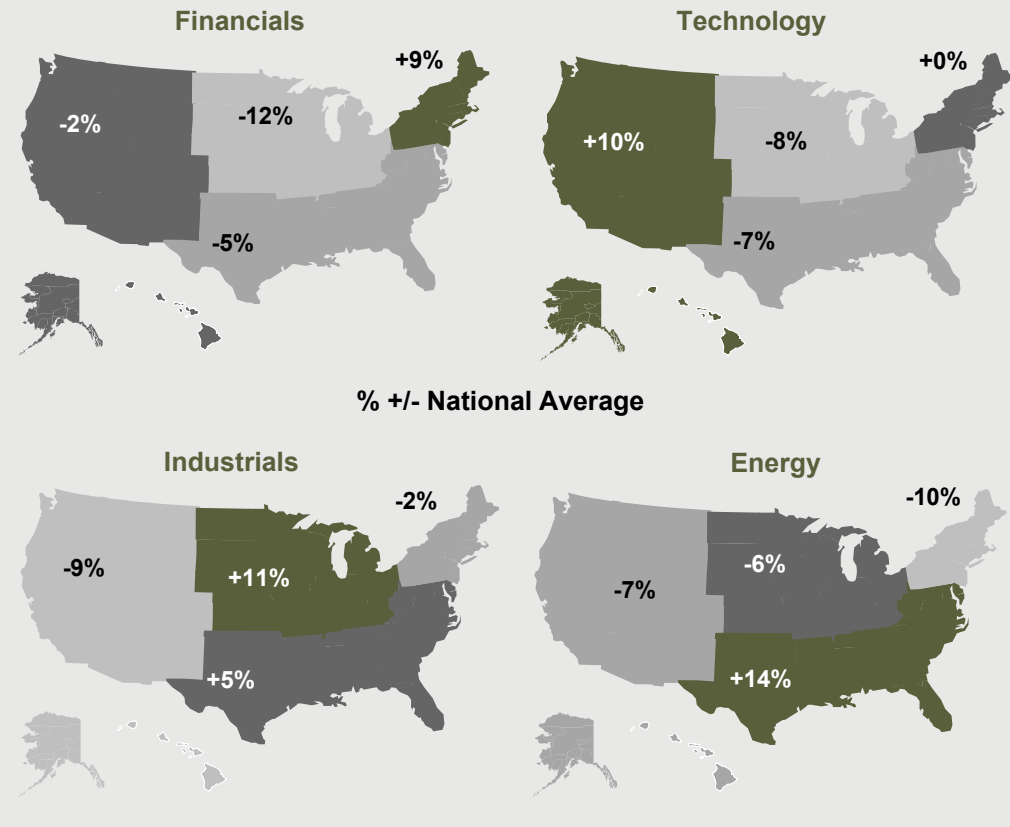
Investment universe & U.S. investors

Likelihood of owning stocks in an industry vs. national average***



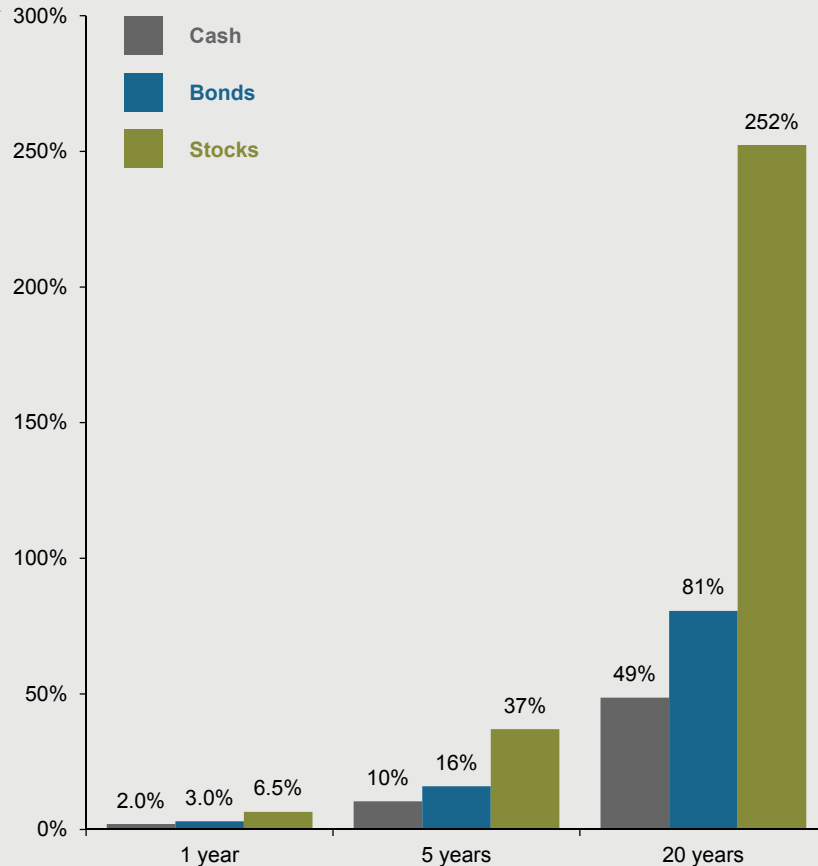

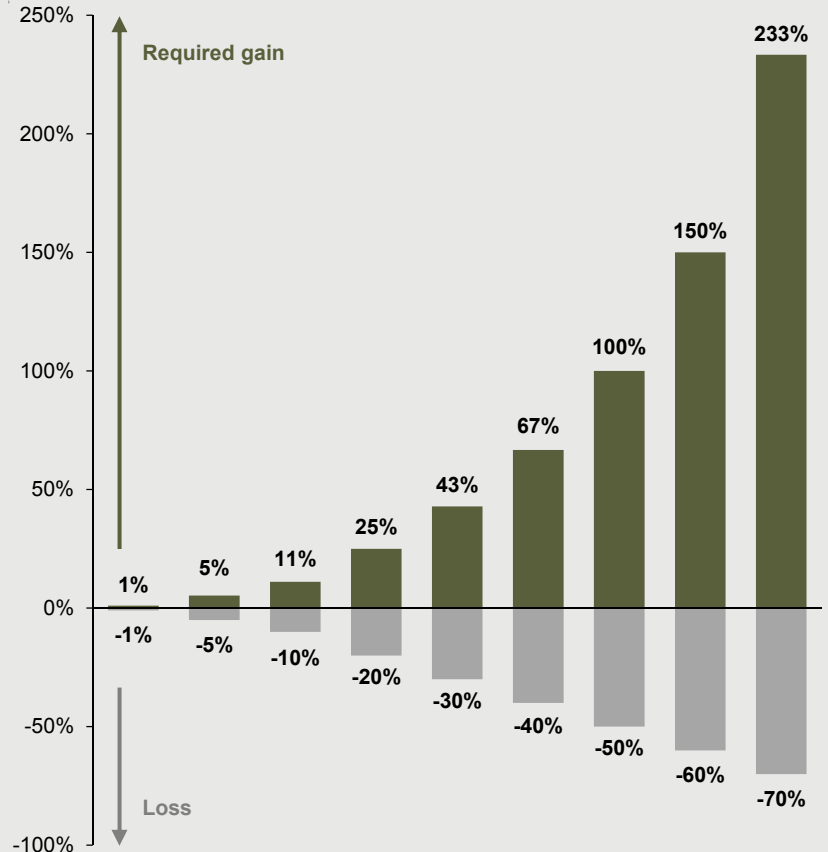

The **Russell Midcap Index**® measures the performance of the 800 smallest companies in the Russell 1000 Index.

The **Russell Midcap Growth Index**® measures the performance of those Russell Midcap companies with higher price-to-book ratios and higher forecasted growth values. The stocks are also members of the Russell 1000 Growth index.

The **Russell Midcap Value Index**® measures the performance of those Russell Midcap companies with lower price-to-book ratios and lower forecasted growth values. The stocks are also members of the Russell 1000 Value index.

The **S&P 500 Index** is widely regarded as the best single gauge of the U.S. equities market. The index includes a representative sample of 500 leading companies in leading industries of the U.S. economy. The **S&P 500 Index** focuses on the large-cap segment of the market; however, since it includes a significant portion of the total value of the market, it also represents the market.

Fixed income:

The **Barclays 1-3 Month U.S. Treasury Bill Index** includes all publicly issued zero-coupon US Treasury Bills that have a remaining maturity of less than 3 months and more than 1 month, are rated investment grade, and have \$250 million or more of outstanding face value. In addition, the securities must be denominated in U.S. dollars and must be fixed rate and non convertible.

The **Barclays Global High Yield Index** is a multi-currency flagship measure of the global high yield debt market. The index represents the union of the US High Yield, the Pan-European High Yield, and Emerging Markets (EM) Hard Currency High Yield Indices. The **J.P. Morgan Corporate Emerging Markets Bond Index Broad Diversified (CEMBI Broad Diversified)** is an expansion of the **J.P. Morgan Corporate Emerging Markets Bond Index (CEMBI)**. The CEMBI is a market capitalization weighted index consisting of U.S. dollar denominated emerging market corporate bonds.

The **J.P. Morgan Emerging Markets Bond Index Global Diversified (EMBI Global Diversified)** tracks total returns for U.S. dollar-denominated debt instruments issued by emerging market sovereign and quasi-sovereign entities: Brady bonds, loans, Eurobonds. The index limits the exposure of some of the larger countries.

The **J.P. Morgan GBI EM Global Diversified** tracks the performance of local currency debt issued by emerging market governments, whose debt is accessible by most of the international investor base.

The **U.S. Treasury Index** is a component of the U.S. Government index.

Other asset classes:

The **Alerian MLP Index** is a composite of the 50 most prominent energy Master Limited Partnerships (MLPs) that provides investors with an unbiased, comprehensive benchmark for the asset class.

The **Bloomberg Commodity Index** and related sub-indices are composed of futures contracts on physical commodities and represents twenty two separate commodities traded on U.S. exchanges, with the exception of aluminum, nickel, and zinc

The **Cambridge Associates U.S. Global Buyout and Growth Index®** is based on data compiled from 1,768 global (U.S. & ex – U.S.) buyout and growth equity funds, including fully liquidated partnerships, formed between 1986 and 2013.

The **CS/Tremont Hedge Fund Index** is compiled by Credit Suisse Tremont Index, LLC. It is an asset-weighted hedge fund index and includes only funds, as opposed to separate accounts. The Index uses the Credit Suisse/Tremont database, which tracks over 4500 funds, and consists only of funds with a minimum of US\$50 million under management, a 12-month track record, and audited financial statements. It is calculated and rebalanced on a monthly basis, and shown net of all performance fees and expenses. It is the exclusive property of Credit Suisse Tremont Index, LLC.

The **HFRI Monthly Indices (HFRI)** are equally weighted performance indexes, utilized by numerous hedge fund managers as a benchmark for their own hedge funds. The HFRI are broken down into 4 main strategies, each with multiple sub strategies. All single-manager HFRI Index constituents are included in the HFRI Fund Weighted Composite, which accounts for over 2200 funds listed on the internal HFR Database.

The **NAREIT EQUITY REIT Index** is designed to provide the most comprehensive assessment of overall industry performance, and includes all tax-qualified real estate investment trusts (REITs) that are listed on the NYSE, the American Stock Exchange or the NASDAQ National Market List.

The **NFI-ODCE**, short for NCREIF Fund Index - Open End Diversified Core Equity, is an index of investment returns reporting on both a historical and current basis the results of 33 open-end commingled funds pursuing a core investment strategy, some of which have performance histories dating back to the 1970s. The NFI-ODCE Index is capitalization-weighted and is reported gross of fees. Measurement is time-weighted.

Definitions:
